- **SUBJECT:** An Ordinance Of The City Council Of The City Of Brea Adopting Zoning Ordinance Amendment No. ZOA 16-03 - Omnibus Code Update Amending Chapter 18.08 Of Title 18, And Chapters 20.00, 20.200, 20.208, 20.212, 20.216 And 20.220 Of Title 20 Of The Brea Municipal Code Consisting Of Updating The Definition For Commercial Vehicles And Development Standards And Deleting/Replacing Information Inconsistent With The City's Organizational Structure

## RECOMMENDATION

Approve Ordinance No. 1191, for first reading by title only and waive further reading.

## **BACKGROUND/DISCUSSION**

Municipal Codes require periodic updates to ensure consistency with City policies and State law, to improve clarity and to better serve the public. Staff has identified a number of provisions in the Brea Zoning Code requiring review and revisions. The goals for this omnibus amendment are to:

- Provide clarity related to certain Zoning Code provisions; and
- Ensure internal consistency.

The updates proposed below consist of deleting/replacing definitions, updating standards and deleting outdated or inconsistent information. If approved, the proposed amendments will be adopted as part of an "omnibus" ordinance comprised of updates to eight sections of the Zoning Code. An omnibus ordinance is the packaging of a collection of amendments relatively small in scale, having a limited scope of impact into one "omnibus" ordinance. These amendments correct typographical errors, fix section references, and clean up existing Code language. State law allows a municipality to submit up to five omnibus ordinances within a one year period. This code amendment update request would be the City's first proposed omnibus ordinance amendment for the year 2017.

## **DISCUSSION**

Over time, staff has identified updates needed for the Code due to changes in policy, new laws and standards, or modifications to other sections of the Code. As part of this review process, staff worked with other departments and divisions, technical experts and the City Attorney to review and consider the proposed changes. Additionally, staff surveyed and analyzed codes and policies from other agencies as appropriate and applicable. The result of this effort is four code amendments to various sections of the Municipal Code. To compare current and proposed text, language to be deleted is shown in <u>strikethrough</u> font and language to be added is shown in <u>underline</u> font. The following provides an overview of the current Code, the issue, and the proposed amendment:

## **Code Amendment 1: Definition of Director**

Section 18.08.100 of Chapter 18.08 of the City Municipal Code defines "Director" as The Director of Development Services. The definition reference to "Director of Development Services" is an outdated reference and not consistent with the current City of Brea Community Development and Public Works Departments' organizational structure. The proposed amendment would replace "The Director of Development Services" with "The Public Works Director" in Section 18.08.100 of Chapter 18.08 of Title 18 of the Brea City Code is proposed to be amended as follows:

• DIRECTOR. The Director of Development Services. The Public Works Director. Where the staff title is no longer used by the City, the staff position most closely associated with this position, as determined by the City Manager, shall be the designated authority."

## **Code Amendment 2: Definition of Director**

Section 20.00.070 of Chapter 20.00 of the Brea City Code is an update to the definition of "Director". This definition update is for consistency with the City of Brea's organization structure which would define the director as the "The Community Development Director". Section 20.00.070 of Chapter 20.00 is proposed to be amended as follows:

"DIRECTOR. The City of Brea Director of Development Services, referred to in this Zoning Code as the "Director," or the Director's designee." <u>The Community Development Director</u>. Where this staff title is no longer used by the City, the staff position most closely associated with this position, as determined by the City Manager, shall be the designated authority."

## **Code Amendment 3: Definition of Commercial Vehicles**

Section 20.00.070 of Chapter 20.00 of the Brea City Code is an update to the definition of "Commercial Vehicles". The current definition states that:

- Any vehicle classified by the State of California as a commercial vehicle must be compliant with State vehicles laws, and;
- Weighs three (3) tons (e.g., six thousand (6,000) pounds) or more.

As currently defined based on vehicle weight in the City Code, this standard makes personal vehicles, such as: Ford, Chevrolet, and Dodge trucks, sport utility vehicles, and vans which range from 6,000-10,000 pounds noncompliant with Code. To remain compliant with City Code and relevant to current practices and developments, the definition update would modify the gross weight to delineate commercial vehicles from motor vehicles and recreational vehicles; and allow an increase in gross vehicle weight from 6,000 pounds to 12,000 pounds. This definition update will allow personal vehicles to be compliant with City Code, and continue to prohibit commercial vehicles from operating or conducting a permanent business within a residence. Section 20.00.070 of Chapter 20.00 is proposed to be amended as follows:

"COMMERCIAL VEHICLE. Any vehicle classified by the State of California as a commercial vehicle in compliance with Cal. Vehicle Code § 260 and that weighs three (3) tons (e.g., six-thousand (6,000) pounds) or more vehicles that have a gross vehicle weight of more than 12,000 pounds.

## **Code Amendment 4: Prohibited Uses in the Residential Zones**

As a result of the Code Amendment 3 definition update, various residential development standards will need to be amended as they pertain to the prohibited parking of vehicles over <sup>3</sup>/<sub>4</sub>

tons (1,500 pounds). To remain compliant with the new City Code definition update for Commercial Vehicle, the following residential development standards will need to be amended: Sections 20.200.030B 20.208.030A, 20.212.030A, 20.216.030A and 20.220.030A of Title 20 of the Brea Municipal Code and listed below:

Chapter 20.200.030, Subsection "B" is proposed to be amended as follows:

B. The parking or storage of commercial vehicles trucks over 3/4-ton capacity."

Chapter 20.208.030, Subsection "A" is proposed to be amended as follows:

A. Parking or storage of commercial vehicles trucks over <sup>3</sup>/<sub>4</sub>-tons in size."

Chapter 20.212.030, Subsection "A" is proposed to be amended as follows:

A. Parking or storage of commercial vehicles trucks over <sup>3</sup>/<sub>4</sub>-tons in size."

Chapter 20.216.030, Subsection "A" is proposed to be amended as follows:

A. Parking or storage of commercial vehicles trucks over <sup>3</sup>/<sub>4</sub>-tons in size."

Chapter 20.220.030, Subsection "A" of is proposed to be amended as follows:

A. Parking or storage of commercial vehicles trucks over <sup>3</sup>/<sub>4</sub>-tons in size."

## **ORDINANCE NO. 1191**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BREA ADOPTING ZONING ORDINANCE AMENDMENT NO. ZOA 16-03-OMNIBUS CODE UPDATE AMENDING CHAPTER 18.08 OF TITLE 18, AND CHAPTERS 20.00, 20.200, 20.208, 20.212, 20.216 AND 20.220 OF TITLE 20 OF THE BREA MUNICIPAL CODE CONSISTING OF UPDATING THE DEFINITION FOR COMMERCIAL VEHICLES AND DEVELOPMENT STANDARDS AND DELETING/REPLACING INFORMATION INCONSISTENT WITH THE CITY'S ORGANIZATIONAL STRUCTURE

#### A. <u>Recitals</u>.

(i) On December 13, 2016, the Planning Commission of the City of Brea conducted a duly noticed public hearing concerning Zoning Ordinance Amendment No. ZOA 16-03 and following the conclusion thereof, adopted Resolution No. 16-20 recommending that the City Council adopt said Zoning Ordinance Amendment.

(ii) The City Council of the City of Brea conducted and concluded a duly noticed public hearing concerning Zoning Ordinance Amendment No. ZOA 16-03, as set forth in this Ordinance. It is the intent of the City Council of the City of Brea in adopting this Ordinance to update various Zoning Ordinance provisions to ensure consistency within the Zoning Ordinance and clarify certain Zoning Ordinance provisions.

(iii) The City Council hereby finds and determines that the proposed amendment will not be materially injurious or detrimental to real property or improvements, nor will they have a significant adverse impact upon the environment. The proposed amendment will consist of a collection of amendments that are relatively

small in scale and have a relatively small scope of impact, and packages these amendments into an omnibus ordinance.

(iv) Adoption of this Ordinance is consistent with the General Plan. Under California law, every city and county must prepare a General Plan that is comprehensive and long-term in perspective. State law further indicates that the General Plan is the primary document a jurisdiction must utilize to regulate land use. Consequently, the Zoning Ordinance must be consistent with General Plan goals, policies, and standards. As part of the Zoning Ordinance, a municipality must periodicly update the City Code to ensure internal consistency with zoning regulations, to improve clarity, user-friendliness, and staff's ability to serve the public. Ongoing compliance is achieved by code amendments such as those proposed for adoption by ZOA 16 - 03. Therefore, having a General Plan and zoning ordinance that are consistent further the goals of the General Plan, allows Brea to continue establishing the fundamental framework to guide future decision-making about development, resource management, public safety, public services, and general community well-being.

(v) All legal prerequisites to the adoption of this Ordinance have occurred.

## B. ORDINANCE:

NOW, THEREFORE, the City Council of the City of Brea ordains as follows:

Section 1. The City Council finds that the facts set forth in the Recitals, Part A, of this Ordinance are true and correct.

Section 2. The definition of "Director" set forth in Section 18.08.100 of Chapter 18.08 of Title 18 of the Brea City Code is hereby amended to read as follows:

**DIRECTOR**. The Public Works Director. Where the staff title is no longer used by the City, the staff position most closely associated with this position, as determined by the City Manager, shall be designated the authority.

<u>Section 3.</u> The definition of "Director" set forth in Section 20.00.070 of Chapter 20.00 of Title 20 of the Brea City Code is hereby amended to read as follows:

"**DIRECTOR**. The Community Development Director. Where this staff title is no longer used by the City, the staff position most closely associated with this position, as determined by the City Manager, shall be the designated authority.

Section 4. The definition of "Commerical Vehicle" set forth in Section 20.00.070 of Chapter 20.00 of Title 20 of the Brea City Code is hereby amended to read as follows:

COMMERCIAL VEHICLE. Any vehicle classified by the State of California as a commercial vehicle in compliance with Cal. Vehicle Code § 260 and vehicles that have a gross vehicle weight of more than 12,000 pounds.

<u>Section 5.</u> Subsection "B" of Section 20.200.030 of Chapter 20.200 of Title 20 of the Brea City Code is hereby amended to read as follows:

B. The parking or storage of commercial vehicles.

<u>Section 6.</u> Subsection "A" Section 20.208.030 of Chapter 20.208 of Title 20 of the Brea City Code is hereby amended to read as follows:

A. Parking or storage of commercial vehicles.

**Section 7.** Subsection "A" Section 20.212.030 of Chapter 20.212 of Title 20 of the Brea City Code is hereby amended to read as follows:

A. Parking or storage of commercial vehicles.

**Section 8.** Subsection "A" Section 20.216.030 of Chapter 20.216 of Title 20 of the Brea City Code is hereby amended to read as follows:

A. Parking or storage of commercial vehicles.

**Section 9.** Subsection "A" Section 20.220.030 of Chapter 20.220 of Title 20 of the Brea City Code is hereby amended to read as follows:

A. Parking or storage of commercial vehicles

<u>Section 10.</u> The provisions of this Ordinance, insofar as they are substantially the same as provisions of ordinances previously adopted by the City relating to the same matter, shall be construed as restatements and continuations of the earlier enactment, and not as new enactments. The adoption of this Ordinance does not affect the following matters:

- a. Actions and proceedings that began before the effective date of this Ordinance.
- b. Prosecution for ordinance violations committed before the effective date of this Ordinance.
- c. Licenses and penalties due and unpaid at the effective date of this Ordinance.
- Collection of licenses and penalties due and unpaid at the effective date of this Ordinance.
- e. Bonds and cash deposits required to be posted, filed, or deposited pursuant to any ordinance, resolution, or regulation.
- f. Matters of record that refer to or are connected with an ordinance previously adopted by the City the substance of which is amended by this Ordinance. Such references shall be construed to apply to the corresponding provisions of this Ordinance.

**Section 11.** CEQA. This Ordinance is exempt from CEQA pursuant to CEQA Guidelines section 15061(b)(3) which is the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment, and CEQA does not apply where it can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment. Therefore, this Ordinance has no impact on the physical environment as it will not result in any changes.

Section 12. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

<u>Section 13</u>. Effective Date. This Ordinance shall become effective thirty (30) days after its adoption in accordance with the provisions of California law.

<u>Section 14.</u> Certification. The City Clerk shall certify to the passage of this Ordinance and cause the same or a summary thereof to be published within fifteen (15) days after adoption in a newspaper of general circulation, printed and published in Brea Star Progress, Orange County, California.

**SUBJECT:** Urgency Ordinance No. 1192 and Ordinance No. 1193, Reauthorizing and Readopting a Public, Educational, and Governmental Access Fee

## **RECOMMENDATION**

A. Adopt the urgency ordinance entitled "An Urgency Ordinance of the City of Brea Reauthorizing the City's Public, Educational, and Governmental Access Support Fee" by four-fifths vote by title only; and

B. Adopt the ordinance entitled "An Ordinance of the City of Brea Reauthorizing and Readopting the City's Public, Educational, and Governmental Access Support Fee" by title only.

## **BACKGROUND/DISCUSSION**

In 2006, the California Legislature adopted the Digital Infrastructure and Video Competition Act ("DIVCA"), which changed the manner in which video services are regulated by replacing local franchising with a state franchising system administered by the Public Utilities Commission. DIVCA requires state franchise holders to offer at least three PEG channels to each community in which they operate. DIVCA also authorizes cities to adopt an ordinance imposing a fee on state franchise holders to support PEG programming facilities.

The City Council established such a fee on April 17, 2007 by adopting Ordinance No. 1099 to require video service providers who have been issued state franchises to pay the City a PEG access fee of 1% of the video service provider's gross revenues. DIVCA also provides, however, that any ordinance adopting a PEG access fee "shall expire, and may be reauthorized, upon the expiration of the state franchise." Public Utilities Code section 5870.

Pacific Bell Telephone Company d/b/a SBC Pacific Bell Telephone Company d/b/a AT&T California ("AT&T") and Verizon California, Inc. received state video franchises to operate within the City on March 30, 2007 and March 8, 2007, respectively. These franchises will expire on March 30, 2017 and March 8, 2017, respectively. The City's PEG fee will therefore expire on March 8, 2017 unless the City Council reauthorizes the fee.

The proposed Urgency Ordinance and the Ordinance would reauthorize the City's PEG fee and therefore preserve funding available to support PEG programming facilities. Staff believes that an urgency ordinance is necessary for the immediate preservation of the public peace, health and safety because the City depends upon the PEG fee to support PEG access channel facilities, which are essential to providing City residents with important civic programming including emergency alerts and community and governmental news.

If this Ordinance does not become effective immediately, but instead becomes effective thirty days after its second reading, funding for City PEG facilities could lapse causing residents who rely on PEG channels for emergency broadcasts and news updates to lose a vital source of City information. Any lapse in funding may also lead to confusion among state video franchisees operating within the City regarding the payment of PEG access fee leading the City to incur additional costs to recover any overdue fees.

## FISCAL IMPACT/SUMMARY

The City's General Fund receives approximately \$97,000 annually from PEG fees which offsets a portion of the cost of providing important civic programming including emergency alerts; community and governmental news as well as the broadcasting of City Council meetings.

In accordance with state law, the City imposes a 1% Public, Educational and Governmental ("PEG") access fee on all state franchised video service providers operating within the City to support PEG programming facilities. The Ordinances will reauthorize a 1% PEG access support fee that the City currently receives. If the City Council does not reauthorize the PEG access support fee, the City will not receive further PEG access fees from video service providers operating under state franchises within the City. This would result in a loss of General Fund revenues of approximately \$97,000 annually.

## **ORDINANCE NO. 1192**

## AN URGENCY ORDINANCE OF THE CITY OF BREA REAUTHORIZING THE CITY'S PUBLIC, EDUCATIONAL, AND GOVERNMENTAL ACCESS SUPPORT FEE

WHEREAS, Section 5870(n) of the Public Utilities Code, which was enacted as part of the Digital Infrastructure and Video Competition Act of 2006, authorized the City adopt an ordinance establishing a fee on state-franchised video service providers to support public, educational, and governmental ("PEG") access channel facilities; and

WHEREAS, on April 17, 2007 the City adopted Ordinance No. 1099 establishing such a fee, which is codified in Section 5.208.092 of the Municipal Code; and

WHEREAS, Section 5870(n) of the Public Utilities Code states that such an ordinance shall expire, and may be reauthorized, upon the expiration of a state franchise; and

WHEREAS, the first state franchise to include the City, California Video Franchise Certificate Franchise No. 0001 granted to Verizon California, Inc., will expire on March 8, 2017; and

WHEREAS, the second state franchise to include the City, California Video Franchise Certificate Franchise No. 0002 granted to Pacific Bell Telephone Co. d/b/a SBC Pacific Bell Telephone Co. d/b/a AT&T California will expire on March 30, 2017.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BREA DOES ORDAIN AS FOLLOWS:

**Section 1.** Urgency Findings. The City Council finds as follows:

(a) Currently, the City depends upon the PEG access fee to support PEG access channel facilities, which are essential to providing city residents with important civic programming including emergency alerts and community and governmental news. Pursuant to Public Utilities Code Section 5870(n), the City's PEG access fee codified in Section 5.208.092 of the Municipal Code shall expire upon the expiration of a state The first state franchise to include the City, California Video Franchise franchise. Certificate Franchise No. 0001 granted to Verizon California, Inc. will expire on March 8, 2017. The second state franchise to include the City, California Video Franchise Certificate Franchise No. 0002 granted to Pacific Bell Telephone Co. d/b/a SBC Pacific Bell Telephone Co. d/b/a AT&T California will expire on March 30, 2017. If this fee is not reauthorized immediately, the City will lose funding for its PEG programming facilities. Any loss of funding would jeopardize a trustworthy, reliable and immediate means by which the City communicates with its residents. Any lapse in funding may also lead to confusion among state video franchisees operating within the City regarding the payment of PEG access fee leading the City to incur additional costs to recover any overdue fees.

(b) Therefore, the City Council finds and determines that the immediate preservation of the public peace, health and safety requires that this ordinance be enacted as an urgency ordinance pursuant to Government Code Section 36937(b) and take effect immediately upon adoption. If this Ordinance does not become effective immediately, but instead becomes effective thirty days after its second reading, funding for City PEG facilities could lapse causing residents who rely on PEG channels for emergency broadcasts and news updates to lose a vital source of City information.

Therefore, this Ordinance is necessary for the immediate preservation of the public peace, health and safety and its urgency is hereby declared.

<u>Section 2.</u> The City Council hereby reauthorizes the fee on state-franchised video service providers to support public, educational, and governmental channel facilities codified in Section 5.208.092 of the Municipal Code, which fee shall remain unchanged and in full effect as to all state-franchised video service providers.

**Section 3.** The City Clerk shall certify to the adoption of this Ordinance and cause the same to be published as required by law.

#### STUDY SESSION SPECIAL MEETING 6:00 p.m. - Council Chambers Level One

#### CALL TO ORDER/ ROLL CALL - COUNCIL Mayor Hupp called the meeting to order at 6:05 p.m., all members were present.

1. Matters from the audience None.

#### **DISCUSSION ITEMS**

2. Review Feasibility Analysis for Providing Multi-City Fire Services Under Joint Powers Authority Jurisdiction for Cities of Brea and Fullerton with Citygate and Associates Fire Chief Knabe introduced the consultants from Citygate and A.P. Triton, discussed the purpose of the ambulance study, provided important considerations, shared the goals for a shared fire service, stated that the City of Fullerton did not take action and will bring the item back to their Council on February 21 to allow all Council Members to be present, and provided the meeting order.

In response to Council questions, Fire Chief Knabe explained ambulance delivery models, discussed CFD funds, and provided the percentage of paramedic use increase.

Steward Gary (Citygate) presented a PowerPoint that included project elements, Citygate's capstone opinion, economics overview, cost projection summary, dollar impact projection summary, economics model, shared management vs. JPA costs, service structural changes, current decision point, project findings, recommendations and next steps.

Kurt Henke and Scott Clough (A.P. Triton) presented a PowerPoint that included determining the value of Fullerton/Brea EMS study, GEMT (federal program that allows public entities to draw down fees for medical beneficiary and federal reimbursement), deployment models, Ambulance Operated (AO) staffed, public/private partnership staffed, contracting and Request for Proposals (RFP).

In response to Council questions, Mr. Clough clarified that the 5 million dollar maximum potential in revenue is possible according to the collection strategy, noted that the model shown is a "fee for service" business model, stated that they suggest using standard industry practice for collection strategies, discussed what other cities are doing to recover costs for ambulance service, clarified that fees for ambulance service is not subject to Proposition 218, and discussed 201 and 24A agency rights.

Fire Association President Josh Jones provided the background of the Fire Department, stated that he believe that there was not enough internal and external conversation regarding ambulance services, expressed concern about the Citygate study, stated that the cost vs. benefit analysis seems to be skewed, discussed section 5 of the Citygate study and stated that the City should be proactive and not reactive.

Mayor Hupp recessed the meeting at 7:46 p.m.

Mayor Hupp reconvened the meeting at 7:57 p.m.

Chad Druten (Emergency Ambulance Service) expressed concern about a Joint Powers Authority (JPA), noted inaccuracies in the fire study, and provided suggestions to the Council and staff regarding the model.

Heidi Gallegos, CEO of Brea Chamber of Commerce, expressed concern with quality of service and response time, thanked Council for having the meeting in Council Chambers and asked Council to take time to make the best decisions for the businesses and residents in the City.

Mayor Hupp and Council Member Simonoff expressed disappointment with the process used to conduct the study; stated that there should have been buy-in from both associations; and expressed concern about seeking revenue from residents.

Council Member Vargas expressed concern about a possible cost increase for fire services and stated that he will not support the JPA.

Mayor Pro Tem Parker stated that he was looking forward to having a discussion about moving toward a JPA,

expressed disappointment that there is a lack of discussion, discussed benefits of using the four (4) person model for ambulance service and expressed opposition of using OCFA for fire services.

Council expressed support for the continuance of sharing the command staff, noted that there might be other opportunities for sharing services, stated that there are no major cost savings and suggested more discussion.

Fire Chief Knabe discussed communication he has had with Emergency Ambulance Service (EAS) and summarized Council's input.

Council reiterated that staff will continue to: work with the current contractor (EAS) on staffing model options, verify 201 rights and continue to work with the labor groups on alternatives.

The Council supported the fire command sharing with Fullerton; however, at this time, discussed an interest in pausing further discussion of a full fire merger with Fullerton.

#### ADJOURNMENT

Mayor Hupp adjourned the Study Session Special Meeting at 8:35 p.m.

Maintenance Service Superintendent Bowlus presented a PowerPoint that included the background of LLMDs; district locations; maps of the districts; special benefit zones; calculation of the general and special benefit; assessment increases/decreases by zone; cost estimate; working group concerns; the shared slope between district 1 and 6; citywide impacts from special/general benefits; and options.

In response to Council questions, Maintenance Service Superintendent Bowlus and City Attorney Markman explained the special benefit to the City for LLMDs, noted that there are homes that are not in the districts, clarified that the City can't add an assessment to a property that didn't have an assessment from the beginning, stated that the City does not get a vote as a landowner, discussed liability, provided the status of funds, clarified that there has not been a reserve study, and discussed a CFD overlay.

### **RECOMMENDATION**

Accept easements and authorize City Clerk to execute and record the easements.

### **BACKGROUND/DISCUSSION**

Tentative Tract Map 16934 (also known as La Floresta Development) was conditionally approved by Planning Commission Resolution No. PC 2010-57 on September 23, 2008. The La Floresta Development is located at the northeast corner of Imperial Highway and Valencia Avenue. The Planning Area 2 of the La Floresta Development was administratively approved for age-qualified single family residential condominium development consisting of 90 units on July 21, 2016. Refer to Exhibit "A" attached for the location of Planning Area 2. As a part of the La Floresta Planning Area 2 approval, a lot line adjustment was required to realign the Buena Vida Drive (private street) and reconfigure the lots to accommodate the proposed site plan.

On July 19, 2016, City Council adopted Resolution 2016-056 to reject the irrevocable offer to dedicate the easement for public utilities, sanitary sewer, water, storm drain and emergency vehicle ingress and egress purposes over the portion of Buena Vida Drive to be realigned. Subsequently, a lot line adjustment (LL 2016-01) was approved and recorded on July 29, 2016 to complete the lot reconfiguration and new alignment of Buena Vida Drive.

As a part of the Buena Vida Drive street realignment, all of the underground utilities are required to be realigned as well. Therefore, the developer is conditioned to dedicate an easement over the new alignment of the street (Lot Q of LL 2016-01) for public utilities, sanitary sewer, water, storm drain and emergency vehicle ingress and egress purposes. Furthermore, there are four (4) 6-inch water lines with meters constructed to provide private water systems for this planning area. The water vaults for the water meters are constructed within the private property, which require the public water easements. These public water easement areas are within the private property adjacent to Buena Vida Drive and La Entrada Drive. Refer to Exhibit "B" for the locations of these easements.

### FISCAL IMPACT/SUMMARY

There are maintenance costs associated with operating and maintaining the sanitation sewer, water and storm drain lines. The maintenance costs of the public sewer and water facilities are included in the City's user fees and the storm drain maintenance costs are included in the general maintenance fund. Therefore, there will be minimal General Fund impact from these improvements. Hence, staff is recommending the City Council to consider accepting the public easements for La Floresta Planning Area 2.

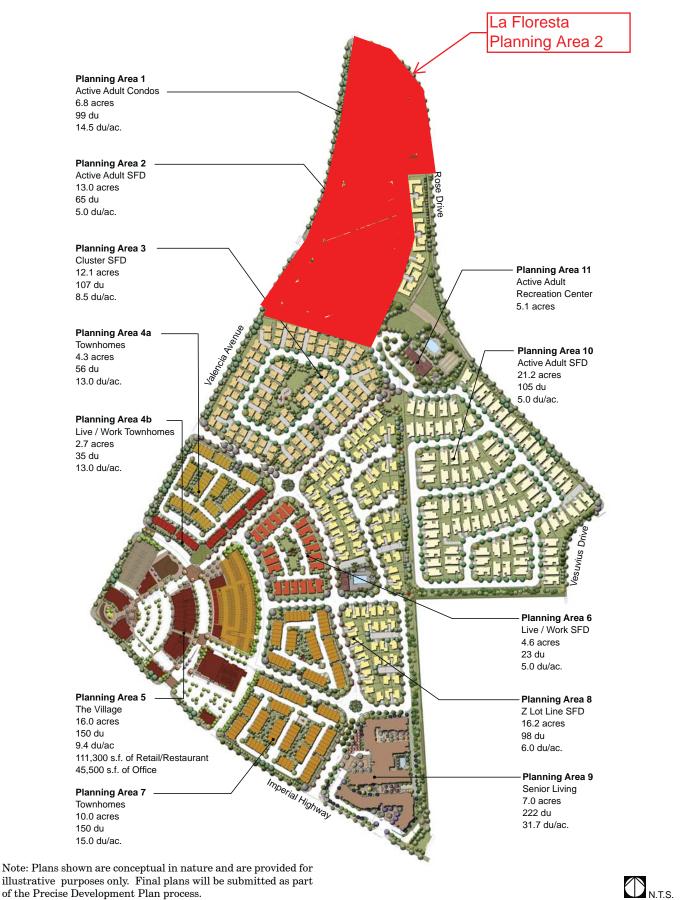

## EXHIBIT "A" - LOCATION MAP

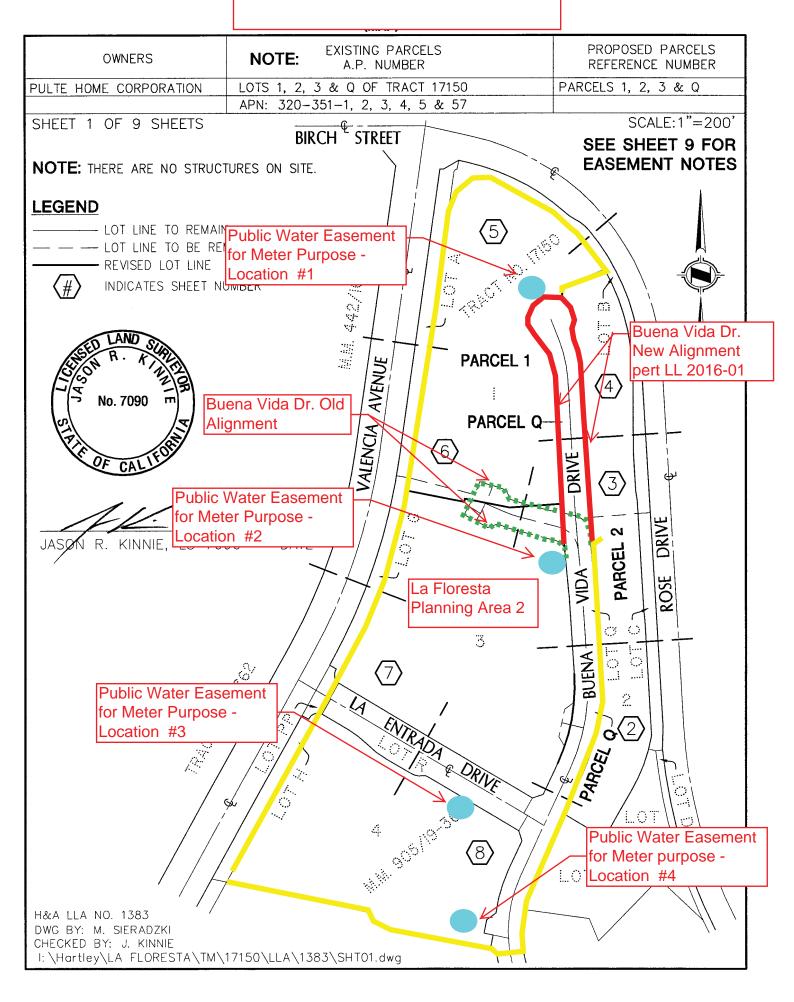

### RECOMMENDATION

Council to Receive and File the Administrative Policy as Amended by the City Attorney and Council, Distribute to all City Employees and Work Towards Implementation of Applicable Provisions Requiring "Meet and Confer" with Employee Associations.

### **BACKGROUND/DISCUSSION**

It is the stated policy of the City of Brea to uphold, promote and demand the highest standards of ethics from all of its employees and officials, whether elected, appointed or otherwise hired. Accordingly, all City elected officials (the Mayor and Council Members), all City employees, and all members of City appointed commissions and/or committees are expected to maintain the highest standards of personal integrity, truthfulness, respect, professionalism, honesty and fairness in carrying out their duties; avoid any improprieties in their roles as public servants; and never use their position or powers for improper personal gain or influence.

In keeping with the commitment to excellence and the highest standards of ethics in public service, the city has adopted the following policies:

- Code of Ethics for Members of City Council and of the City's Commissions and Committees (Adopted 10-1-2002)
- AB 1234 State Ethics Training Requirements for Local Officials and Certain City Employees (Adopted 1-1-2006)
- Code of Ethics for Employees of the City of Brea Administrative Policy (Adopted 1-19-2012, revised 9-2-2016)
- Conflict of Interest Administrative Policy (Adopted 12-23-1992 and revision under review)
- Outside Employment Administrative Policy (Adopted 9-27-2012)
- Acceptance of Gifts and Gratuities Administrative Policy (Adopted 3-9-92 and revision under review)
- City of Brea Personnel Rules and Regulations (Recent revision 3-1-2012)

The policy that most comprehensively addresses issues of employee ethics is the administrative policy titled Code of Ethics for Employees of the City of Brea. This policy was initially adopted on January 19, 2012 and was recently updated on September 2, 2016. The goal was to establish a

uniform policy on ethics and accountability for City employees. At the time the policy was originally adopted in 2012, every employee was provided with a electronic copy via email with documentation the policy was received and the policy was posted to our City's internal Intranet webpage.

In an effort to increase awareness of this policy, Human Resources updated the policy in 2016 and required that all new employees be provided with a copy of the policy during new employee orientations and sign an acknowledgement of receipt of the policy. In addition, the City Manager and all Department Directors have signed the 2016 Policy. In the 2016 version, added was an entire section on reporting wrong doing and updated the section on investigations and enforcement.

The Code of Ethics for Employees of the City of Brea policy covers the following specific categories of ethical conduct and conflicts of interests:

- Use of Public Resources
- Incompatible employment
- Disclosure of Confidential Information
- Gifts and Favors
- Representing Private Interests Before City Agencies or Courts
- Financial and Personal Interest
- Reporting
- Investigation and Enforcement

In regards to state mandated ethics training, AB 1234 requires that elected or appointed officials and certain designated City employees (usually managers, line supervisors, and analysts) take a two hour ethics training class every two years. This training is offered to our employees and elected officials by City Attorney Jim Markman and is titled "principles of ethics and the law in public service." The most recent training occurred on Thursday, April 14, 2016. The City Clerk is working on another training date for March or April 2017. Over the last two years at least 57 City of Brea employees have taken the course in order to comply with state requirements.

### **City Attorney Review**

At the February 6 City Council Study Session, the Council directed the City Attorney's office to edit the revised policy for compliance with all state and local laws. The attached policy reflects the City Attorney's recommended changes to the policy. There are provisions of this policy which may constitute grounds for discipline not found in state code and therefore are subject to "Meet and Confer" with Brea's employee associations.

The following action will occur upon the Councils concurrence with this policy:

- 1. Distributed electronically to all City Employees with electronic acknowledgment of delivery.
- 2. Reposted on the City's internal Intranet webpage.
- 3. Continue to require all new employees sign the policy upon hire.
- 4. Work towards the "Meet and Confer" process with employee associations on applicable sections of the policy.

In general, our administrative ethics policies are appropriately drafted to provide the City the necessary tools to address employee wrong doing and ensure sound ethical behavior. We regularly review our policies and make revisions when appropriate. In the end, the main goal is

that all City employees remain independent, impartial, responsible to the public and are all bound to observe the highest standards of integrity and ethics.

### FISCAL IMPACT/SUMMARY

### Summary

In 2012 the City of Brea adopted an Administrative Policy on ethical standards and reporting fraud, waste, and abuse by public employees and officials. The policy was updated in 2016 and a subsequent update by the City Attorney is now presented to the City Council to receive and file. In addition, direct the City Manager to distribute, "meet and confer" with employee groups and update the Administrative Policy whenever necessary.

POLICIES & PROCEDURES	ADOPTED: September 19, 2012 REVISED: February 21, 2017 CITY MANAGER

#### Purpose

To establish a uniform policy for City employees to achieve fair, ethical, and accountable local government for the City of Brea. City employees are expected to demonstrate the highest standards of personal integrity, honesty, and conduct in all activities in order to inspire public confidence and trust in City employees.

#### <u>Policy</u>

The proper operation of democratic government requires that public employees be independent, impartial, and responsible to the people; that governmental decisions and policies be made in the proper channels of the governmental structure; that public employment not be used for improper personal gain; and that the public have confidence in the integrity of its government.

To assist employees of the City of Brea in achieving these goals, we have established a Code of Ethics for all City employees under the control of the City Manager. The purpose of this Code is to establish ethical standards of conduct by setting forth actions that are incompatible with the best interest of the City. Further, it is the purpose of this Code to relieve employees of the impossible task of judging themselves and to enable them to carry out their role as trustees of the public interest.

#### Responsibilities of Public Employees

Public employees are agents of public purpose and hold their position for the benefit of the public. They are bound to uphold, carry out impartially, and comply with the letter and spirit of the laws of the nation, state, and municipality and thus to foster respect for all government. These laws include, but are not limited to: the United States and California Constitutions and Codes; the City of Brea Municipal Code; and City policies. They are bound to observe in their official acts the highest standards of morality and to discharge faithfully the duties of their office regardless of personal considerations, recognizing that the public interest must be their primary concern. They should exercise prudence and integrity in the management of funds in their custody and in all financial transactions. Their conduct in performing their official tasks should be above reproach and avoid the appearance of impropriety.

### **Dedicated Service**

All employees of the City of Brea shall encourage meaningful involvement of the public and be loyal to the policy objectives expressed by the electorate through the City Council and to programs developed to attain those objectives.

Employees shall adhere to the rules of work and performance established as the standard for their positions by the City Manager.

Employees should not exceed their authority or ask others to do so, and they shall work in full cooperation with other public officials and employees.

#### Fair and Equal Treatment

- 1. <u>Impartiality</u>: No employee shall grant or make available to any person consideration, treatment, advantage, or favor beyond that which is the general practice to grant or make available to the public at large.
- 2. <u>Use of Public Resources</u>: No employee shall request use or permit use of Cityowned vehicles, equipment, materials, property, or resources for personal purposes or gain, except when such services are available to the public generally, or are provided as municipal policy for the use of such employee in the conduct of official business. This prohibition also is inapplicable when such use is authorized by state law.

#### **Conflict of Interest**

No employee shall engage in any business or transaction, incur any obligation, or have a financial or other personal interest, direct or indirect, which is incompatible with the proper discharge of his or her official duties in the public interest or which would tend to impair his or her independence of judgment or action in the performance of his or her official duties. A personal interest, as distinguished from a financial interest, includes an interest arising from family or marital relationships.

Some specific conflict prohibitions are listed below for the guidance of employees; the items included are not an exclusive list:

 Incompatible Employment: No employee shall engage in or accept private employment or render services for private interests when such employment or services is incompatible with the proper discharge of his or her official duties. Employees must receive written authorization from their Department Director and the Human Resources Manager via an approved Request for Outside Employment application before engaging in any outside employment. For additional information, please refer to the Administrative Policy titled "Outside Employment Policy" adopted August 2012.

### Code of Ethics for Employees of the City of Brea

- <u>Disclosure of Confidential Information</u>: No employee shall, without proper legal authorization, disclose confidential information concerning any City official or employee, or the affairs of the City. Nor shall he or she use such information to advance his or her financial or other personal interest.
- 3. <u>Gifts and Favors</u>: No employee shall accept any valuable gift, unless authorized by the Political Reform Act or FPPC regulations, whether in the form of service, loan, item of value, or promise, from any person, firm, or corporation which to his or her knowledge is interested, directly or indirectly, in any manner whatsoever with the City; nor shall any such employee (a) accept any gift, favor, or thing of value that may tend to influence him or her in the discharge of his or her duties, or (b) grant in the discharge of his or her duties any improper favor, or item of value.
- 4. <u>Representing Private Interests Before City Agencies or Courts</u>: No employee shall appear on behalf of the private interests of any third party before any agency of the City. Nor shall he or she represent the private interest of any third party in any action or proceeding adverse to the interests of the City in any litigation to which the City is a party. However, it is understood that employees enjoy free speech rights under federal and state law. Therefore, an employee may present his or her individual opinions and positions before the City Council so long as that employee explicitly states that he or she does not represent the position of the City of Brea.
- 5. <u>Financial and Personal Interest</u>: Employees shall comply with applicable requirements of the Political Reform Act of 1974 (Government Code Section 81000, et seq.), the regulations of the Fair Political Practices Commission (2 Cal. Code of Regs. Section 18110, et seq.), any amendments thereto, and other applicable laws, relating to the disclosure of financial and personal interests and disqualification from making, participating in making, or influencing any governmental decision before the City.
- 6. <u>Political Activity</u>: Employees generally have a right to voluntarily participate, or to refrain from participating, in political activities as individuals as long as these activities do not involve the use of City time, resources or facilities. Prohibited political activities include:
  - a. Participation in political activities while in uniform.
  - b. Direct or indirect solicitation of political funds or contributions from City officers or employees, unless the solicitation is part of a general effort that incidentally includes local officials and employees.
  - c. Use of a City position or authority to influence the political actions of other City officers or employees or those seeking City employment.

d. Use of public funds to support or oppose a candidate or ballot measure. In addition to the use of public money, this prohibition includes the use of City facilities, staff or equipment, including the City website, telephones, computer, e-mail accounts, vehicles, copy machines and any other City equipment.

This list is not exhaustive, but is intended to provide general guidelines. Employees whose primary job is in connection with federally financed activities may be subject to additional requirements under federal law. Employees engaging in political activities are responsible for assuring their activities are consistent with State and federal law.

### Conflict of Interest

This Code is an official administrative policy but is not the only policy related to employee conduct. Some conduct may be ethical without being efficient, safe, or practical. Therefore, this Code may not be the only standard to which an employee is held.

Existing law and policy already addresses many areas of ethical conduct. This Code does supersede other sources of guidance including the following:

- City's Personnel Regulations
  - Harassment Policy
- Drug Free Workplace Policy
   Business and Travel Policy
- Purchasing Policy
- Social Media Policy
- Internet and Electronic Device Usage Policy
- Municipal Code

### **Reporting**

Employees are expected to report all violations or suspected violations of this policy to management in a timely and professional manner. The City recognizes that the reporting party may desire or require anonymity. Thus anonymous reports or concerns may be reported by any party to the City Council, City Manager, Human Resources or City Attorney. It is the duty of every employee to report any known violation of this policy or what would appear to a reasonable person to be a violation of this policy. Employees are reminded that they may report anonymously any actions that detract from the efficiency and effectiveness of City operations including, but not limited to, fraud, waste, abuse, ethics violations, retaliation, discrimination, and safety violations. It is a violation of this policy to retaliate against an employee who makes a report anonymously under California Labor Code Sections 1102.5 and 1106. The California State Attorney General's Whistleblower Hotline number is (800) 952-5225.

#### **Investigation and Enforcement**

All violations or alleged violations of this policy will be investigated. As stated above, it is the duty of every employee to cooperate in any investigation involving a

violation or an alleged violation of this Code. Upon the request of the City, an employee will participate and fully cooperate in any investigation, whether conducted by the City or its agent(s). In addition to any other penalty provided by law, an employee who violates this Code will be subject to disciplinary action in accordance with the City Personnel Regulations. If you any questions about the appropriateness of an action, you should consult with your supervisor, department head, Human Resources Department, or the City Attorney.

**SUBJECT:** Amendment No. 1 to the Professional Services Agreement with Housing Programs for Single Family Rehabilitation Program Assistance

### **RECOMMENDATION**

Approve Amendment No. 1 to the Professional Services Agreement with Housing Programs for Single Family Rehabilitation Program Assistance.

### **BACKGROUND/DISCUSSION**

The City has successfully participated in the Community Development Block Grant (CDBG) Program for Single Family Rehabilitation for over forty years. Each year the City receives approximately \$180,000 of federal funds to use to assist 15 to 20 low-income Brea homeowners with home repairs, which include correcting health, safety, and building code violations. With the retirement of a Management Analyst II (MAII) in the Community Development Department, there was a significant gap in staff resources to keep this and other housing programs going. While the City explored the alternatives for staffing the housing programs going forward, a consultant was selected to assist with the Housing Rehabilitation Program. The City is contractually committed to continue this program and to meet grant deadlines. Additionally, several low-income homeowners were in various stages of home repairs under the program.

Community Development staff received recommendations from other cities who use consultants to implement their CDBG Housing Rehabilitation Programs. Four consultants were interviewed: AmeriNational Community Services, GRC Associates, Housing Programs, and Lorraine Mendez & Associates. Based on their experience, references, and fees, Housing Programs was recommended to the City Manager, who approved a Professional Services Agreement (PSA) on October 18, 2016, for an amount not to exceed \$24,000. Housing Programs then provided assistance to the Housing Rehabilitation Program on a trial basis to complete the FY 2015-16 grant cycle, which ended December 31, 2016. Housing Programs successfully carried out the remainder of FY 2015-16 projects and four homes were rehabilitated between October and December of last year.

It is now recommended that the City amend Housing Programs' PSA to continue their services. The amendment would add \$84,000 to the PSA and extend the term to the end of FY 2018-19. Beginning in FY 2018-19, the City will be able to cover consultant costs with the CDBG grant. As part of the budget process, Community Development is proposing budget savings by operating the City's affordable housing programs with one less staff position. However, this can only be done if consultant services are also utilized to perform critical related functions.

### COMMISSION/COMMITTEE RECOMMENDATION

The Finance Committee discussed this amendment at their meeting on February 14, 2017 and recommended approval.

### FISCAL IMPACT/SUMMARY

Council is requested to approve Amendment No. 1 to the Professional Services Agreement with Housing Programs to provide service for Brea's CDBG Housing Rehabilitation Program through FY 2018-19. The not-to-exceed amount in this amendment is \$84,000. This would bring the current \$24,000 PSA to \$108,000. This PSA is paid from the Housing Successor Fund, thus the PSA creates no impact on the General Fund. The Housing Successor Fund has sufficient funds in the current budget to cover the additional expense for this Fiscal Year. The remaining amount will be budgeted in FY 2017-18 and FY 2018-19.

#### AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT

This Amendment to Professional Services Agreement is made and entered into this <u>21<sup>st</sup></u> day of <u>February</u>, 2017, by and between the CITY OF BREA, a municipal corporation (hereinafter called the "CITY") and HOUSING PROGRAMS (hereinafter called the "CONSULTANT").

#### A. <u>RECITALS</u>

(i.) On or about October 18, 2016, CITY and CONSULTANT entered into an agreement for professional services, whereby CONSULTANT provides Housing Rehabilitation Program administration services and various related services on an "as-needed" basis ("Agreement", hereinafter.)

(ii.) The parties hereto desire to amend the Agreement to increase the contract amount from \$24,000 to \$108,000.

(iii.) The parties hereto desire to amend the Agreement to extend the contract term from one year to June 30, 2019.

#### B. <u>AMENDMENT</u>

NOW, THEREFORE, it is agreed by and between CITY and CONSULTANT as follows:

- Notwithstanding any other provision therein, the term of the Agreement is hereby increased from \$24,000 to \$108,000, and from one year to June 30, 2019. Except as amended by this Amendment, all other terms and conditions of the Agreement remain unchanged.
- 2. The persons executing this Amendment warrant that they are authorized to execute this Amendment and that this Amendment is binding on the parties hereto.

#### A. NON-OWNED AIRCRAFT

Under Paragraph 2. Exclusions of Section I – Coverage A - Bodily Injury And Property Damage Liability, exclusion g. Aircraft, Auto Or Watercraft does not apply to an aircraft provided:

- 1. It is not owned by any insured;

  - (3) Insurance applies to premises you own, rent, or control but only with respect to the following hazards:
    - a) The existence, maintenance, repair, construction, erection, or removal of advertising signs, awnings, canopies, cellar entrances, coal holes, driveways, manholes, marquees, hoist away openings, sidewalk vaults, street banners, or decorations and similar exposures; or

## BACKGROUND/DISCUSSION

The Treasurer's Report contains information on the investment activities for the month of January 2017. Cash for day-to-day activities is deposited in the demand and interest-bearing checking accounts. The Local Agency Investment Fund (LAIF) is used for short term investment and functions like a savings account. The City's managed investment portfolio is for longer-term investments which are managed through Chandler Asset Management. Together, the short and long-term investment accounts represent the City's investment portfolio. Attachment A includes a Portfolio Summary, Holdings Report, Book Value Report and Compliance with Investment Policy Statement prepared by Chandler Asset Management for the invested funds. The book value is the cost, plus or minus amortization/accretion.

As of January 31, 2017, the total market value of the managed investment portfolio, including accrued interest, was \$63,694,336.32 as compared to \$63,575,364.01 at December 31, 2016. The weighted average investment yield for January 2017 was 1.51%, which was slightly higher from the prior month of 1.47%. The City's Local Agency Investment Fund (LAIF) had a total market value, including accrued interest of \$5,704,199.13 at January 31, 2017. This brings the total value of the City's investment portfolio as of January 31, 2017 to \$69,398,535.45, as compared to \$67,774,765.16 at December 31, 2016.

Restricted cash and investments are held in the post-employment benefits trust account administered by PARS and managed by High Mark Capital and the City's various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a monthly statement from US Bank for the PARS account as well as a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of January 31, 2017, the market value of these funds, including short-term cash and accrued interest were \$6,492,172.89 and \$6,705,855.17, respectively. Furthermore, the City of Brea holds 2,106.5 shares of water common stock with Cal Domestic totaling \$6,692,116.02 and 687.85 shares of Class A preferred stock with Pellissier Co-Tenancy, totaling \$8,444,403.67.

All City investments are GASB rated No. 1, where the custodian (The Bank of New York Mellon Trust Company, N.A.) acts as an agent of the City, and is not a counter party to the investment transaction, and all securities are held in the name of the City of Brea. The custodial account at

Bank of New York and account records with Chandler Asset Management have been reconciled to par value for the month. The City of Brea has sufficient cash flow to meet its expected expenditures for the next six months.

## FISCAL IMPACT/SUMMARY

During the month of January, the total value of the City's investment portfolio increased by \$1,623,770.29. The increase was primarily due to receipt of property taxes and sales tax. The total value of the City's restricted cash and investment accounts decreased by \$733,679.03 primarily due to debt service payments for the City's 2010 and 2014 Water Revenue Bonds.

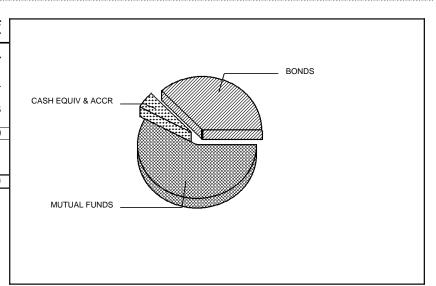

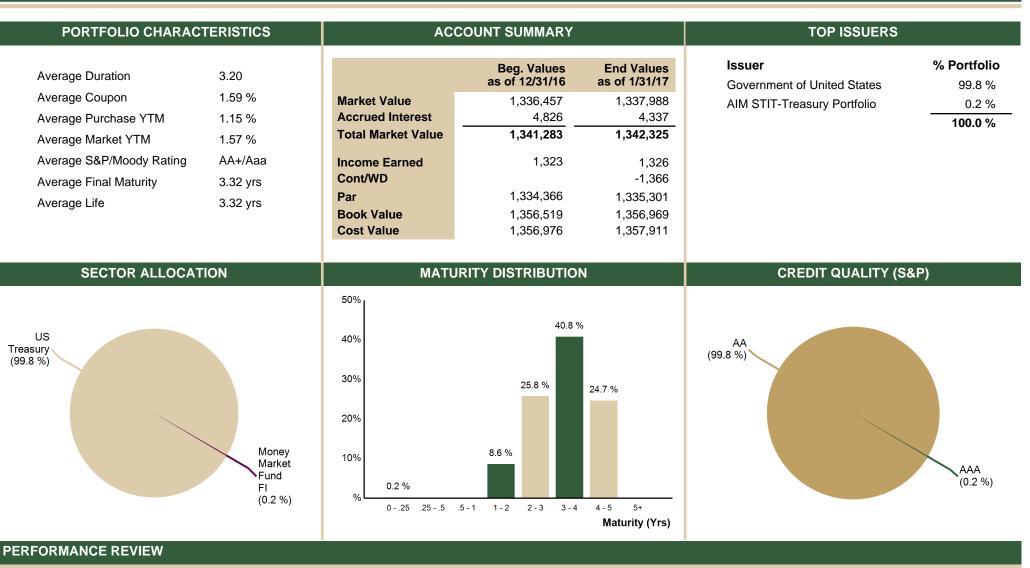

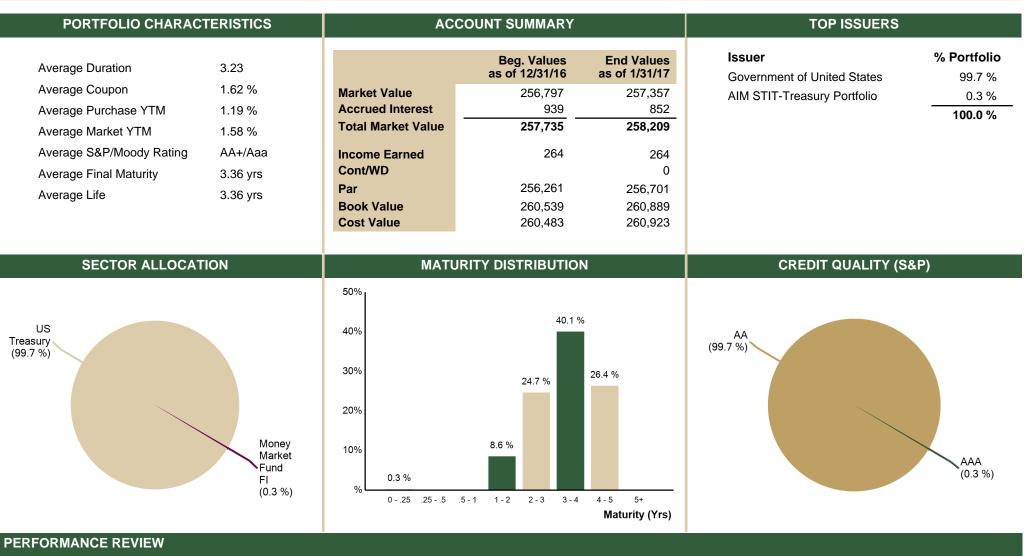

## **RECOMMENDATION**

## BACKGROUND/DISCUSSION

The Treasurer's Report contains information on the investment activities for the month of January 2017. Funds received by the Successor Agency are typically spent within 3-6 months; therefore are not invested long-term. The Successor Agency's Local Agency Investment Fund (LAIF) is used for short-term investments and functions like a savings account until funds are required to meet expenditures needs. Attachment A includes a Portfolio Summary and Holdings Report prepared by Chandler Asset Management for the funds invested by the City. As of January 31, 2017, the market value, including accrued interest on the Successor Agency's Local Agency Investment Fund (LAIF), was \$2,602,714.72 in comparison to \$301,252.94 at December 31, 2016. The Successor Agency to the Brea Redevelopment Agency has sufficient cash flow to meet its expected expenditures for the next six months.

The Successor Agency also has restricted (fiscal agent) cash and investment accounts related to its various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of January 31, 2017, the market value of these funds, including short-term cash and accrued interest was \$30,184,021.81 as compared to \$15,634,716.11 as of December 31, 2016.

## FISCAL IMPACT/SUMMARY

During the month of January, the total value of the Successor Agency to the Brea Redevelopment Agency's investment portfolio increased by \$2,301,461.78 and the total value of the restricted cash and investments increased by \$14,549,305.70. This is primarily due to a payment received from the County to address the obligations (including debt service payments) identified within the Agency's Recognized Obligation Payment Schedule (ROPS).

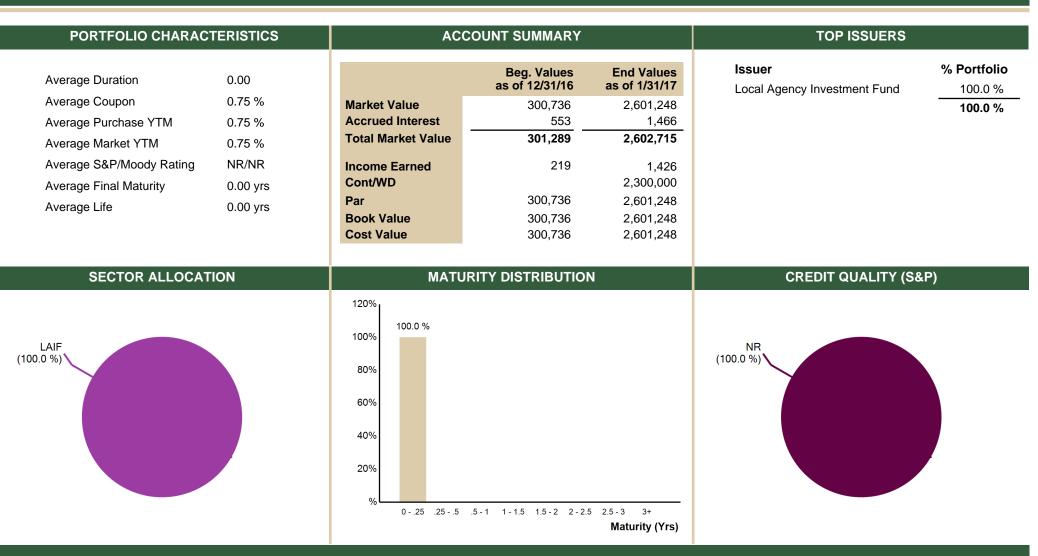

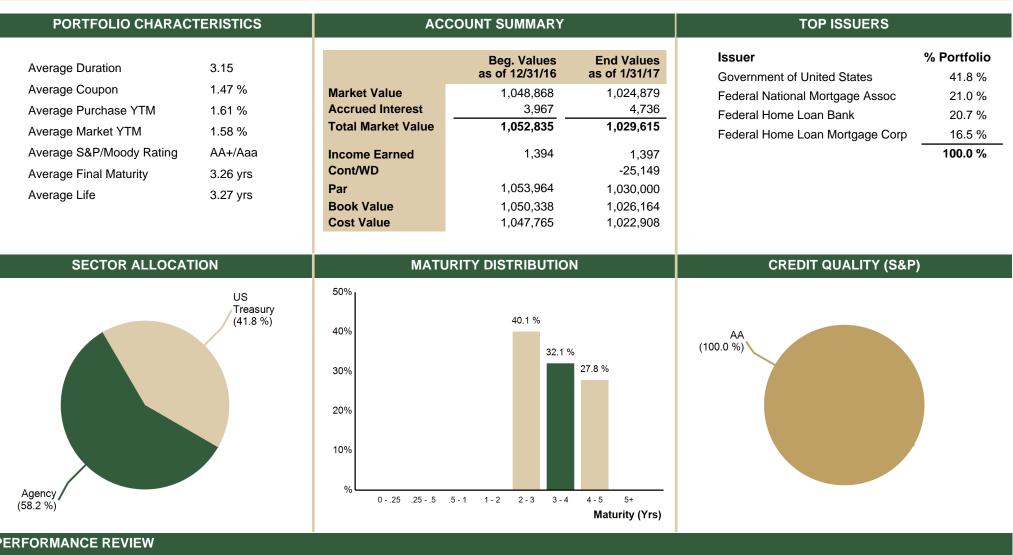
