Mr. Emeterio advised the Commission that the recruitment to fill the vacancy created by the resignation of Commissioner Lanzisera, will close at 5 p.m. on Tuesday, March 28, and that Council will be conducting interviews immediately with the expectation that the new appointee will be named at the April 4, 2017, City Council meeting.

Mr. Matlock shared the video created by vendor, Landscape Structures, stating that even though they are a playground equipment vendor, the video is not about selling, rather it contains an important message.

STUDENT ADVISORY BOARD

Student Advisory Board (SAB) Vice Chair, Cassidy Phillips, reported that SAB members volunteered at Brea's 100th Birthday Celebration serving cake and supervising arts and crafts for the children; they also helped at the Spring Boutique working in the café and helped at the 6th Grade Dance. They will be volunteering at Love Brea on April 29 and are involved with planning an event on May 27 at The Tracks at Brea. Finally she reported on activities at Brea Olinda High School advising that the Cheerleaders are going to Nationals and that the Choir swept all the awards in a recent competition in which they participated.

Mr. Emeterio added that ten to twelve members of the SAB participated in the Brea Envisions Workshop and Commissioner Livingston, a member of the Brea Envisions Committee, indicated that the students were engaged, open and that their input was appreciated by the Committee.

SCHOOL DISTRICT REPRESENTATIVE

School District representative, Barbara Ott, reported that spring break is scheduled for April 10 to 14 and that there are 54 days left in the school year. She also reported that although some enthusiasm was lost when the Centennial parade had to be rescheduled, all of the schools are again excited to be participating in the parade and that approximately 30 members of the 501st Legion will be in the parade and at the picnic.

Project Updates

Lagos de Moreno Park/Laurel Elementary School Rehabilitation

Using a PowerPoint presentation, Mr. Matlock shared a conceptual drawing of the playground equipment and elevations of the two areas, pointing out that the playground area will be lowered; an ADA ramp added; and the solid wall that will be built parallel to Birch Street, will not be visible from the street. He also reviewed the original cost estimates and possible cost estimate changes indicating that any changes will be brought back to the Commission. It is expected to go to City Council on April 18 with the recommendation to authorize going out to bid with bids closing on the May 15.

The Tracks at Brea

Mr. Matlock reviewed the status of each of the segments of The Tracks at Brea reporting that Segments 1 and 3 are open (with amenities being added to Segment 3) and that it is anticipated that Segment 5 through the Brea Hills Golf Course will be open soon; Segment 6 along the Loftus Channel is expected to be completed in August; and Segment 2 along the Brea Channel is expected to be completed in September. Plans for Segment 4 have been approved and the project will be going out for construction bids.

Centennial Celebration

Photographs of the events celebrating Brea's 100th Birthday were shared including the Sister Cities luncheon with representatives from all three Sister Cities in attendance; the ribbon cutting for the Gallery opening of *The Birth of Motion Pictures;* and the Special City Council meeting where three centenarians were honored. Commissioners were advised that the new date for the parade and picnic is May 20 with the parade starting at 9 a.m. and the picnic running from 11 a.m. to 3 p.m. Chair Higgins elaborated on the parade and picnic indicating that he thought the new date would be even better than the original date that was rained out. Commissioners were also informed that Randy Jones

and Andrea Barber (Kimmy Gibbler on *Fuller House*) have been confirmed as Parade Grand Marshals and that the Wells Fargo Bank stagecoach and 501st Legion (in their replica Star Wars costumes) will be in the parade.

INFORMATION MEMORANDUM

Commissioners were directed to Park Development Funds and were advised that part-in-lieu fees are expected from Central Park Village within the next month or two. Articles on the Brea 8k and the special birthday celebration for Ida McKenzie as well as the other Brea Centenarians who were honored at the Special City Council meeting celebrating the City's 100th Birthday were also highlighted.

Commissioners Livingston and Shatynski indicated that they would be able to accompany staff on tours of their respective parks, i.e., Wildcatters Park on April 5 and the Sports Park on May 3. Mr. Beckman addressed questions raised regarding Little League's funds and graffiti removal.

Commission Livingston reported that he attended a meeting of the Art in Public Places Advisory Committee and that they were looking forward to the installation of the Albertsons' art piece. He also reported that the Committee discussed costs for the Centennial Legacy sculpture being created by artist, Carlos Terres, and that the Committee supported using art in lieu funds for the piece.

Staff

Mr. Beckman advised Commissioners that the old tube type lights in the restrooms at Tamarack Park are being replaced with LED lights and if they are successful, lights in all of the City parks' restrooms will also be replaced.

Mr. Emeterio reported that a question has been raised as to what The Tracks at Brea would look like if the tracks were extended west towards La Habra and whether the City could partner with Union Pacific for an easement.

Ms. Hernandez reported that Love Brea, a day of volunteerism, is scheduled for Saturday, April 29, and that about 15 projects have been identified to date. She also reported that approximately 220 people have volunteered so far and that staff is expecting a good turnout. Commissioner Shatynski reported that he has volunteered.

- 2. Accept Sewer Lift Station Improvements, and
- 3. Approve Access Easement Agreement for Sewer Lift Station.

BACKGROUND/DISCUSSION

Tentative Tract Map 16934 for the La Floresta Development was conditionally approved by Planning Commission Resolution No. PC 2010-57 on September 23, 2008. The property is located at the northeast corner of Imperial Highway and Valencia Avenue, formerly known as Unocal Research Center. During the initial review of the La Floresta project, the sewer system was planned to discharge into the City of Placentia's sewer collection system. The City of Placentia wanted the developer to substantially upgrade their sewer mains and it was decided to install a sewer lift station that would pump the material north and directly into the OCSD main trunk line in Rose Drive. See attached Exhibit 'A' for sewer lift station location.

Subsequently, the final conveyance Tract Map 17150, a part of Tentative Tract Map 16934, was approved by City Council on May 11, 2011. This final map subdivided the La Floresta development into 19 number lots for future planning areas and 48 letter lots for private streets, landscape open space and the sewer lift station. Lot QQ was irrevocably offered to dedicate to the City of Brea in fee for sewer lift station purposes on Tract Map 17150. However, at the time of final map approval, the City Council rejected the dedication until such time when the sewer lift station improvements were completed. A copy of the map is attached as Exhibit 'B' for reference. Now that the sewer lift station has been completed and the conditions of approval associated with this have been satisfied, Lot QQ will need to be accepted as part of the sewer lift station acceptance.

The construction of the sewer lift station was completed and has been in operation since May, 2014. It was stipulated in the development agreement for La Floresta development (DA 08-01) that the master developer, La Floresta, LLC, would operate and maintain the sewer lift station until the 300th occupancy before the City accepts the sewer lift station. La Floresta development was granted the 300th occupancy, hence, the sewer lift station is ready for the City to accept and maintain. However, in order for the City to begin maintaining this sewer lift station, an access easement is required over the landscape lots (Lot KK and Lot LL) with the offer to dedicate Lot QQ.

These landscape lots are currently owned by La Floresta Maintenance Corporation (HOA). Therefore, the terms and conditions for the access easement are included in the Access Easement Agreement (Agreement) between the City and HOA. This Agreement has been reviewed and approved as to form by the City Attorney's office.

FISCAL IMPACT/SUMMARY

The majority of the La Floresta development is served by this sewer lift station and proper operation and maintenance is needed. Jamison Engineering has been maintaining this sewer lift station for the past years for the developer. In addition, City Council approved the Maintenance Agreement with Jamison Engineering on May 31, 2016, in anticipation of accepting the sewer lift station improvements. The ongoing maintenance cost will be covered by the Sewer Fund. Therefore, there will be no General Fund Impact.

Staff is recommending the acceptance of the Lot QQ dedication and sewer lift station improvements, as well as approving the Access Easement Agreement to finalize the sewer lift station and take over the maintenance in accordance with the La Floresta Development Agreement.

ACCESS EASEMENT AGREEMENT (Sewer Lift Station)

This Access Easement Agreement (this "Agreement") is made as of April _____, 2017 (the "Effective Date"), by and between LA FLORESTA MAINTENANCE CORPORATION, a California nonprofit mutual benefit corporation ("Grantor"), and the CITY OF BREA, a municipal corporation ("Grantee").

RECITALS

- A. Grantor is the owner of certain real property situated in the City of Brea, County of Orange, State of California (Lots KK & LL of Tract 17150; APN: 320-351-45 & 320¬351-46), and more particularly described in <u>Exhibit "A"</u> attached hereto and incorporated herein by this reference (the "Master Association Property").
- B. La Floresta, LLC, a Delaware limited liability company ("La Floresta, LLC"), is the owner of certain real property situated in the City of Brea, County of Orange, State of California (Lot QQ of Tract 17150; APN: 320-351-43), and more particularly described in <u>Exhibit</u>"B" attached hereto and incorporated herein by this reference (the "La Floresta Property").
- C. La Floresta, LLC is in the process of granting to Grantee fee title ownership of the La Floresta Property.
- D. As of the Effective Date, a sewer lift station owned by La Floresta, LLC (the "Sewer Lift Station") is located on the La Floresta Property in the approximate location shown on the site plan attached hereto as Exhibit "C-1" and incorporated herein by this reference (the "Site Plan").
- E. Grantor desires to grant to Grantee and Grantee desires to obtain from Grantor certain covenants and easements with respect to the Master Association Property and access to the Sewer Lift Station, all as more specifically set forth below.

NOW THEREFORE, for good and valuable consideration, the parties hereto agree as follows:

1. Grant of Easement. Subject to the terms and conditions of this Agreement, and conditioned on Grantee obtaining fee title ownership of the La Floresta Property, Grantor hereby

grants to Grantee, for the benefit of Grantee and the La Floresta Property, a perpetual nonexclusive easement, appurtenant to the La Floresta Property, over and across the portion of the Master Association Property described on Exhibit "C-2" attached hereto and incorporated herein by this reference, and depicted on the Site Plan (the "Easement Area"), for the purpose of accessing the Sewer Lift Station.

- 2. Exercise of Easement Rights. In using the Easement Area under this Agreement, the Grantee shall make commercially reasonable efforts not to interfere with the reasonable use of the Master Association Property by Grantor and Grantor's licensees. Grantee's exercise of its rights under this Agreement shall be in accordance with all applicable laws.
- 3. Indemnity. Grantee covenants and agrees to indemnify, defend, and hold harmless Grantor, and each of Grantor's affiliates, and their respective partners, members, directors, officers, agents, employees, contractors successors and assigns (collectively "Indemnified Parties" and each singularly a "Indemnified Party") from and against all claims, demands, damages, actions, losses, costs, expenses and liabilities (including, without limitation, reasonable attorneys' fees and expenses incurred as a result of such claims or in enforcing this indemnity provision) incurred in connection with any personal injury or property damage caused by Grantee and arising out of the use by Grantee or its employees or contractors of the easement granted to Grantee in this Agreement, except for, and to the extent of, any claims caused by the negligence or willful misconduct of Grantor or any Indemnified Party. Grantee's defense and indemnification obligations under this Section 3 shall survive the expiration or earlier termination of this Agreement with respect to activities by Grantee prior to the expiration or earlier termination of this Agreement.
- Liens. Grantee agrees to keep the Master Association Property free of any mechanic's or materialmen's liens resulting from use of the Easement Area by Grantee or Grantee's partners, members, directors, officers, agents, employees, consultants, or contractors, and Grantee shall indemnify, defend and hold Grantor and all other Indemnified Parties harmless from any and all liability, claims, damages, expenses (including reasonable attorneys' fees and costs incurred as a result of such claims or in enforcing this indemnity provision), liens, claims of lien, judgments, proceedings and causes of action arising out of, or in any way resulting from any lien recorded against the Master Association Property or any portion thereof (each a "Lien Encumbrance") as a result of such use. Notwithstanding anything herein to the contrary, Grantee shall not be required, nor shall Grantor have the right, to pay, discharge or remove any Lien Encumbrance, as long as (a) Grantee is contesting in good faith the existence, amount or validity of the Lien Encumbrance in question by appropriate proceedings or actions, and (b) such proceedings or other actions do not subject Grantor or any Indemnified Party (including any successor owner) to material risk of any criminal or civil liability. Grantee's defense and indemnification obligations under this Section 4 shall survive the expiration or earlier termination of this Agreement.
- 5. Maintenance and Repairs. Grantee's use of the Easement Area for access to the Sewer Lift Station on Lot QQ includes the use by Grantee for their vehicles to drive over the asphalt paved portion of that Area. Grantee shall be solely responsible for (i) all repair and maintenance of that asphalt area on the Easement Area to the extent the need for repair is not caused by the Grantor or any of their officers, employees, contractors or invitees (excluding

Grantee); and (ii) any liability arising from use of the Easement Area by Grantee or its employees or contractors. In addition, to the extent that Grantee's use of the Easement Area results in any damage to any portion of the Master Association Property, Grantee, at Grantee's sole cost and expense, shall promptly repair such damage.

- 6. Term. The easements, covenants, and obligations set forth in this Agreement shall continue in full force and effect in perpetuity from the date of recordation hereof, unless this Agreement is amended or terminated by a written agreement executed, acknowledged and recorded by the parties hereto or their successors and assigns.
- 7. Binding Effect/Runs with Land. All terms, conditions, covenants, easements or obligations set forth in this Agreement will be binding upon and inure to the benefit of the parties hereto, and to their respective successors, assigns and successors-in-interest. All provisions of this Agreement, including the benefits and burdens, will run with the Master Association Property and La Floresta Property and are imposed upon the Master Association Property as an easement and as equitable servitudes in favor of Grantee, pursuant to Civil Code Sections 1462 and 1468 of the State of California, as the same may be amended from time to time and any successor statutes thereof, and other applicable law.

8. Miscellaneous.

- (a) Captions. The captions of this Agreement are inserted only as a matter of convenience and for reference. They do not define, limit or describe the scope or intent of this Agreement and they shall not affect the interpretation hereof.
- (b) Amendment. This Agreement may be amended only by an instrument in writing executed by the parties hereto or their successors and assigns.
- (c) Attorneys' Fees. If any legal action or proceeding arising out of or relating to this Agreement is brought by either party to this Agreement, the prevailing party shall be entitled to receive from the other party, in addition to any other relief that may be granted, the reasonable attorneys' fees, costs, and expenses incurred in the action or proceeding by the prevailing party.
- (d) Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of California.
- (e) Entire Agreement. This Agreement constitutes the entire agreement between Grantor and Grantee with respect to the specific subject matter hereof and supersedes all oral statements and prior understandings relating hereto. Except as set forth in this Agreement, no representations, warranties, or agreements have been made by Grantor or Grantee to the other with respect to this Agreement or the obligations of Grantor or Grantee.
- (f) Counterparts. This Agreement may be executed in counterparts, each of which shall constitute an original, and all of which together shall constitute one and the same instrument.

Site Plan

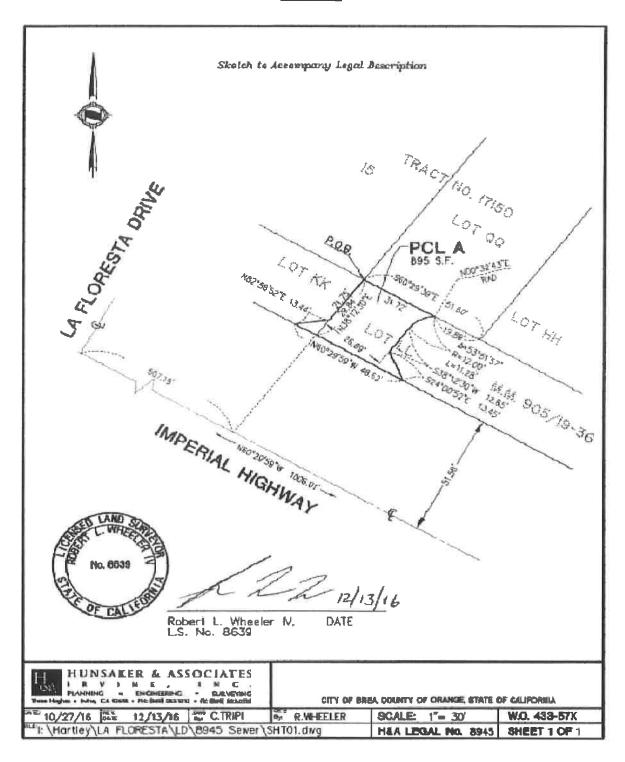

SUBJECT: Plans and Specifications for Central Avenue and Tamarack Avenue Intersection

Improvement, Project 7310

RECOMMENDATION

Approve Plans and Specifications and authorize City Clerk to advertise and receive bids.

BACKGROUND/DISCUSSION

The Central Avenue and Tamarack Intersection Improvement, Project 7310 (Project) is included in the FY 2016-2017 Capital Improvement Program (CIP). This Project will enhance the flow of traffic along Central Avenue in the westbound direction by adding a dedicated westbound right turn lane at the intersection of Tamarack Avenue. The additional right-of-way needed for this improvement has been previously dedicated at the northeast corner of the intersection.

This Project will widen the north side of Central Avenue east of Tamarack Avenue to provide a dedicated westbound right turn lane. The improvements will include modifying the traffic signal, and reconstruction of sidewalks, curb and gutter, and curb access ramps at the northeast corner of the intersection. In addition, Tamarack Avenue will also be reconstructed north of Central Avenue to approximately 250 feet northerly to provide a proper transition due to the existing steep street grade at Tamarack Avenue. The reconstruction of Tamarack Avenue may require a full or partial street closure during the construction period. The coordination and Right of Entry Agreements with several properties are in progress, including the apartment north of the gas station, Shell Gas Station, 7-11 Plaza and the property adjacent to 7-11 Plaza. Due to its proximity to Mariposa School, this improvement/street closure is scheduled to be constructed during the school break.

If approved, bids will be received on June 5, 2017, with award tentatively scheduled for the City Council meeting on June 20, 2017. Construction is anticipated to start in July 2017 and expected to be completed in September 2017. Staff is expecting to significantly complete the Project by the end of August with some lane closures in September to complete the Project. Staff ordered the Traffic Signal poles separate from the construction contract in April 2017 in order to meet the tight schedule for completion and to stay within the expected lead time for the procurement.

FISCAL IMPACT/SUMMARY

The Project's overall budget was estimated at \$550,000 including design, construction, and construction management in the FY 2016/2017 CIP. However, based on the current probable construction estimate of approximately \$600,000 inclusive of a 10% contingency, an additional \$230,000 has been proposed for FY 2017-2018 within the annual CIP update to fully fund the Project. Therefore, if required based on the lowest responsible bid amount received, the construction contract award will be contingent on City Council's approval and adoption of the annual FY 2017/2018 CIP update, which is planned for June 2, 2017 or a separate budget resolution adjustment would be required at time of award. The Project is funded with Fund 220 (Gas Tax). Therefore, there is no General Fund impact.

The Project will widen the north side of Central Avenue east of Tamarack Avenue to construct a dedicated westbound right turn lane to enhance the westbound through traffic on Central Avenue. Plans and Specifications have been approved by the City Engineer and are ready for bid. Therefore, staff is recommending City Council consider approving the Plans and Specifications and authorization to advertise and receive bids for the Project.

Replacement, Phase 2, Project 7928 in the Amount of \$116,278.00

RECOMMENDATION

1. Adopt Resolution to appropriate an additional \$85,000 from the Fixed Asset Replacement Fund, FARP (Fund 182) for Project Construction and Project Administration.

2. Receive bids, proceed with the award of an informal Contract to Commercial Roofing Systems, Inc. in the amount of \$116,278.00, and authorize Public Works Director or his designee to issue Contract Changes up to a "not to exceed" amount of 15% of the Contract.

BACKGROUND/DISCUSSION

The Civic and Cultural Center Roof Replacement Project 7928, (Project), was approved for construction as part of the Capital Improvement Program (CIP). The Project consists of repairing and replacing sections of the 37 year old existing roof system with City furnished roofing material to the existing Civic Center main building, Conference Center, and Curtis Theater buildings in accordance with the current building code requirement.

On October 13, 2015, staff received four (4) informal bids from the following contractors; Chapman Coast Roof Co., Inc., Letner Roofing Co., Best Contracting Services, Inc. and Commercial Roofing Systems, Inc. The low bid amount was \$250,436.00. Unfortunately, the low bid amount exceeded the informal bidding threshold allowed (\$175,000) and there were insufficient funds to fully fund the Project (remaining budget was \$218,000 for construction after the purchase of material). In an effort to minimize the impact of El Nino weather forecasted that year, staff decided to break the project into two phases. Phase 1 scope pertained to the re-roof of the Civic Center main building and Phase 2 included the re-roof of the Conference Center and Curtis Theater buildings. Given the timing and budget considerations, it was decided to re-bid Phase 1 first.

On November 02, 2015, six (6) informal bids were received for Phase I. The lowest responsive bidder was Chapman Coast Roof Co., Inc. with a bid of \$173,353.00. The informal contract was then awarded to Chapman Coast Roof Co., Inc. to complete the re-roofing of the Civic Center main building. Chapman Coast Roof Co., Inc. completed Phase 1 of the Project on February 12, 2016 with a final cost of \$173,994.83, including contract change orders amounting to less than a half of one percent. After completion of Phase 1, the remaining balance in the Project budget was approximately \$35,000. In April 2016, staff requested an additional \$75,000 for a revised budget of approximately \$110,000. The additional \$75,000 for the Phase 2 Project budget was

recommended by the consultant based on the previous bids received in October 2015 for the two remaining roofs.

On July 7, 2016, staff received five (5) informal bids for Phase 2 with the lowest bid in the amount of \$153,376.00 from Commercial Roofing Systems, Inc. In speaking to the contractors, the high bids were due to an enormous workload demand of the contractors in the roofing industry. As a result, after purchasing the roofing material directly from the roofing manufacture/supplier (The Garland Company, Inc.) for Phase 2, there was approximately \$69,000 remaining in the Project budget.

On April, 17, 2017, staff received five (5) in-formal bids for Project 7928 Phase 2 with the following results:

1.	Commercial Roofing, Inc.	\$116,278.00
2.	Western States Roofing, Inc.	\$128,935.40
3.	Chapman Coast Roof Co., Inc.	\$132,862.00
4.	Best Contracting Services, Inc.	\$156,300.00
5.	Tecta America, Inc.	\$187,000.00

The apparent lowest responsible bidder was Commercial Roofing Systems, Inc. of Arcadia, California in the total amount of \$116,278.00, which is under the informal bid threshold of \$175,000. However, the bid amount exceeds the remaining Project budget balance by approximately \$47,000 without a contingency. Therefore, an additional budget appropriation will be required in order to proceed with the contract award. The company has a valid contractor's license and has been in the construction business for 27 years. Commercial Roofing Systems, Inc. has been prequalified with The Garland Company, Inc., to use their product. If awarded, construction could begin in late May 2017, and take approximately two (2) months to complete or by August 2017.

COMMISSION/COMMITTEE RECOMMENDATION

The Finance Committee reviewed staff's recommendation at their April 25, 2017 meeting and recommended to proceed.

FISCAL IMPACT/SUMMARY

The total approved budget for the Project is \$425,000 with funding coming from the Fixed Asset Replacement Program, FARP (Fund 182). The remaining budget amount is approximately \$69,000. Therefore, in order to award the contract to Commercial Roofing, Inc. (\$116,278), with a recommended 15% Contract Change Order contingency (\$17,442), and construction engineering support (\$20,058), staff is requesting City Council consider an additional \$85,000 from the FARP Fund (Fund 182). A Resolution appropriating the added funds from the FARP Fund (Fund 182) to the Project is attached for City Council consideration and approval (see Attachment 'B' for Resolution). Based on the available funds within Fund 182, there will be no General Fund impact from this action. The following table provides a breakdown of the construction and construction engineering budget with the requested additional funds:

The Project will repair and replace sections of the Civic Center Main, Conference Center and Curtis Theater buildings. Due to budget constraints, this Project phased. Phase 1, the Civic Center Main Building Re-roof, was completed in February 2016. Phase 2 consists of the re-roofing of the Conference Center and Curtis Theater buildings. Five (5) bids for Phase 2 were received on April 17, 2017. The apparent lowest responsive bidder was Commercial Roofing Systems, Inc. in the amount of \$116,278.00, as depicted on page C-3 of their proposal (see Attachment "A" for Proposal).

As depicted in the budget summary, staff is requesting that City Council adopt a Resolution to appropriate an additional \$85,000 from FARP to fully fund Phase 2. In addition, staff is requesting that City Council consider proceeding with the informal bid award process with the Public Works Director awarding a Construction Contract to Commercial Roofing Systems, Inc in the amount of \$116,278.00. Additionally, staff is recommending City Council authorize the Public Works Director or his designee to issue Contract Change Orders up to a "not to exceed" amount of 15% of the Contract amount.

A. <u>RECITALS:</u>

- (i) The City Council has determined that it is in the best interest of the City of Brea to appropriate funds from the Fixed Asset Replacement Program Fund (182), to the Capital Improvement Program Fund (510), for Project 7928 for the fiscal year 2016-17.
- (ii) The Capital Improvement Program Budget, Resolution No. 2016-049, and subsequent amendments, did not appropriate funds for this unanticipated adjustment.

B. RESOLUTION:

NOW, THEREFORE, be it found, determined and resolved by the City Council of the City of Brea that Capital Improvement Program Budget, Resolution No. 2016-049, as heretofore amended, be further amended to:

- Increase funding from the Fixed Asset Replacement Program Fund (182)
 Capital Improvement Program Fund (510) for Project 7928, Civic and Cultural Center
 Roof Replacement, by \$85,000; and
- 2. Appropriate an additional \$85,000 to the Capital Improvement Program Fund (510) for Project 7928, Civic and Cultural Center Roof Replacement.

BACKGROUND/DISCUSSION

The Treasurer's Report contains information on the investment activities for the month of March 2017. Cash for day-to-day activities is deposited in the demand and interest-bearing checking accounts. The Local Agency Investment Fund (LAIF) is used for short term investment and functions like a savings account. The City's managed investment portfolio is for longer-term investments which are managed through Chandler Asset Management. Together, the short and long-term investment accounts represent the City's investment portfolio. Attachment A includes a Portfolio Summary, Holdings Report, Book Value Report and Compliance with Investment Policy Statement prepared by Chandler Asset Management for the invested funds. The book value is the cost, plus or minus amortization/accretion.

As of March 31, 2017, the total market value of the managed investment portfolio, including accrued interest, was \$63,881,279.47 as compared to \$63,820,580.16 at February 28, 2017. The weighted average investment yield for March 2017 was 1.56%, which was slightly higher from the prior month of 1.52%. The City's Local Agency Investment Fund (LAIF) had a total market value, including accrued interest of \$6,211,983.00 at March 31, 2017. This brings the total value of the City's investment portfolio as of March 31, 2017 to \$70,093,262.47, as compared to \$71,528,218.06 at February 28, 2017.

Restricted cash and investments are held in the post-employment benefits trust account administered by PARS and managed by High Mark Capital and the City's various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a monthly statement from US Bank for the PARS account as well as a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of March 31, 2017, the market value of these funds, including short-term cash and accrued interest were \$6,637,884.74 and \$6,688,741.38, respectively. Furthermore, the City of Brea holds 2,106.5 shares of water common stock with Cal Domestic totaling \$6,692,116.02 and 687.85 shares of Class A preferred stock with Pellissier Co-Tenancy, totaling \$8,444,403.67.

All City investments are GASB rated No. 1, where the custodian (The Bank of New York Mellon Trust Company, N.A.) acts as an agent of the City, and is not a counter party to the investment transaction, and all securities are held in the name of the City of Brea. The custodial account at

Bank of New York and account records with Chandler Asset Management have been reconciled to par value for the month. The City of Brea has sufficient cash flow to meet its expected expenditures for the next six months.

FISCAL IMPACT/SUMMARY

During the month of March, the total value of the City's investment portfolio decreased by \$1,434,955.59. The decrease was primarily due to the Solar Lease Debt payment, Downtown Parking Structure progress payment and normal operating expenditures. The total value of the City's restricted cash and investment accounts decreased by \$96,861.94 primarily due to investment activity.

BACKGROUND/DISCUSSION

The Treasurer's Report contains information on the investment activities for the month of March 2017. Funds received by the Successor Agency are typically spent within 3-6 months; therefore are not invested long-term. The Successor Agency's Local Agency Investment Fund (LAIF) is used for short-term investments and functions like a savings account until funds are required to meet expenditures needs. Attachment A includes a Portfolio Summary and Holdings Report prepared by Chandler Asset Management for the funds invested by the City. As of March 31, 2017, the market value, including accrued interest on the Successor Agency's Local Agency Investment Fund (LAIF), was \$2,606,074.24 in comparison to \$2,604,264.76 at February 28, 2017. The Successor Agency to the Brea Redevelopment Agency has sufficient cash flow to meet its expected expenditures for the next six months.

The Successor Agency also has restricted (fiscal agent) cash and investment accounts related to its various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of March 31, 2017, the market value of these funds, including short-term cash and accrued interest was \$27,557,070.94 as compared to \$27,368,456.19 as of February 28, 2017.

FISCAL IMPACT/SUMMARY

During the month of March, the total value of the Successor Agency to the Brea Redevelopment Agency's investment portfolio increased by \$1,809.48 due to accrued interest. The total value of the restricted cash and investments increased by \$188,614.75. This increase is primarily due to accrued interest as well.

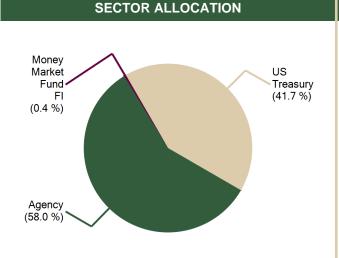

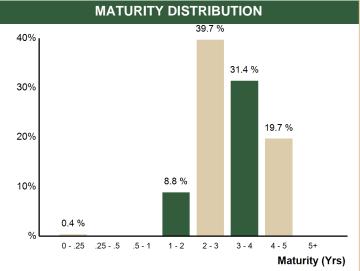

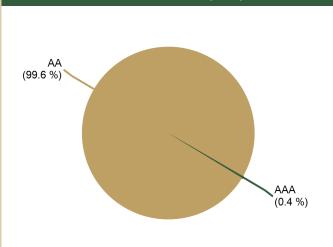
