SUBJECT: Approval of Zoning Ordinance Amendment No. Zoa 17-01 and Related Municipal Code Amendments (Chapter 8.48), Prohibiting All Medical and Non-Medical Commercial Cannabis Activity, Prohibiting Outdoor Cultivation and Regulating Indoor Cannabis Cultivation, Consistent with State Law

RECOMMENDATION

Approve Ordinance No. 1200 for second reading, approving Zoning Ordinance Amendment No. ZOA 17-01, and related municipal code amendments, prohibiting all medical and non-medical commercial cannabis and non-medical commercial cannabis activity, prohibiting outdoor cultivation, and regulating indoor cannabis cultivation, consistent with State law.

BACKGROUND/DISCUSSION

Since 2015, California law has been evolving with new legislation regarding marijuana/cannabis land use and activities. To respond to changes made to state law, the City of Brea adopted and modified Chapter 20.70, to maintain local land use control and prohibit all commercial cannabis activities in the City. In 2016, California voters passed Proposition 64, legalizing limited personal and recreational use of cannabis. Included in the provisions of the new law is the ability for local jurisdictions to regulate commercial cannabis land uses and activities.

In December 2016, the City adopted interim Ordinance 1190 allowing time to review the new law, consideration of potential impacts and land use effects and crafting of a permanent Ordinance to address land use issues, define terms and provide clarification for personal and commercial activities as they relate to the City of Brea. Although the City is in the process of adopting its permanent Ordinance, there is a gap in the timing of the adoption period and the January 1, 2018 state law timing. To ensure the City's current prohibition on commercial cannabis is protected, the City Council adopted an extension to Interim Ordinance 1190 on October 17, 2017. Figure 1 provides an overview of the history of actions related to marijuana land uses and activities.

Figure 1 - History of Actions

On January 1, 2018, commercial cannabis activities will begin to be licensed by the State pursuant to the Medicinal and Adult Use Cannabis Regulation and Safety Act (MAUCRSA) (Senate Bill No. 94 enacted on June 27, 2017). The City of Brea wants to maintain current restrictions prohibiting commercial cannabis land uses and related activities within the City to the extent permitted by State law. Section 20.70 of the Zoning Code was adopted prior to the most recent changes to state law and does not provide the level of specificity to address cultivation, sales, delivery and similar commercial land uses which were not previously allowed by the State. The proposed amendment includes the addition of Chapter 8.48 of the Municipal Code and revisions to Chapter 20.70 of the Brea Zoning Code and provides the following (see Attachment 2 for the draft Ordinance):

- Updated language to reflect the prohibition of commercial cannabis uses as opposed to the prohibition of commercial "marijuana" uses; the change from marijuana to cannabis clarifies the prohibitions includes all strains of the marijuana plant. This language ensures there is no confusion or misunderstanding related to cannabis or cannabis products;
- Parameters for indoor cultivation taking into account the maximum number of plants allowed within a private residence and the conditions in which the plants can be kept; and
- Prohibitions and exceptions related to commercial cannabis activity and private use allowed under state law
- New definitions and standards consistent with state law.

This Item was taken to council for first reading on November 21, 2017.

ENVIRONMENTAL ASSESSMENT

The proposed project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061, Class 3 (b) Article 5 because it can be seen with certainty

that there is no possibility that the project to prohibit commercial cannabis activity will have a significant negative impact on the environment. The project will not result in permanent alteration of property or the construction of any new or expanded structures. The project by itself does not result in any physical changes in the environment. The project is also eligible for a Class 5 categorical CEQA exemption pursuant to Section 15305 Article 19 of Title 14 (minor alterations in land use). Since the project is prohibiting all commercial cannabis uses, it will not result in changes in land use or density and will not have a significant environmental impact.

COMMISSION/COMMITTEE RECOMMENDATION

On October 17, 2017, the Planning Commission acted (5-0) to recommend approval of Zoning Ordinance Amendment No. ZOA 17-01 to the City Council.

FISCAL IMPACT/SUMMARY

The proposed code amendment has no fiscal impact anticipated.

ORDINANCE NO. 1200

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BREA APPROVING ZONING ORDINANCE AMENDMENT RELATED NO. 17-01 AND MUNICIPAL CODE AMENDMENTS, PROHIBITING ALL MEDICAL AND NON-MEDICAL COMMERCIAL CANNABIS ACTIVITY, PROHIBITING OUTDOOR CULTIVATION. AND REGULATING INDOOR CANNABIS CULTIVATION, **CONSISTENT WITH STATE LAW**

A. RECITALS:

The City Council of the City of Brea makes the following findings in support of Zoning Ordinance Amendment ("ZOA") No. 17-01 and related Municipal Code amendments herein:

(i) The City of Brea, California ("City") is a municipal corporation, duly organized under the constitution and laws of the State of California.

(ii) The City Council has heretofore adopted Interim Ordinance Nos. 1189 and 1190, thereby prohibiting medical and non-medical commercial cannabis activities in all zones of the City, to the maximum extent permitted by law.

(iii) On October 9, 2015, Governor Brown signed Assembly Bill No. 243, Assembly Bill No. 266, and Senate Bill 643 into law, which were collectively known as the Medical Cannabis Regulation and Safety Act (hereinafter "MCRSA"). The MCRSA established State licensing for commercial medical cannabis uses, while protecting local control by requiring that all such businesses have a local license or permit to operate in addition to a State license. The MCRSA allowed the City to completely prohibit commercial medical cannabis activities.

(iv) On November 8, 2016, California voters approved the Control, Regulate and Tax Adult Use of Marijuana Act ("AUMA"). The AUMA added Division 10 to the California Business and Professions Code, sections 26000, *et seq.*, which grants State agencies the authority to create, issue, renew, discipline, suspend, or revoke licenses for cannabis businesses. The AUMA provides that the State shall begin issuing licenses to cannabis businesses under Division 10 of the California Business and Professions Code by January 1, 2018. California Business and Professions Code section 26055(e) provides that a State licensing authority shall not approve an application for a State license for commercial non-medical cannabis activity if approval of the State license will violate the provisions of any local ordinance.

(v) On June 27, 2017, the Governor signed into law Senate Bill 94 which repealed the MCRSA, included certain provisions of the MCRSA in the licensing provisions of the AUMA, and created a single regulatory provision for both medical and non-medical cannabis known as the Medicinal and Adult-Use Cannabis Regulation and Safety Act ("MAUCRSA"). The MAUCRSA retains the provisions of the MCRSA and the AUMA that

granted local jurisdictions control over whether commercial cannabis activity can occur in a particular jurisdiction. Specifically, California Business and Professions Code section 26200 provides that the MAUCRSA shall not be interpreted to supersede or limit the authority of a local jurisdiction to adopt and enforce local ordinances that completely prohibit the establishment or operation of one or more businesses licensed under the State, within that local jurisdiction. Furthermore, the MAUCRSA provides that a State licensing authority shall not approve an application for a State license for a business to engage in commercial cannabis activity if approval of the State license will violate the provisions of any local ordinance or regulation. The MAUCRSA requires that a State licensing authority begin issuing licenses to marijuana businesses beginning January 1, 2018. The MAUCRSA also requires that a city provide a copy of its ordinance regarding commercial cannabis activity to the Bureau of Cannabis Control.

(vi) On October 24, 2017, the Planning Commission of the City of Brea conducted and concluded a properly noticed public hearing regarding ZOA No. 17-01. At the conclusion of the Planning Commission hearing, the Planning Commission adopted Resolution No. PCR 17-12 recommending that the City Council adopt ZOA No. 17-01.

(vii) On November 21, 2017, the City Council of the City of Brea conducted and concluded a properly noticed public hearing regarding ZOA No. 17-01, as well as related Municipal Code amendments.

(viii) All legal prerequisites to the adoption of this Ordinance have occurred.

B. Ordinance.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BREA DOES ORDAIN AS FOLLOWS:

SECTION 1. The facts set forth in the Recitals, Part A, above, are true and correct.

SECTION 2. Environmental Determination. Zoning Ordinance Amendment No. 17-01 is considered a "project" pursuant to the California Environmental Quality Act ("CEQA") and the State CEQA Guidelines (14 CCR § 15000, et seq.). The project is considered exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility that the project to prohibit commercial cannabis activity will have a significant effect on the environment. The project will not result in a permanent alteration of property or the construction of any new or expanded structures. Therefore, the project by itself does not result in any physical changes in the environment. The project is also eligible for a Class 5 categorical exemption for minor changes in land use limitations with an average slope of less than 20% that do not result in any changes in land use or density. Since the project is prohibiting all commercial cannabis uses, it will not result in changes in land use or density and will not have a significant environmental impact. The project is therefore also exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations. Based thereon, the City Council directs that a Notice of Exemption be filed with the County Clerk in accordance with CEQA Guidelines.

SECTION 3. The proposed amendments to the City's Zoning Ordinance set forth herein are consistent with and conform to the General Plan of the City.

SECTION 4. A new Chapter 8.48 is hereby added to Title 8 (Health, Safety, and Welfare) of the Brea Municipal Code to read as follows:

"CHAPTER 8.48 CANNABIS PROHIBITIONS AND REGULATIONS

Sections:

<u>8.48.010</u> :	Definitions.
<u>8.48.020</u> :	Prohibited activities.
<u>8.48.030</u> :	Exceptions.
<u>8.48.040</u> :	Violation and penalty.

§ 8.48.010 DEFINITIONS.

For purposes of this chapter, the following words and phrases shall have the meanings set forth in the MAUCRSA and otherwise as set forth below:

"Cannabis" means all parts of the plant *Cannabis sativa linnaeus*, *Cannabis indica*, or *Cannabis ruderalis*, whether growing or not; the seeds thereof; the resin, whether crude or purified, extracted from any part of the plant; and every compound, manufacture, salt, derivative, mixture, or preparation of the plant, its seeds, or resin. "Cannabis" also means the separated resin, whether crude or purified, obtained from cannabis. "Cannabis" includes cannabis that is used for medical, non-medical, or other purposes. "Cannabis" does not include the mature stalks of the plant, fiber produced from the stalks, oil or cake made from the seeds of the plant, any other compound, manufacture, salt, derivative, mixture, or preparation of the mature stalks (except the resin extracted therefrom), fiber, oil, or cake, or the sterilized seed of the plant which is incapable of germination. "Cannabis" also does not include industrial hemp, as defined in California Health and Safety Code section 11018.5.

"Cannabis product" means cannabis that has undergone a process whereby the plant material has been transformed into a concentrate, including, but not limited to, concentrated cannabis, or an edible or topical product containing cannabis or concentrated cannabis and other ingredients.

"Commercial cannabis activity" means the cultivation, possession, manufacture, distribution, processing, storing, laboratory testing, packaging, labeling, transportation, delivery or sale of cannabis and cannabis product for medical, non-medical, or any other purpose and includes the activities of any business licensed by the State or other government entity under Division 10 of the California Business and Professions Code, or any provision of State law that regulates the licensing of cannabis businesses. Commercial cannabis activity does not include the cultivation, possession, storage, manufacturing, or transportation of cannabis by a qualified patient for his or her personal medical use so long as the qualified patient does not provide, donate, sell or distribute cannabis to any other person. Commercial cannabis activity also does not include the

cultivation, possession, storage, manufacturing, transportation, donation or provision of cannabis by a primary caregiver, exclusively for the personal medical purposes of no more than five specified qualified patients for whom he or she is the primary caregiver, but who does not receive remuneration for these activities except for compensation in full compliance with California Health and Safety Code section 11362.765.

"Concentrated cannabis" means manufactured cannabis that has undergone a process to concentrate one or more active cannabinoids, thereby increasing the product's potency. Resin from granular trichomes from a cannabis plant is a concentrate.

"Cultivation" means any activity involving the planting, growing, harvesting, drying, curing, grading, or trimming of cannabis.

"Delivery" means the commercial transfer of cannabis or cannabis products to a customer. "Delivery" also includes the use by a retailer of any technology platform.

"Distribution" means the procurement, sale, and transport of cannabis and cannabis products between entities licensed under Division 10 of the California Business and Professions Code, as the same may be amended from time to time.

"Manufacture" means to compound, blend, extract, infuse, or otherwise make or prepare a cannabis product.

"MAUCRSA" means the Medicinal and Adult-Use Cannabis Regulation and Safety Act as codified in Division 10 of the Business and Professions Code, and any successor provisions thereto, as the same may be amended from time to time.

"Person" means any natural person, firm, corporation, association, club, society, partnership, joint venture, limited liability company, sole proprietorship, collective, cooperative, coop, non-profit, estate, trust, receiver, syndicate, or any other organization, group or entity or combination of organizations or entities of any kind whatsoever, however formed, as well as trustees, heirs, executors, administrators, and/or assigns, and shall also include any owner, operator, manager, proprietor, employee, agent, officer, volunteer, salesperson, trustees, heirs, executors, administrators and assigns. The term "person" shall also include all persons who have an ownership or leasehold interest in any real property, premises and/or structures in which commercial cannabis activity is occurring.

"Qualified patient" means a person who is entitled to the protections of California Health and Safety Code Section 11362.5, as the same may be amended from time to time.

"Primary caregiver" shall have the same meaning as is defined in California Health and Safety Code section 11362.7(d), as the same may be amended from time to time.

§ 8.48.020 PROHIBITED ACTIVITIES.

A. Commercial cannabis activity, whether or not for profit, is prohibited in the city. No person shall establish, operate, maintain, conduct, allow, or engage in commercial cannabis activity anywhere within the city.

B. A property owner shall not rent, lease or otherwise permit any person or business that engages in commercial cannabis activity to occupy real property in the city. A property owner shall not allow any person or business to establish, operate, maintain, conduct, or engage in commercial cannabis activity on any real property owned or controlled by that property owner that is located in the city.

C. Subsection A above shall prohibit all activities for which a State license is required pursuant to the MAUCRSA, or successor provisions thereto, as the same may be amended from time to time.

D. Subject to the exceptions set forth in Section 8.48.030 below, and to the extent not already prohibited by subsection A above, all deliveries of cannabis or cannabis products, to or from any location in the city are expressly prohibited. No person shall conduct or perform any delivery of any cannabis or cannabis products, which delivery either originates or terminates within the city.

§ 8.48.030 EXCEPTIONS.

A. Nothing in this chapter shall prohibit any person from transporting cannabis through the jurisdictional limits of the city for delivery or distribution to a person located outside the city, where such transport does not involve delivery or distribution within the jurisdictional limits of the city and is otherwise in compliance with State law.

B. Nothing in this chapter shall prohibit a person 21 years of age or older from engaging in any activities authorized under California Health and Safety Code section 11362.1.

C. Nothing in this chapter shall prohibit any commercial cannabis activity that the city is required by State law to permit within its jurisdiction pursuant Business and Professions Code section 26054(c) and (d), as the same may be amended from time to time, or any other provision of the MAUCRSA.

§ 8.48.040 VIOLATION AND PENALTY.

In addition to any other enforcement permitted by this Chapter 8.48 of the Brea Municipal Code, the city attorney or city prosecutor may bring a civil action for injunctive relief and civil penalties against any person or entity that violates this chapter. In any civil action brought pursuant to this chapter, a court of competent jurisdiction may award reasonable attorneys' fees and costs to the prevailing party. Notwithstanding the penalties set forth in Chapter 1.04 of the Brea Municipal Code, no provision of this chapter

authorizes a criminal prosecution, arrest or penalty inconsistent with or prohibited by Health and Safety Code section 11362.71, *et seq.*, or section 11362.1, *et seq.*, as the same may be amended from time to time. In the event of any conflict between the penalties enumerated under Chapter 1.04 of the Brea Municipal Code and any penalties set forth in State law, the maximum penalties allowable under State law shall govern."

SECTION 5. Chapter 20.70 (Commercial Medical Marijuana) of Title 20 (Zoning Code) of the Brea Municipal Code is hereby repealed, provided such repeal shall not excuse or otherwise affect any prosecution occurring prior to the effective date of this Ordinance.

SECTION 6. A new Chapter 20.70 is hereby added to Title 20 (Zoning Code) of the Brea Municipal Code, to read as follows:

"CHAPTER 20.70

COMMERCIAL CANNABIS USES AND CULTIVATION

Sections:

<u>20.70.010</u>	Definitions.
<u>20.70.020</u> :	Prohibited uses.
<u>20.70.030</u> :	Indoor cannabis cultivation.
20.70.040:	Exceptions.
20.70.050:	Violation and penalty.

§ 20.70.010 DEFINITIONS.

For purposes of this chapter, the following words and phrases shall have the meanings set forth in the MAUCRSA and as set forth below:

"Cannabis" means all parts of the plant *Cannabis sativa linnaeus*, *Cannabis indica*, or *Cannabis ruderalis*, whether growing or not; the seeds thereof; the resin, whether crude or purified, extracted from any part of the plant; and every compound, manufacture, salt, derivative, mixture, or preparation of the plant, its seeds, or resin. "Cannabis" also means the separated resin, whether crude or purified, obtained from cannabis. "Cannabis" includes cannabis that is used for medical, non-medical, or other purposes. "Cannabis" does not include the mature stalks of the plant, fiber produced from the stalks, oil or cake made from the seeds of the plant, any other compound, manufacture, salt, derivative, mixture, or preparation of the mature stalks (except the resin extracted therefrom), fiber, oil, or cake, or the sterilized seed of the plant which is incapable of germination. "Cannabis" also does not include industrial hemp, as defined in California Health and Safety Code section 11018.5.

"Cannabis product" means cannabis that has undergone a process whereby the plant material has been transformed into a concentrate, including, but not limited to, concentrated cannabis, or an edible or topical product containing cannabis or concentrated cannabis and other ingredients. "Commercial cannabis activity" means the cultivation, possession, manufacture, distribution, processing, storing, laboratory testing, packaging, labeling, transportation, delivery or sale of cannabis and cannabis product for medical, non-medical, or any other purpose and includes the activities of any business licensed by the State or other government entity under Division 10 of the California Business and Professions Code, or any provision of State law that regulates the licensing of cannabis businesses. Commercial cannabis activity does not include the cultivation, possession, storage, manufacturing, or transportation of cannabis by a qualified patient for his or her personal medical use so long as the qualified patient does not provide, donate, sell or distribute cannabis to any other person. Commercial cannabis activity also does not include the cultivation, possession, storage, manufacturing, transportation, donation or provision of cannabis by a primary caregiver, exclusively for the personal medical purposes of no more than five specified qualified patients for whom he or she is the primary caregiver, but who does not receive remuneration for these activities except for compensation in full compliance with California Health and Safety Code section 11362.765.

"Commercial cannabis use" means the use of any property for commercial cannabis activity.

"Compassionate Use Act" means the Compassionate Use Act of 1996 (Proposition 215), codified as California Health and Safety Code Section 11362.5.

"Concentrated cannabis" means manufactured cannabis that has undergone a process to concentrate one or more active cannabinoids, thereby increasing the product's potency. Resin from granular trichomes from a cannabis plant is a concentrate.

"Cultivation" means any activity involving the planting, growing, harvesting, drying, curing, grading, or trimming of cannabis.

"Delivery" means the commercial transfer of cannabis or cannabis products to a customer. "Delivery" also includes the use by a retailer of any technology platform owned and controlled by the retailer.

"Distribution" means the procurement, sale, and transport of cannabis and cannabis products between entities licensed under Division 10 of the California Business and Professions Code, as the same may be amended from time to time.

"Fully enclosed and secure structure" means a space within a building, greenhouse or other structure which has a complete roof enclosure supported by connecting walls extending from the ground to the roof, which is secure against unauthorized entry, provides complete visual screening, and which is accessible only through one or more lockable doors and inaccessible to minors.

"Indoor" means within a fully enclosed and secure structure.

"Manufacture" means to compound, blend, extract, infuse, or otherwise make or prepare a cannabis product.

"MAUCRSA" means the Medicinal and Adult-Use Cannabis Regulation and Safety Act as codified in Division 10 of the Business and Professions Code, and any successor provisions thereto, as the same may be amended from time to time.

"Medical Marijuana Program" means California Health and Safety Code Sections 11362.7 through 11362.83, as such statutes may be amended from time to time.

"Outdoors" means any location that is not within a fully enclosed and secure structure.

"Person" means any natural person, firm, corporation, association, club, society, partnership, joint venture, limited liability company, sole proprietorship, collective, cooperative, coop, non-profit, estate, trust, receiver, syndicate, or any other organization, group or entity or combination of organizations or entities of any kind whatsoever, however formed, as well as trustees, heirs, executors, administrators, and/or assigns, and shall also include any owner, operator, manager, proprietor, employee, agent, officer, volunteer, salesperson, trustees, heirs, executors, administrators and assigns. The term "person" shall also include all persons who have an ownership or leasehold interest in any real property, premises and/or structures in which commercial cannabis activity is occurring.

"Primary caregiver" means the individual, designated by a qualified patient or by a person with an identification card, who has consistently assumed responsibility for the housing, health, or safety of that patient or person pursuant to the requirements of the Compassionate Use Act and the Medical Marijuana Program.

"Private residence" means a house, an apartment unit, condominium, or other similar dwelling that is lawfully used as a residence.

"Qualified patient" means a person who is entitled to the protections of California Health and Safety Code section 11362.5, as the same may be amended from time to time, but who does not have an identification card.

"Primary caregiver" shall have the same meaning as is defined in California Health and Safety Code section 11362.7(d), as the same may be amended from time to time.

§ 20.70.020 PROHIBITED USES.

A. Commercial cannabis uses are expressly prohibited in all zones and overlay districts in the city. No person shall establish, operate, maintain, conduct or allow commercial cannabis uses anywhere within the city. The city shall not approve any application for a building permit, conditional use permit, variance, or any other entitlement authorizing the establishment, operation, maintenance, development, or construction of any commercial cannabis use.

B. Outdoor cannabis cultivation is expressly prohibited everywhere in the city. No person owning, renting, leasing, occupying or having charge or possession of any parcel shall cause or allow such parcel to be used for cultivating cannabis outdoors.

C. Indoor cannabis cultivation, including cultivation by a qualified patient and primary caregiver, is prohibited except in strict compliance with Section 20.70.030.

§ 20.70.030 INDOOR CANNABIS CULTIVATION.

It is hereby declared to be a public nuisance for any person owning, leasing, occupying, or having charge or possession of any real property in the city to cause or allow such real property to be used for the cultivation of cannabis except in strict compliance with the requirements set forth below. For purposes of this Section 20.70.030, 'private residence' means a house, an apartment unit, a mobile home, or other similar dwelling, or otherwise as defined in Health and Safety Code Section 11362.2(b)(5), or any successor provision thereto.

A. Cannabis cultivation shall only occur indoors at a private residence, or inside an enclosed accessory structure located upon the grounds of a private residence.

B. Only persons twenty-one (21) years of age or older may cultivate cannabis. Any cannabis cultivation must comply with the requirements set forth in California Health and Safety Code sections 11362.1 and 11362.2.

C. Cannabis cultivation is permitted only within fully enclosed and secure structures capable of being locked.

D. Cannabis cultivation is limited to six (6) plants total being planted, harvested cultivated, dried or processed at one time at or upon any private residence, regardless of the number of residents, tenants, guests, or other persons occupying such residence.

§ 20.70.040 EXCEPTIONS.

A. Nothing in this chapter shall prohibit any person from transporting cannabis through the jurisdictional limits of the city for delivery or distribution to a person located outside the city, where such transport does not involve delivery or distribution within the jurisdictional limits of the city.

B. Nothing in this chapter shall prohibit a person 21 years of age or older from engaging in any activities authorized under California Health and Safety Code section 11362.1.

C. Nothing in this chapter shall prohibit any commercial cannabis activity that the city is required by State law to permit within its jurisdiction pursuant to Business and Profession Code section 26054(c) and (d), as the same may be amended from time to time, or any other provision of the MAUCRSA.

§ 20.70.050 VIOLATION AND PENALTY.

In addition to any other enforcement permitted by this Chapter 20.70 of the Brea Municipal Code, the city attorney or city prosecutor may bring a civil action for injunctive relief and civil penalties against any person or entity that violates this chapter. In any civil action brought pursuant to this article, a court of competent jurisdiction may award reasonable attorneys' fees and costs to the prevailing party. Notwithstanding the penalties set forth in Chapter 1.04 of the Brea Municipal Code, no provision of this chapter authorizes a criminal prosecution, arrest or penalty inconsistent with or prohibited by Health and Safety Code section 11362.71, *et seq.*, or section 11362.1, *et seq.*, as the same may be amended from time to time. In the event of any conflict between the penalties enumerated under Chapter 1.04 of the Brea Municipal Code and any penalties set forth in State law, the maximum penalties allowable under State law shall govern."

SECTION 7. As of the effective date of this Ordinance, Interim Ordinance Nos. 1183 and 1197 are hereby repealed.

SECTION 8. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance for any reason is held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrase, or portion thereof be declared invalid or unconstitutional.

SECTION 9. Savings Clause. Neither the adoption of this Ordinance or the repeal of any provision of the Brea Municipal Code shall in any manner affect the prosecution for violations of ordinances or Code provisions, which violations were committed prior to the effective date hereof, nor be construed as a waiver of any penalty or the penal provisions applicable to any violation thereof.

SECTION 10. The City Clerk shall certify to the adoption of this Ordinance.

RECOMMENDATION

Introduce Ordinance No. 1201 for first reading by title only and waive further reading.

BACKGROUND/DISCUSSION

Demonstrations, marches, parades, processions, and rallies are regularly conducted on the City's streets, sidewalks, parks, and other public property each year. Although such activities involve free speech rights, the City has the ability to impose content-neutral time, place, and manner regulations to promote substantial government interests including the following: protecting the safety, comfort, and convenience of persons using streets, sidewalks, parks, and other public property; regulating competing uses of public fora; maintaining public property in an attractive and intact condition; preventing unreasonable interferences with residential properties and lawful businesses; and defraying the cost of certain departmental services provided for the activities.

The attached Ordinance No. 1201 will add a new Chapter 12.28 to the City Code to establish public assembly regulations consistent with federal and state court precedents. The key components of these regulations are as follows:

- An assembly permit requirement for public assemblies that meet certain criteria
- Prohibitions on the carrying or possession of certain items at a public assembly
- Prohibitions on certain conduct at a public assembly
- Restrictions on the use of sound amplification devices at a public assembly
- An indemnity requirement
- A departmental services reimbursement requirement

For purposes of these regulations, the term "public assembly" is defined as a demonstration, march, parade, procession, or rally that assembles or travels in unison on a street, sidewalk, park, public right-of-way, or other public property owned or controlled by the City and that meets any one of three criteria. The first criteria is that the activity does not comply with applicable traffic laws, regulations, or controls. The second is that the activity takes place on public property in Downtown Brea and involves 20 or more participants. The last is that the activity takes place on public property outside of Downtown Brea and involves 75 or more participants. There is a lower threshold for Downtown Brea because, due to the unique and compact nature of that area, public assemblies there can be unreasonably disruptive with fewer participants than

public assemblies elsewhere.

These regulations will exempt certain public assemblies from the permit requirement. For example, no permit will be required to conduct a public assembly at the City Hall plaza in response to news or affairs coming into public knowledge within three days prior to such public assembly. There also are exemptions for public assemblies in facilities rented from the City, for activities conducted pursuant to a film permit issued by the City, and for funeral processions.

The regulations include many measures to promote public safety. These include a prohibition on the carrying or possession, at a public assembly, of certain items that would be particularly dangerous if used as a weapon. There also will be a prohibition on the carrying or possession, at a public assembly, of gas masks and similar devices that could be used thwart riot control efforts by law enforcement officers. Further, the regulations will prohibit permit holders from giving traffic control instructions to non-participants of such assembly.

To prevent unreasonable interference with residential properties and lawful businesses, the regulations will restrict the time and manner in which sound amplification devices may be used at a public assembly. These restrictions will ensure that such devices are not used in the late evening or early morning hours, and that they are not used in a manner that is unduly incompatible with surrounding areas.

Finally, the regulations will require permittees to execute an indemnity agreement and to reimburse the City for any fire safety and traffic control costs associated with their public assembly. The indemnity agreement will protect the City against damages and liabilities that may be caused by the permittee or by the permittee's officers, employees, or agents. A permittee will be exempt from the indemnity agreement requirement if the permittee cooperates with the City to design the public assembly to respond to public health and safety threats identified by the City. The departmental service charges reimbursement requirement will allow the City to recover its fire safety and traffic control costs if it provides these critical services for a public assembly.

FISCAL IMPACT/SUMMARY

The attached Ordinance 1201 contemplates that the City Council will establish, by resolution, an assembly permit fee to cover application processing costs. If the attached Ordinance No.1201 is introduced, then Staff will agendize an assembly permit fee resolution for consideration concurrently with adoption of this Ordinance.

ORDINANCE NO. 1201

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BREA ESTABLISHING PUBLIC ASSEMBLY REGULATIONS AND AMENDING THE BREA CITY CODE

THE CITY COUNCIL OF THE CITY OF BREA DOES ORDAIN AS FOLLOWS:

A. <u>RECITALS:</u>

(i) Demonstrations, marches, parades, processions, and rallies are regularly conducted on the City's streets, sidewalks, parks, and other public property each year.

(ii) The purpose of this Ordinance is to promote the City's interests in protecting the safety, comfort, and convenience of persons using streets, sidewalks, parks, and other public property; regulating competing uses of public fora; maintaining public property in an attractive and intact condition; preventing unreasonable interferences with residential properties and lawful businesses; and defraying the cost of certain departmental services provided for public assemblies.

(iii) Downtown Brea is a unique, compact pedestrian-friendly area devoted to shopping, entertainment, and dining uses. The City Council finds that the permit requirement threshold for public assemblies in Downtown Brea must be lower than the permit requirement threshold for public assemblies in other areas because public assemblies in Downtown Brea can be unreasonably disruptive with fewer participants than public assemblies in other areas.

B. ORDINANCE:

SECTION 1. The facts set forth in the Recitals, Part A of this Ordinance, are true and correct.

SECTION 2. Title 12 (Streets, Sidewalks and Public Property) of Part I (Municipal Code) of the Brea City Code is amended by adding a new Chapter 12.28 to read as follows:

"CHAPTER 12.28: PUBLIC ASSEMBLIES

§ 12.28.010 Short Title.

This chapter shall be known and may be cited as the "Public Assembly Ordinance".

§ 12.28.020 Purpose.

The purpose of this chapter is to promote the City's interests in protecting the safety, comfort, and convenience of persons using streets, sidewalks, parks, and other public property; regulating competing uses of public fora; maintaining public property in an attractive and intact condition; and defraying the cost of certain departmental services provided for public assemblies.

§ 12.28.030 Definitions.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

CITY MANAGER. City Manager or designee thereof.

DEPARTMENTAL SERVICE CHARGE. Actual fire safety and traffic control costs incurred by the City in connection with a public assembly for which an assembly permit is issued.

DOWNTOWN BREA. That portion of the City bounded by Imperial Highway on

the south, by Brea Boulevard on the east (including properties with frontage on the east side of Brea Boulevard), by Ash Street on the north, and by the terminus of Birch Street and the Gateway Shopping Center on the west. A map depicting the boundaries of the Downtown Brea area is available for public inspection in the office of the City Clerk during normal business hours of the City.

INDIGENT NATURAL PERSON. A person who satisfies either of the following criteria:

1. Is receiving benefits pursuant to the Burton-Moscone-Bagley Citizens' Income Security Act for Aged, Blind and Disabled Californians (Welfare and Institutions Code § 12000 et seq.), the California Work Opportunity and Responsibility to Kids Act (Welfare and Institutions Code § 11200 et seq.), the Supplemental Nutritional Assistance Program (7 U.S.C. § 2011 et seq.), or Welfare and Institutions Code § 17000.

2. Whose monthly income is 125% or less of the current monthly poverty line annually established by the Secretary of Health and Human Services.

PUBLIC ASSEMBLY. A demonstration, march, parade, procession, or rally that assembles or travels in unison on a street, sidewalk, park, public right-of-way, or other public property owned or controlled by the City and that meets any of the following criteria:

1. Does not comply with applicable traffic laws, regulations, or controls.

Takes place on public property in Downtown Brea (including any areas over which an easement for public pedestrian use or access exists) and involves 20 or more participants.

3. Takes place on public property outside of Downtown Brea and involves 75 or more participants.

SOUND AMPLIFICATION DEVICE. Any bullhorn, megaphone, speaker, or

similar device used to amplify the volume of a voice or a sound.

§ 12.28.040 Permit Requirement.

No person shall conduct or participate in a public assembly unless an assembly permit has been issued for such activity.

§ 12.28.050 Permit Exemptions.

An assembly permit shall not be required for any of the following:

A. Public assemblies that are conducted at the City Hall plaza and are occasioned by news or affairs coming into public knowledge less than three days prior to such public assembly.

B. Public assemblies in a City facility that has been rented from the City.

C. Activities conducted pursuant to a film permit issued under Chapter 5.224 of this Code.

D. Activities conducted by a governmental agency acting within the scope of its authority.

E. Funeral processions conducted by a mortuary or funeral home.

§ 12.28.060 Permit Processing.

A. Application Deadline. Assembly permit applications shall be filed with the City Manager in accordance with the following time limitations:

1. Not less than six days prior to the date of the public assembly if the activity is proposed to take place in Downtown Brea or in the roadway portion (other than within crosswalks) of the following streets in the City of Brea: Associated Road; Berry Street; Birch Street; Brea Boulevard; Carbon Canyon Road; Central Avenue; Imperial Highway; Kraemer Boulevard; Lambert Road; Puente Street; Randolph Avenue; State College Boulevard; and Valencia Avenue.

2. Not less than four days prior to the date of the public assembly if the activity is proposed to take place in the roadway portion (other than within crosswalks) of any street in a commercial zone within the City of Brea, not referenced in Paragraph A.1.

3. Not less than three days prior to the date of the public assembly if the activity is proposed to take place in a residential zone, or outside of the roadway in a commercial zone, but within the sidewalk or any other portion of the public right of way.

4. Not less than two days prior to the date of the public assembly if the activity is proposed to take place in a park or other area not governed by Paragraphs A.1 through A.3 of this Section.

B. Application Contents. Assembly permit applications shall be filed on a Cityprovided form and shall contain the following information as applicable:

1. Name and contact information for the person who is organizing the public assembly and will be responsible for its conduct.

2. Name and contact information for the organization on whose behalf the public assembly is proposed to be conducted.

3. Date, time, and location of the public assembly including any staging area, disbanding area, and travel route.

4. An estimate of the number of persons who will be participating in the public assembly.

5. An estimate of the length of the public assembly in miles.

6. An estimate of the number persons who will be observing the public assembly.

7. The type of security or other arrangements that will be provided to assure that participants are properly directed.

8. The minimum and maximum speeds that the public assembly is to travel.

9. The maximum number of march, parade, or procession units in the public assembly and the maximum and minimum interval of space to be maintained between the units.

10. The number and type of vehicles in the public assembly.

11. Written permission from the owner of any private property that will be used as a staging area or a disbanding area.

C. Application Fee. Any person seeking an assembly permit shall pay a nonrefundable application fee concurrently with the filing of the application. The assembly permit application fee amount shall be as set by City Council resolution.

D. Indigency Waivers. An indigent natural person shall be exempt from payment of the assembly permit application fee upon obtaining an indigency waiver. An organization in which a majority of its members are indigent natural persons also shall be exempt from payment of the assembly permit application fee upon obtaining an indigency waiver. A request for an indigency waiver shall be made at the time of permit application and shall be accompanied by such relevant information and documentation as may be necessary for verification of eligibility. The City Manager shall grant an indigency waiver upon verification of eligibility.

E. Permit Approval or Denial. The City Manager shall approve an assembly permit application unless one or more of the denial findings specified in Paragraph F below is made in a written notice to the applicant. The City Manager shall consider each application upon its merits, shall not discriminate in granting or denying applications, and shall not deny a permit based upon a subject matter or viewpoint involved in a proposed

public assembly.

F. Denial Findings. An assembly permit application shall only be denied on the basis of one or more of the following criteria:

1. The application is incomplete.

2. The application contains false or intentionally misleading information.

3. The applicant, or the organization on whose behalf the public assembly is proposed to be conducted, has an unpaid departmental service charge debt to the City for a prior public assembly.

4. The public assembly is proposed for a time and location for which another activity has been previously authorized.

5. The public assembly will require the simultaneous closure of the roadway portion of more than two streets that run in a parallel direction between the hours of seven a.m. and eight p.m. Monday through Friday, or between the hours of ten a.m. and six p.m. on Saturday, unless the activity will occur on a national holiday.

6. The public assembly will require closure of the roadway portion of any street in a commercial zone for more than three hours in any one day between the hours of seven a.m. and eight p.m. Monday through Friday, unless the activity will occur on a national holiday.

7. The route or location of the public assembly traverses a street or other public right of way that was scheduled for maintenance, construction or repair prior to the submission of the permit application and the conduct of the public assembly would interfere with such maintenance, construction or repair or would create a threat to the health or safety of the public assembly's participants.

8. The staging area or disbanding area cannot physically accommodate the number of participants expected by the applicant.

9. The public assembly would result in a violation of any federal, state or local law.

G. Permit Conditions. The City Manager may condition an approved permit with reasonable requirements concerning the time, place, or manner of holding the public assembly as is necessary to coordinate multiple uses of public property, to assure preservation of public property, to prevent dangerous, unlawful, or impermissible uses, to protect the safety of persons and property, and to control vehicular and pedestrian traffic in and around the venue.

§ 12.28.070 Prohibited Items.

A. Prohibitions. No person shall carry or possess any of the following items while present at a public assembly:

1. Lumber, wood, or wood lath greater than one foot in length.

2. Plastic pipe or metal greater than one foot in length or greater than one-quarter inch in its thickest dimension.

3. A sign, poster, plaque, or notice that is not constructed solely of a cloth, paper, or cardboard material less than one-quarter inch in thickness.

4. A projectile launcher or similar device used to hurl an object, liquid, or other substance.

5. A gas mask or similar device used to filter air breathed and that would protect the respiratory tract and face against irritating, noxious, or poisonous gases.

B. Exceptions. Paragraph A does not apply to the following:

1. Any person carrying or possessing a piece of wood that satisfies all of the following criteria:

- a. Is blunted at its ends.
- b. Is two inches or less in width.

c. Is one-fourth inch or less in thickness or, if not generally rectangular in shape, is three-fourths inch or less in its thickest dimension.

2. Any disabled person carrying or possessing a cane, walker, or similar item necessary for such person's mobility.

§ 12.28.080 Prohibited Conduct.

No person shall engage in any of the following conduct while present at a public assembly:

A. Violate any permit condition contained in the assembly permit issued for the public assembly.

B. Fail to abide by instructions given by a traffic control officer or law enforcement officer for the purpose of accommodating emergency vehicles or traffic through a public assembly route.

C. Give traffic control instructions to non-participants of the public assembly.

D. Ignite or burn any open flame device (including a candle, portable or stationary torch, road flare or fuse, fuel fired lantern, signal flare or sky lantern), bonfire, recreational fire, cooking fire, warming fire, sign, or effigy.

§ 12.28.090 Sound Amplification.

A. Time Restriction. No person at a public assembly shall utilize a sound amplification device between the hours of 10:00 p.m. and 9:00 a.m.

B. Manner Restrictions. No person at a public assembly shall utilize a sound

amplification device that does any of the following:

1. Produces loud or raucous noises which interferes with the conduct of any business in the vicinity of the assembly.

2. Disturbs the peace, quiet and comfort of persons in the vicinity of the assembly.

3. Is audible at a distance of 250 feet from the point from which the broadcast emanates.

§ 12.28.100 Indemnity.

A. Requirement. An assembly permit shall not be effective until the permittee has submitted to the City Manager an executed indemnification agreement approved as to form by the City Attorney.

B. Scope. The indemnification agreement shall require the permittee to defend, indemnify, and hold the City and the City's officers' employees, agents harmless from and against claims, damages expenses, loss or liability arising out of or resulting from the alleged acts or omissions of the permittee or the permittee's officers, employees, or agents in connection with the permittee's public assembly. The indemnification agreement shall not make the permittee responsible for losses to the City arising from audience reaction to the permittee's public assembly; shall not make the permittee responsible for activities at the permittee's public assembly that are outside of the permittee's control; and shall not require the permittee to waive any cause of action the permittee might otherwise have against the City.

C. Exception. An indemnification agreement shall not be required if the permittee cooperates with the City Manager to design the public assembly to respond to specific risks, hazards, and dangers to the public health and safety identified by the City

Manager as being reasonably foreseeable consequences of the public assembly.

§ 12.28.110 Departmental Service Charges.

A. Reimbursement Requirement. A permittee shall reimburse the City for departmental service charges incurred in connection with or due to the permittee's public assembly. No permittee is required to pay for the cost of law enforcement personnel to provide for the protection of a public assembly and its attendees from hostile members of the public or from counter-demonstrators, or to pay for the cost of general law enforcement in the vicinity of the event.

B. Invoice. No later than 30 business days after the expiration of an assembly permit, the City Manager shall issue the permittee an itemized invoice of departmental service charges incurred in connection with or due to the permittee's public assembly.

C. Payment Deadline. No later than 30 business days after issuance of the invoice, a permittee shall remit to the City Manager payment for the departmental service charges specified in such invoice.

D. Exception. This Section shall not apply to any person who has been exempted from payment of the assembly permit application fee by receipt of an indigency waiver.

§ 12.28.120 Violations.

Any person who intentionally violates any provision of this Chapter shall be guilty of a misdemeanor."

SECTION 3. The City Council finds that it can be seen with certainty that there is no possibility the adoption of this Ordinance may have a significant effect on the environment because it establishes content-neutral time, place, and manner regulations for public assemblies on City property. It is therefore exempt from California Environmental Quality

Act review pursuant to Title 14, Section 15061(b)(3) of the California Code of Regulations.

SECTION 4. The City Council declares that, should any provision, section, paragraph, sentence, or word of this Ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences, and words of this Ordinance shall remain in full force and effect.

<u>SECTION 5.</u> The City Clerk shall certify to the adoption of this Ordinance.



CALL TO ORDER/ ROLL CALL - COUNCIL

Mayor Hupp called the meeting to order at 6:02 p.m., all Council Members were present.

Present: Hupp, Parker, Marick, Simonoff, Vargas

1. Matters from the audience

Jay Padilla, Embassy Suites General Manager, expressed concern about the proposed Transient Occupancy Tax (TOT) increase, provided TOT statistics for other Orange County cities, and believed that the number of 911 police calls for issues at hotels in the City of Brea is minor.

John Koos, expressed concern about a possible increase to the business license tax, noted that he understands the proposed increase to the building permit fee, and stated that further discussion is needed.

DISCUSSION ITEM

2. Budget Update and Discuss Business License fees, Transient Occupancy Taxes (TOT), City Service Levels and Other Matters

City Manager Gallardo reported that the focus of the presentation will be on fiscal responsibility and stated that if we use time and creative energy to tackle budget concerns, we can succeed.

Administrative Services Director Russell presented a PowerPoint that included: what in the City of Brea has changed; the budget efforts to maintain service levels; balancing the current year budget; five (5) year General Fund projections; closing the 2018-19 budget gap; revenue enhancements; ballot measure considerations; ballot measure steps; direction needs; and the budget timeline.

In response to Council questions, staff explained that the expenditure savings in staffing reductions is for the past 2 years; verified that the amount given does not include the FARP Study Replacement Reserves; noted that only some of the retirement rates were calculated into the upcoming budget; stated that staff is analyzing the services to decide if layoffs are necessary; added that the FARP Study will be presented to Council in January or February 2018; indicated that they will provide information regarding recreation/gym fees for nonresidents to Council at a later date; discussed possible digital billboard revenue; noted that communication with vendors for cell towers is ongoing; provided the

amount of revenue versus expenditure for the paramedic program; offered to do more research to find out if the landfill will be closing; briefly discussed CBED funds; and clarified that staff will discuss JPA services again with other cities starting in January.

Council stated that they will need more information before making a decision on how to close the budget gap and noted that all options will be considered.

Council Member Vargas stated that he is willing to lower the mandated reserves to assist with the budget gap; suggested that the utilities in the City be municipalized; proposed that there be a \$300,000 cap on compensation for employees; and directed staff to focus on workers compensation and pension reform. City Manager Gallardo stated that he along with Mayor Hupp, Mayor Pro Tem Parker, and Acting Human Resources Manager/Assistant to the City Manager Maldonado are going to Sacramento in December to discuss pension reform legislation.

Council Member Marick asked that staff keep Council updated on what other cities are doing in respect to concession bargaining.

In response to Council questions, Police Chief Conklin stated that there were 425 police calls for incidents at hotels in the City of Brea in the last three (3) years and noted that most calls for hotel incidents require two (2) Police Officers to respond. In response to a question, he added that he is not aware of a voucher program to pay for hotel rooms in the City for probationers.

Mayor Pro Tem Parker expressed concern that raising the TOT and business license tax may cause diminished returns. He directed staff to provide more information, to look at the impact, and to expand outreach in the community for feedback on how they feel about the new proposed taxes.

Mayor Hupp and Council Member Simonoff asked staff for more information from other cities that have raised taxes to find out the impact to their City and noted that they are not willing to take anything off the table.

Council Member Marick stated that staff should make sure there is a 4/5 vote of Council in favor of raising taxes before spending City funds to research any tax measure.

Mayor Hupp called a recess at 7:46 p.m.

Council reconvened at 7:53 p.m.

Mayor Hupp opened the floor for more public comments.

Jason Kraft stated that smaller cuts in the budget now, will help further down the road.

Dwight Manley stated that the public does not have enough information, believed that permanent decisions should not be made at this time, and expressed concern about mismanagement of funds in the past.

Sean Thomas believed that Council should look at who is impacted when raising taxes.

Keith Fullington asked Council and staff to be creative when raising taxes by soliciting ideas and suggestions from businesses and residents in the City.

John Bickel suggested that Council and staff look at all options and he briefly discussed grants.

Steve Shatynski believed that more information should be provided to the public, discussed pension reform, and suggested a citizen committee that will focus on the budget.

Administrative Services Director Russell recapped that Council would like more information regarding a ballot measure and staff should bring options for labor/service impacts.

ADJOURNMENT

Mayor Hupp adjourned the meeting at 8:01 p.m.

Mayor Hupp called the Study Session to order at 6:00 p.m., all members were present except for Council Member Marick.

1. Public Comment - None

2. Clarify Regular Meeting Topics

Regarding Item 16 (November 7, 2017 City Council Regular Meeting Minutes) - Mayor Hupp asked the City Clerk to make the following amendments: Item 19 (Legislative Briefing) - add that the real estate transaction fee is \$75 but could be as much as \$225. Regarding Item 20 (Review of Process for Selection and Removal of Council Appointed Commissioners) - add that Council Member Vargas seconded her motion but later withdrew it.

Regarding Item 16 (November 7, 2017 City Council Regular Meeting Minutes) - Council Member Vargas asked the City Clerk to make the following amendments: Item 20 (Review of Process for Selection and Removal of Council Appointed Commissioners) - add wording that he was disappointed that the item was added as an Administrative Item and expressed that it was a political play.

Council Member Vargas stated that the water rate discussion should be heard at the General Session instead of Study Session and expressed concern about transparency.

DISCUSSION ITEMS

3. Brea Water Rate Update

Administrative Services Director Russell provided the background, discussed the goals, provided the three (3) rate scenarios, discussed the drought rates, noted that the State reduced the water conservation regulation from stage 2 to stage 1, reported that the water usage did not go up, and recommended that the City forego increases.

In response to City Attorney Markman's question, Administrative Services Director Russell stated that the projected 6% water usage is based on both new connections and new demand and noted that all approved new development that has not been built, has not been factored in yet.

In response to Council Member Vargas' questions, staff clarified that the loan for the purchase of water rights will be paid in June 2019 and stated if the water demand and rates stay the same, there is no need to adjust water rates for the next 18 months.

4. Street Sweeping Contract Options

Public Works Director Olmos presented a PowerPoint that included the background, proposed scenarios, analysis, other options, and bids received.

In response to Council questions, Public Works Director Olmos projected how the General Fund would be affected for the different options; stated that staff will continue to review options and benefits; noted that the process can take 6 months minimum; indicated that the City's current back up sweeper is due to be replaced; suggested that a short term contract with NES be established; provided a cost breakdown for street sweepers; mentioned that if there is a joint contract with other Cities, staff will request separate schedules because each City has different needs; clarified that trash hauling and street sweeping are performed on separate days; provided the next steps; and stated that a letter was received from Brea City Employees Association (BCEA) regarding street sweeping.

REPORT

5. Council Member Report

Council Member Simonoff reported that he attended the National League of Cities Conference (NLC) where they discussed revenue loss and fees to offset revenue loss.

Mayor Hupp reported that she also attended the NLC and attended sessions that discussed homelessness and affordable housing. She expressed concern about raising fees for affordable housing resulting in more expensive housing.

Mayor Hupp adjourned the Study Session meeting at 6:43 p.m.

SUBJECT: Resolution for the Submittal of a Grant Application for the Construction of the SR-57 and Lambert Road Interchange Improvements, Phase 1, Project 7251, to the Orange County Transportation Authority for Funding Under the Comprehensive Transportation Funding Program.

RECOMMENDATION

Adopt Resolution Approving Application Submittal

BACKGROUND/DISCUSSION

The SR-57 and Lambert Road Interchange Improvement, Project 7251 ("Project") has been programmed within the Capital Improvement Program ("CIP") for over ten years. The Project Approval and Environmental Document ("PA&ED") Phase was completed in the Fall of 2015 with a preferred design alternative selected as Alternative 7A. The 7A Project will add a northbound loop on-ramp and realign northbound off-ramp; widen southbound ramps and bridge by the railroad; convert southbound exit ramp to a two (2) lane exit and widen Lambert Road from west State College.

The Project is currently in the design and right-of-way acquisition phases. The scope of work within the Design Professional Services Agreement with Parsons required completion of Plans, Specifications, and Estimates ("PS&E") for the overall Project. Parsons completed the 65% PS&E documents for the overall Project in December 2016. However, due to cost increases in construction from the PA&ED planning estimate and funding constraints for the overall project construction costs, a phasing plan concept was proposed to Caltrans in the Spring of 2016. Caltrans and Orange County Transportation Authority ("OCTA") staff accepted this phased approach in an effort to keep the Project moving forward. The proposed phasing allows the City and Caltrans to effectively secure grant funds for each phase and deliver much needed operational improvements to the interchange while waiting to secure 100% construction funds for the overall Project.

The phasing plan proposes four (4) phases for this Project. The first phase ("Phase 1") will improve the east side of the SR-57 Freeway Interchange by constructing the northbound loop on-ramp, realign the northbound off-ramp, and improve the existing northbound on-ramp. The succeeding phases 2-4 will be reprogrammed within the CIP pursuant to available grant funds from the State Transportation Improvement Program ("STIP") and OCTA in Fiscal Years 2018-19 thru 2022-23 respectively. The PS&E for Phases 2-4 will be completed from the current 65% level to 100% upon securing the necessary additional grant funds for these subsequent phases.

Currently, the PS&E for the Phase 1 Project is nearing 100% completion, pursuant to the decision to phase the Project. The design for the remaining phases has been shelved at the 65% level until additional grant funds are secured, which is anticipated to be by Fiscal Years 2018-19 and 2019-20. In 2016, the City secured funding from OCTA in the amount of \$5.9 million with reprogrammed grant funds from the STIP for Right-of-Way ("ROW") acquisition in the amount of \$9 million for a total of \$14.9 million. The ROW phase is completely funded and started with the anticipation of being complete by the third quarter of 2018. Since 2016, staff has been working on securing the necessary funds to complete the construction of the Phase 1 Project.

In October 2016, staff submitted a grant application for Construction funding for the Phase 1 Project to OCTA. The funding request was in the amount of \$12.4 million. However, due to limited funding in the program with many competing projects from other cities, OCTA was only going to fund approximately \$4 million of the \$12.4 million request, which would not have fully funded the Phase 1 construction. Therefore, staff decided to wait for the 2018 grant cycle to re-apply for the full funding amount for Phase 1 construction.

In August 2017, OCTA issued the 2018 Comprehensive Transportation Funding Program ("CTFP") Call for Projects for Measure M2 funding under the Regional Capacity Program ("RCP") and Project P Regional Traffic Signal Synchronization Program ("RTSSP"). These competitive Call for Projects are designed to supplement funding for streets and roads projects within Orange County.

On October 20, 2017, staff submitted an application for Construction funding for the Phase 1 Project to OCTA. The funding request is in the amount of \$12.8 million through the Freeway Arterial/Street Transition (FAST) program under the RCP. A draft Resolution was included as part of the OCTA application. However, in order for OCTA to consider the City's application complete, the attached final Resolution must be approved by the City Council. If successful, the construction funding would be programmed starting in FY 2018-19 at the earliest, or in FY 2019-20 pursuant to securing the ROW for the Phase 1 Project.

Additionally, staff has been working with OCTA and Caltrans to secure funding from the United States Department of Transportation's Infrastructure for Rebuilding America ("INFRA") competitive grant program, the United States Department of Transportation's Investment Generating Economic Recovery 2017 ("TIGER 2017") competitive grant program, and Caltrans State Highway Operations and Protection Program ("SHOPP") for the entire Project. If successful, the complete Project construction for all phases would be fully funded in FY 2018-19.

COMMISSION/COMMITTEE RECOMMENDATION

The Finance Committee reviewed staff's recommendation at their November 28, 2017 meeting and it was recommended for City Council approval.

FISCAL IMPACT/SUMMARY

The amount budgeted for the overall Construction of the Project, including contingency, construction management, and inspection costs (soft costs), in the adopted FY 2017-18 Seven-Year CIP is approximately \$52.9 million. This number was based on the 65% PS&E cost estimate. The current 2017 cost estimate for the overall Project construction in FY 2018-19 is approximately \$71.5 million. The main cost increases from the 65% PS&E were due to added costs associated with extending the existing bridge over Lambert Road; lowering Lambert Road; the south off-ramp retaining wall, including the Phase 4 truck climbing lane interchange

improvements; added sound walls at El Torrito and along the south On and north Off ramps; and other roadway work not included in the 2016 65% PS&E estimate that are required by Caltrans. Therefore, the updated cost increases in the overall Project construction coupled with the current funding constraints in the State and OCTA, necessitated the collective Caltrans, OCTA, and City staff to propose phasing the Project and looking to other grant and Caltrans funding opportunities with INFRA, TIGER 2017, and SHOPP.

The current Phase 1 construction cost is estimated at approximately \$21.5 million inclusive of contingency and soft costs, which has been increased from the 2017 CIP budget of \$19.8 as shown in FY 2018/2019. This represents an 8% increase due to construction cost escalations and other improvements not identified in the 65% PS&E Phase 1 estimate. The estimated construction costs for the remaining phases 2, 3, and 4 is approximately \$53 million. The summary for Phase 1 Construction funding is as follows, which is also included in the OCTA Grant application:

In October 2017, staff applied for Construction (Phase 1) funds for the Project as part of the OCTA's CTFP grant program. Given the limited availability of grant funding, staff requested \$12.8 million in construction funds with \$8.7 million matching funds coming from Traffic Impact Fees (Fund 540). If successful, the funds would be programmed and available as early as FY 2018-19. Staff will update the CIP Project Budget as part of the 2018 Annual CIP Update to reflect the approved OCTA grant funds, other grant funds secured, and increased Traffic Impact Fees (Fund 540) match. There will be no General Funds used for this Project and as such, there will be no General Fund Impact. Therefore, in order for OCTA to deem the City's application complete and potentially receive the grant funds, staff recommends the City Council adopt the attached Resolution.

RECOMMENDATION

Approve Amendment No. 3 to Professional Services Agreement with AKAL Consultants for Additional Project Management Services for the SR-57 & Lambert Road Interchange Improvements, Project 7251.

BACKGROUND/DISCUSSION

The SR-57 Freeway/Lambert Road Interchange Improvement, Project 7251 (Project) has been programmed within the Capital Improvement Program for over ten years. The Project Approval and Environmental Document (PA&ED) phase was completed in the Fall of 2015 with a preferred design alternative selected as Alternative 7A. The 7A project will add a northbound loop on-ramp and realign northbound off-ramp; widen southbound ramps and bridge by the railroad; convert southbound exit ramp to a two (2) lane exit; and widen Lambert Road from west State College.

Due to the complexity of the Project and Caltrans' involvement, staff identified the need to augment our in-house capability to manage the Project. On August 17, 2010, City Council approved a Professional Services Agreement (PSA) with AKAL Consultants (AKAL) in the amount of \$95,100 to provide project management services for the Project. A first Amendment in the amount of \$87,900 was approved by Council in October 2014. Due to delays in approval of the PAED resulting from additional technical studies required by Caltrans and the need to secure construction funding for this project, a second amendment in the amount of \$27,000 was approved by City Council on December 6, 2016 bringing the total contract to \$210,000.

The Project is currently in the design and right-of-way acquisition phases. The scope of work within the Design Professional Services Agreement with Parsons required completion of Plans, Specifications, and Estimates (PS&E) for the overall Project. Parsons completed the 65% PS&E documents for the overall Project in December 2016. However, due to cost increases in construction from the PA&ED planning estimate and funding constraints for the overall project construction costs, a phasing plan concept was proposed to Caltrans in the spring of 2016. Caltrans and Orange County Transportation Authority (OCTA) staff accepted this phased approach in an effort to keep the Project moving forward. The proposed phasing allows the City and Caltrans to effectively secure grant funds for each phase and deliver much needed operational improvements to the interchange while waiting to secure 100% construction funds for the overall Project.

Currently, the PS&E for the Phase 1 Project is nearing 100% completion, pursuant to the decision to phase the Project. The design for the remaining phases has been shelved at the 65% level until additional grant funds are secured, which is anticipated to be by Fiscal Years 2018-19 and 2019-20. In 2016, the City, with assistance from AKAL, secured funding from OCTA in the amount of 5.9 million with reprogrammed grant funds from the STIP for Right-of-Way (ROW) acquisition in the amount of \$9 million for a total of \$14.9 million. The ROW phase is completely funded and has started with the anticipation of being complete by the third quarter of 2018. Since 2016, staff with assistance from AKAL, has been working on securing the necessary funds to complete the construction of the Phase 1 Project.

Additionally, staff and AKAL have been working with OCTA and Caltrans to secure funding from the United States Department of Transportation's Infrastructure for Rebuilding America ("INFRA") competitive grant program, the United States Department of Transportation's Investment Generating Economics Recovery 2017 ("TIGER 2017") competitive grant program, and Caltrans State Highway Operations and Protection Program ("SHOPP") for the entire project. If successful, the complete Project construction for all phases would be fully funded in FY 2018-19.

Therefore, in order for AKAL to continue to assist the City with the OCTA grant applications for construction funds as part of the Fiscal Year 2017-18 and 2018-19 Call For Projects grant cycle a third amendment of the PSA with AKAL is required. AKAL has been instrumental in assisting the City in securing grant funding from OCTA for PAED/PS&E and Right-of-Way in the amount of \$927,000 and approximately \$5.9 million respectively as well as assisting staff with other grant applications.

These above mentioned efforts will require additional management services and comprehensive coordination with OCTA and Caltrans by AKAL. Some of the continuing services to be provided by AKAL as a part of this third amendment are as follows:

- Provide assistance with M2 grant application (Construction phase 1);
- Review design consultant invoices and provide as-needed PM work;
- Perform design (PS&E) consultant performance evaluation for compliance with federal guidelines;
- Provide project review and attend PDT meetings;
- Provide assistance with OCTA semi-annual review; and
- Assist City staff with project audit reviews, grant reimbursement requests and miscellaneous project activities as directed by City Engineer

COMMISSION/COMMITTEE RECOMMENDATION

The Finance Committee reviewed staff's recommendation at their November 28, 2017 meeting and it was recommended for City Council approval.

The requested \$33,600 amendment to the existing PSA for project management and miscellaneous services would bring the current \$210,000 PSA to \$243,600. The table above depicts the current Fiscal Year (FY) 2017-18 Approved Budget for this project within the CIP inclusive of staff time, design consultant, and project management consultant.

Based on the remaining FY 2017-18 balance of \$14,639,373 there are sufficient funds to cover the additional \$33,600 amendment to AKAL's PSA. The Project's overall source of funds for Design and Right-Of-Way are from Fund 540 (Traffic Impact Funds), Federal and OCTA grants. Therefore, there is no fiscal impact to the General Fund. Approving a third amendment with AKAL will continue the project management services during the PS&E and ROW Phases and assist the City with securing construction grant funds for the Project. With AKAL Consultant's broad knowledge of Federal and OCTA's guidelines, it would ensure compliance with this very complex Project.

RECOMMENDATION

Award professional services agreement to Trinity Sound Company to provide Curtis Theatre Building Monitor and PA System Upgrade in the amount of \$49,727.53.

BACKGROUND/DISCUSSION

In May 2017, City Council approved a decision package to move forward with replacing original and outdated building monitor and PA equipment to help increase efficiencies within the facility, as well as provide for a method to quickly respond in the case of emergencies which is currently lacking. Staff has received quotes from two contractors for this project and is now seeking the support of City Council to award the contract to Trinity Sound Company.

Drawing more than 50,000 visitors annually, the Curtis Theatre is responsible for a number of programs contributing to the City's prestigious reputation for Cultural Arts. The Theatre presents and produces an annual season of live performances, cultivating collaborative partnerships with local theatrical production companies, and negotiating to bring notable guest performers to the 199-seat venue. While these performances have a regional draw, they also offer Brea residents - be it a parents night out, seniors on a fixed income, or young people - a cultural arts experience. Additionally, Theatre staff oversees a large-scale youth theatre program serving an average of 475 children playing to sold-out houses, while also providing volunteer opportunities for their parents. The Theatre also derives revenue from its Facility Rental Program, offering performance and meeting space for area schools, performing arts companies, businesses and faith-based organizations. Outside the facility, Theatre staff administers the annual Concerts in the Park Program and contributes to a number of City events.

The building monitor and PA system is used to get the sound of whatever is on stage to Dressing Rooms A and B, the Green Room and Theatre office. In 2014, one of the amplifiers providing a stage feed to the dressing room malfunctioned, which can happen if used for an extended period of time. As a result, it is unavailable for rentals and programs like Brea's Youth Theatre. Currently, there is no comprehensive means of communication to all backstage areas - even in the event of an emergency. Furthermore, rental clients expect that there is an efficient call system to communicate among the various parts of the Theatre, something that is a standard feature in many civic-run or school performing spaces. The cost of a building monitor and PA system includes the following features: paging, recorded music/announcement playback capabilities, stage monitoring and chiming. These features are interchangeable and customizable to 12 zones within the facility: Dressing rooms A/B/C, Scene Shop, backstage restrooms, Green Room, office, lobby, lobby restrooms, lobby exterior, spot booth, tech booth, and Backstage SM Station.

Several vendors were contacted to provide a quote for this project; however, staff only received reasonable responses from the following vendors:

The vendor's proposals we received were substantially different in cost. However, after reviewing, staff determined the cost difference to be based on the company's structure and capabilities.

In addition to being the lowest bidder, Trinity Sound Company has also had previous experience working with the City of Brea on live events (Brea Fest, Concerts in the Park and Centennial Parade), installing audio equipment at both the Brea Senior Center and the Brea Community Center, and maintaining a positive professional relationship with the Curtis Theatre while providing support on various performances, meetings community programs and rentals.

PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF BREA AND TRINITY SOUND COMPANY

This Aareement ("Agreement" "Contract") is made or and entered into this 21st day of 2017 Sept, ("Effective Date"), between the City of Brea, a municipal corporation (hereinafter referred to as "CITY") and Trinity Sound Company (hereinafter referred to as "CONTRACTOR").

I. Recitals

- A. CITY has solicited a request for proposal to upgrade the Curtis Theatre sound and monitoring equipment described in Exhibit A Scope of Services ("Services") from CONTRACTOR;
- B. CONTRACTOR has submitted a proposal in response thereto and represents CONTRACTOR is qualified and willing to perform such services;
- C: CITY has reviewed and evaluated the CONTRACTOR's proposal, representations, qualifications, pricing, and promises to perform;
- D. CITY desires to retain CONTRACTOR to provide the Exhibit A Services per Exhibit B Term and Compensation ("the Term" and "the Price").

II. Agreement

NOW, THEREFORE, it is agreed by and between CITY and CONTRACTOR as follows:

- A. CONTRACTOR agrees to provide the Services for the Term and the Price.
- B. CONTRACTOR agrees as follows:
 - 1. Upon receiving a written notice to proceed from CITY, CONTRACTOR shall commence performance in accordance with the required Services, all Federal, State, and CITY statutes, regulations, ordinances, and all applicable industry standards and guidelines, all to the reasonable satisfaction of CITY.

- 2. CONTRACTOR shall supply copies of all required reports, writings, photographs and/or documents (hereinafter collectively referred to as "documents") including any supplemental documents to CITY, necessary for CONTRACTOR to perform the Services, or as otherwise specifically required hereunder. CONTRACTOR shall furnish copies of said documents in such quantities as required by CITY. Thereafter, CITY may review and forward comments regarding said documents to CONTRACTOR for revisions. Thereafter, CONTRACTOR shall make such revisions to said documents and provide revised documents to CITY in such form and quantities determined necessary by CITY.
- 3. CONTRACTOR shall, at CONTRACTOR's sole cost and expense, secure and hire such other persons as may, in the opinion of CONTRACTOR, be necessary to comply with the terms of this Agreement. In the event any such other persons are retained by CONTRACTOR, CONTRACTOR hereby warrants that such persons shall be fully qualified to perform services required hereunder. CONTRACTOR further agrees that no subcontractor shall be retained by CONTRACTOR except upon the prior written approval of CITY.
- 4. CONTRACTOR, while fulfilling the terms of this Agreement shall provide exceptional customer care. Any negative contact with staff, residents/citizens, businesses, visitors or other contractors shall be reported by CONTRACTOR immediately to CITY. CONTRACTOR's management and supervisory personnel shall intercede to resolve or mitigate the negative contact in conjunction with CITY staff. CITY and CONTRACTOR may agree in advance to a single person contact, a representative of either CITY or CONTRACTOR, for the investigation and response to complaints.

- C. CITY agrees to pay CONTRACTOR:
 - For required Services performed by CONTRACTOR at Exhibit B Compensation prices. Payment shall cover cost of all staff time and all other direct and indirect costs and fees, including work of employees, CONTRACTOR and subcontractors to CONTRACTOR.
 - Within a reasonable time after receipt of monthly invoices submitted by CONTRACTOR for charges in accordance with Exhibit B Compensation prices.
- D. CITY agrees to provide to CONTRACTOR:
 - 1. Information and assistance needed to enable CONTRACTOR to perform Services. Any and all such information and data so provided shall be forever maintained as confidential by CONTRACTOR to the maximum extent permitted by law.
 - 2. Assistance, if necessary, in obtaining information from other governmental agencies and/or private parties. CONTRACTOR shall make all initial contact with respect to gathering of such information.
- E. Ownership of Documents:
 - 1. All documents prepared by CONTRACTOR pursuant to this Agreement shall be considered works made for hire and, together with all intellectual property rights arising therefrom, shall be deemed to be the property of CITY. CONTRACTOR hereby assigns to CITY any and all intellectual property rights to such documents not otherwise conveyed by this subsection.
 - CONTRACTOR shall not make and retain for its own use, copies of any documents prepared pursuant to this Agreement, without CITY's prior written consent.

- F. Termination:
 - 1. CITY may terminate this Agreement upon giving a written "Notice of Termination" to CONTRACTOR at least thirty (30) days prior to the date of termination specified in said notice. In the event this Agreement is so terminated, CONTRACTOR shall be compensated on a pro-rata basis with respect to the percentage of the Services completed and the corresponding Price as of the date of termination.
 - 2. CONTRACTOR shall provide to CITY any and all documents and reports, whether in draft or final form, prepared by CONTRACTOR as of the date of termination.
 - CONTRACTOR may not terminate this Agreement except for cause.
 - 4. Termination or expiration of this Agreement does not release CONTRACTOR from any and all claims, damages or other liability incurred prior to termination or expiration.
- G. Indemnity:
 - 1. CONTRACTOR and CITY agree that CITY, its elected officials, officers, employees, agents and volunteers should, to the extent permitted by law, be fully protected from any loss, injury, damage, claim, lawsuit, cost, expense, attorneys fees, litigation costs, defense costs, court costs or any other cost arising out of, pertaining to or relating to the negligence, recklessness or willful misconduct in performance of this Agreement. Accordingly, the provisions of this indemnity provision are intended by the parties to be interpreted and construed to provide the fullest protection possible under the law to CITY.
 - 2. To the fullest extent permitted by law, CONTRACTOR shall defend, indemnify and hold CITY, its elected officials, officers, employees,

agents and volunteers free and harmless from any and all liability, claims, suits, actions, arbitration proceedings, administrative proceedings, regulatory proceedings, losses, expenses or costs of any kind, whether actual, alleged, or threatened, actual attorneys fees and experts costs incurred by CITY, court costs, interest, defense costs including expert witness fees and any other costs or expenses of any kind whatsoever without restriction or limitation incurred in, arising out of, pertaining to or relating to the negligence, recklessness or willful misconduct in CONTRACTOR's performance of this Agreement. All obligations under this provision are to be paid by CONTRACTOR as they are incurred by CITY.

- Any tort claims filed against CITY related to CONTRACTOR's performance of this Agreement and subsequently tendered to CONTRACTOR shall be promptly investigated, and the resolution of such claims shall be promptly reported to CITY.
- 4. The obligations of CONTRACTOR under this or any other provision of this Agreement will not be limited by the provisions of any workers compensation act or similar act. CONTRACTOR expressly waives its statutory immunity under such statutes or laws as to CITY, its employees, agents, and officials.
- 5. CONTRACTOR agrees to obtain executed indemnity agreements with provisions identical to those as set forth here in this section from each and every subcontractor, sub-tier contractor or any other person or entity involved by, for, with or on behalf of CONTRACTOR in the performance or subject matter of this Agreement. Notwithstanding the foregoing, CONTRACTOR agrees to be fully and primarily responsible for all claims and liabilities arising out of the acts or omissions of any of its contractors and sub-tier contractors in the performance of this Agreement.

- 6. Failure of CITY to monitor compliance with these requirements imposes no additional obligations on CITY and will in no way act as a waiver of any rights hereunder. This obligation to indemnify and defend CITY as set forth herein is binding on the successors, assigns or heirs of CONTRACTOR and shall survive the termination of this Agreement or this section.
- H. Insurance:
 - Throughout the term of this Agreement, CONTRACTOR agrees to provide and maintain insurance as set forth in Exhibit C Insurance Requirements attached hereto and incorporated herein by reference.
- I. Assignment:
 - No assignment of all or any part of this Agreement, and no subcontract to perform any obligation hereunder, shall be made, either in whole or in part, by CONTRACTOR without the prior written consent of CITY.
- J. Independent Contractor:
 - The parties hereto agree that CONTRACTOR and its employees, officers, and agents are independent contractors under this Agreement and shall not be construed for any purpose to be employees of CITY.
- K. Governing Law:
 - 1. This Agreement shall be governed by and construed in accordance with the laws of the State of California. Venue for any litigation arising out of this Agreement shall be the Superior Court of the County of Orange.

- L. Attorneys' Fees:
 - 1. In the event any legal proceeding is instituted to enforce any term or provision of this Agreement, the prevailing party in said legal proceeding shall be entitled to recover attorneys' fees and costs from the opposing party in an amount determined by the court to be reasonable.
- M. Notices and Designated Representatives:
 - 1. Any and all notices, demands, invoices, and written communications (notices) between Parties shall be addressed to the individuals set forth below who are primarily responsible for their respective parties' performance. Such notices shall be deemed as received by addressee within two working days after deposit in the United States mail or an express mail carrier or by verifiable electronic means.

EXHIBIT A SCOPE OF SERVICES

I. Services Summary

- A. CONTRACTOR shall provide upgrades to the Curtis Theatre sound and monitoring equipment for CITY's Curtis Theatre.
- B. CONTRACTOR shall provide additional as-needed repair and maintenance services.

II. Services Locations

- A. The Curtis Theatre, 1 Civic Center Circle, Brea CA 92821.
- B: Locations may vary for additional as-needed repair and maintenance services.

III. Services Schedule

- A. CONTRACTOR shall provide the Services based on a to-be-determined agreed-upon schedule.
- B. CONTRACTOR shall be available on an on-call basis for additional asneeded repair and maintenance services as follows:
 - Routine work is when there is NO significant interruption in operation.
 CONTRACTOR must be at work site at agreed-upon time.
 Regular Time rates applies.
 - Urgent work is when there is a partial malfunction causing any significant interruption. CONTRACTOR must be at work site at agreed-upon time within 8 working hours of notification, 24/7/365.
 Overtime Rates of up to 1.5 times the Regular rate may apply.
 - 3. Emergency work is when there is a complete malfunction causing a complete interruption. CONTRACTOR must be at work site at

agreed-upon time within 2 hours of notification, 24/7/365, Doubletime Rates of up to 2.0 times the Regular rate may apply.

- 4. Premium Time (Overtime, Double-time) work is when CITY requires work that is outside of CITY's normal operational hours. Any work that CITY permits for CONTRACTOR's convenience outside of CITY's normal operational hours is not subject to any Premium Time rates. Premium Time rates are based on CONTRACTOR'S Regular rates multiplied by the appropriate factor.
- 5. CONTRACTOR shall notify City Representative immediately of issues that prevent responding by the above required times.

IV. General Requirements

- A: CONTRACTOR shall at all times comply with all applicable federal, state and local laws, regulations, statutes, orders and policies throughout the term of this Agreement.
- B. CONTRACTOR shall perform the Services according to all applicable industry standards and guidelines.
- C. CONTRACTOR shall not disclose any information in any form to any party other than CITY, unless CITY authorizes.

V. Scope of Services – Minimum Requirements

- A. CONTRACTOR shall provide fully-trained employees that are deemed acceptable by CITY perform the Services.
- B. CITY will refuse to permit any employee of CONTRACTOR considered by CITY in its sole discretion to be unacceptable to perform Services.
- C. CONTRACTOR shall provide everything necessary to perform Services including but not limited to all services, management, supervision, labor, handling, analysis, reports, supplies, equipment, transportation, insurances,

and related items and services at the all-inclusive lump sum stated in Exhibit B Compensation.

- D. CONTRACTOR shall provide Installation, connectivity, integration, and programming of all of the equipment listed in Exhibit 1: Estimate 0916-8170 and Exhibit 2: Estimate 0917-8306.
- E. CONTRACTOR shall provide additional as-needed repair and maintenance services upon City's request based on the Services Schedule subsection and Exhibit B Compensation subsection.

EXHIBIT B TERM AND COMPENSATION

I. Term

- A. The term of the agreement will be until project has been completed based on the Services Schedule stated in Exhibit A and for the additional as needed repair and maintenance services for a one-year base period with up to four optional one-year extensions based on available budget appropriations for a maximum term of five years.
- B. For each of the one-year extension terms, City and Contractor must agree mutually to extend the term prior to the expiration date of the current term. There are not automatic extensions. City Manager, on behalf of the City, may authorize any mutually-agreed upon extensions.

II. Compensation

- A. Services
 - The compensation shall be at the maximum lump sum amount of \$79,568.91 for the Services, which is the aggregate of Exhibit 1: Estimate 0916-8170 for \$49,727.53 and Exhibit 2: Estimate 0917-8306 for \$29,841.38.
- B. Additional As Needed Repair and Maintenance Services
 - The compensation shall be at the maximum rate of \$95.00 per hour for Routine Service Time, which is subject to Urgent and Emergency Premium rates and a 12% markup over costs for materials for additional as needed repair and maintenance services.
 - 2. Pricing for materials, equipment, services, G & A, overhead, and profit (Pricing Components) shall remain fixed for the one-year base period of the contract.

- 3. Pricing for each of the one-year extension terms shall be negotiated prior to the expiration date of the then current term based on Pricing Components and the the most recent available month for the applicable Los Angeles-Riverside-Orange County, CA Consumer Price Index (CPI) in effect for Orange County, CA.
- 4. The maximum sum payable is \$25,000.00 per year and the maximum aggregate amount is \$125,000.00 for the maximum term of five years.

EXHIBIT C INSURANCE REQUIREMENTS

I. Existing Coverage

A. If CONTRACTOR uses existing coverage to comply with these requirements and that coverage does not meet the requirements set forth herein, CONTRACTOR agrees to amend, supplement or endorse the existing coverage to do so.

II. Coverage Requirements

- A. The following coverages will be provided by CONTRACTOR and maintained on behalf of CITY and in accordance with the requirements set forth herein:
 - Commercial General Liability/Umbrella Insurance. Primary insurance shall be provided on ISO-CGL form No. CG 00 01 11 85 or 88 or similar. Total limits shall be not less than two million dollars (\$2,000,000) per occurrence for all coverage and two million dollars (\$2,000,000) general aggregate.
 - CITY and its officers, agents and employees shall be named as additional insureds using ISO additional insured endorsement form CG 20 10 11 85 or similar (in no event will CITY accept an endorsement form with an edition date later than 1990).
 - 3. General and Auto Liability Insurance Coverage shall be provided on a "per occurrence" basis and shall apply on a primary noncontributing basis in relation to any other insurance or self-insurance, primary or excess, available to CITY or any employee or agent of CITY. Coverage shall not be limited to the vicarious liability or supervisory role of any additional insured. Umbrella Liability Insurance (over primary) shall apply to bodily injury/property damage, personal injury/advertising injury, at a minimum, and shall

include a "drop down" provision providing primary coverage above a maximum of \$25,000.00 self-insured retention for liability not covered by primary policies but covered by the umbrella policy.

- 4. Coverage shall be in the following form as to any underlying coverage. Coverage shall be provided on a "pay on behalf" basis, with defense costs payable in addition to policy limits. There shall be no cross-liability exclusion. Policies shall have concurrent starting and ending dates.
- 5. Business Auto/Umbrella Liability Insurance. Primary coverage shall be written on ISO Business Auto Coverage form CA 00 01 06 92 or similar including symbol 1 (Any Auto). Limits shall be no less than one million dollars (\$1,000,000) per accident. Starting and ending dates shall be concurrent. If CONTRACTOR owns no autos, a nonowned auto endorsement to the General Liability policy drafted above is acceptable.
- 6. Workers' Compensation/Employers' Liability shall be written on a policy form providing workers' compensation statutory benefits as required by law. Employers' liability limits shall be no less than one million dollars (\$1,000,000) per accident or disease. Employer's liability coverage shall be scheduled under any umbrella policy described above. Unless otherwise agreed, this policy shall be endorsed to waive any right of subrogation as respects the CITY, its officers, agents or employees.
- B₂ Additional insurance requirements:
 - This Section supersedes all other sections and provisions of this Agreement to the extent that any other section or provision conflicts with or impairs the provisions of this Section.
 - 2. Nothing contained in this Section is to be construed as affecting or altering the legal status of the parties to this Agreement. The

insurance requirements set forth in this Section are intended to be separate and distinct from any other provision in this Agreement and shall be interpreted as such.

- 3. All insurance coverage and limits provided pursuant to this Agreement shall apply to the full extent of the policies involved, available, or applicable. Nothing contained in this Agreement or any other agreement relating to the CITY or its operations limits the application of each insurance coverage.
- 4. Requirements of specific coverage features or limits contained in this Section are not intended as a limitation on coverage, limits or other requirements, or a waiver of any coverage normally provided by any insurance. Specific reference to a given coverage feature is for purposes of clarification only and is not intended by any party to be all-inclusive, or to the exclusion of other coverage, or a waiver of any type.
- 5. For purposes of insurance coverage only, this Agreement shall be deemed to have been executed immediately upon any party hereto taking any steps that can be deemed to be in furtherance of or towards performance of this Agreement.
- 6. All general or auto liability insurance coverage provided pursuant to this Agreement, or any other agreements pertaining to the performance of this Agreement, shall not prohibit CONTRACTOR, and CONTRACTOR's agents, officers, or employees from waiving the right of subrogation prior to a loss. Contractor hereby waives all rights of subrogation against CITY.
- 7. Unless otherwise approved by CITY, CONTRACTOR's insurance shall be written by insurers authorized to do business in the State of California and with a minimum "Best's" Insurance Guide rating of "A VII."

- 8. In the event any policy of insurance required by this Agreement does not comply with these requirements or is canceled and not replaced, CITY has the right but not the duty to obtain the insurance it deems necessary and any premium paid by CITY will be promptly reimbursed by CONTRACTOR. Upon CONTRACTOR's failure to make such reimbursement within 30 days of written demand, CITY may deduct that sum from any monies due CONTRACTOR hereunder or otherwise.
- 9. CONTRACTOR agrees to provide evidence of the insurance required herein, satisfactory to CITY, consisting of certificate(s) of insurance evidencing all of the coverages required and an additional insured endorsement to CONTRACTOR's general liability and umbrella liability policy (if any) using ISO form CG 20 10 11 85 or similar. Certificate(s) are to reflect that the insurer will provide 30 days' notice of any cancellation of coverage. CONTRACTOR agrees to require its insurer to modify such certificates to delete any exculpatory wording stating that failure of insurer to mail written notice of cancellation imposes no obligation, and to delete the word "endeavor" with regarding to any notice provisions. CONTRACTOR agrees.
- 10. CONTRACTOR shall provide proof that policies of insurance required herein expiring during the term of this Agreement have been renewed or replaced with other policies providing at least the same coverage. Such proof shall be furnished within 72 hours of the expiration of the coverage.
- 11. Any actual or alleged failure on the part of CITY or any other additional insured under these requirements to obtain proof of insurance required under this Agreement in no way waives any right or remedy of CITY or any additional insured, in this or any other regard.

- 12. CONTRACTOR agrees to require all subcontractors or other parties hired for this project to provide general liability insurance naming as additional insureds all parties to this Agreement. CONTRACTOR agrees to obtain certificates evidencing such coverage and make reasonable efforts to ensure that such coverage is provided as required here. CONTRACTOR agrees to require that no contract used by any subcontractor, or contracts CONTRACTOR enters into on behalf of CITY, will reserve the right to charge back to CITY the cost of insurance required by this Agreement. CONTRACTOR agrees that upon request, all agreements with subcontractors or others with whom CONTRACTOR contracts on behalf of CITY will be submitted to CITY for review. Failure of CITY to request copies of such agreement will not impose any liability on CITY, its officers, agents, or employees.
- 13. If CONTRACTOR is a Limited Liability Company (LLC), general liability coverage must be amended so that the LLC and its managers, affiliates, employees, agents and other persons necessary or incidental to its operations are insureds.
- 14. CONTRACTOR agrees to provide immediate notice to CITY of any claim or loss against CONTRACTOR that includes CITY as a defendant. CITY assumes no obligation or liability by such notice, but has the right (but not the duty) to monitor the handling of any such claim or claims.

BACKGROUND/DISCUSSION

The Monthly Report of Investments (formally known as the Treasurer's Report) is in accordance with Government Code Section 53607 and contains information on the investment activities for the month of October 2017. Cash for day-to-day activities is deposited in the demand and interest-bearing checking accounts. The Local Agency Investment Fund (LAIF) is used for short term investment and functions like a savings account. The City's managed investment portfolio is for longer-term investments which are managed through Chandler Asset Management. Together, the short and long-term investment accounts represent the City's investment portfolio. Attachment A includes a Portfolio Summary, Holdings Report, Book Value Report and Compliance with Investment Policy Statement prepared by Chandler Asset Management for the invested funds. The book value is the cost, plus or minus amortization/accretion.

As of October 31, 2017, the total market value of the managed investment portfolio, including accrued interest, was \$57,425,996.25 as compared to \$59,451,563.22 at September 30, 2017. The weighted average investment yield for October 2017 was 1.69%, which was slightly higher from the prior month of 1.66%. The City's Local Agency Investment Fund (LAIF) had a total market value, including accrued interest of \$1,601,468.62 at October 31, 2017. This brings the total value of the City's investment portfolio as of October 31, 2017 to \$59,027,464.87, as compared to \$65,050,854.35 at September 30, 2017.

Restricted cash and investments are held in the post-employment benefits trust account administered by PARS (*PARS account*) and managed by High Mark Capital and the City's various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a monthly statement from US Bank for the PARS account as well as a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of October 31, 2017, the market value of the PARS account, including short-term cash and accrued interest was \$7,139,409.46 as compared to \$7,063,813.37 from the prior month. All other restricted cash investments (bond reserve accounts), including short-term cash and accrued interest was \$6,696,932.96 in comparison to \$6,796,075.39 from the prior month. Furthermore, the City of Brea holds 2,106.5 shares of water common stock with Cal Domestic valued at \$6,692,116.02 and 687.85 shares of Class A preferred stock with Pellissier Co-Tenancy, valued at

\$8,444,403.67 as of June 30, 2016.

All City investments are GASB rated No. 1, where the custodian (The Bank of New York Mellon Trust Company, N.A.) acts as an agent of the City, and is not a counter party to the investment transaction, and all securities are held in the name of the City of Brea. The custodial account at the Bank of New York and account records with Chandler Asset Management have been reconciled to par value for the month. The City of Brea has sufficient cash flow to meet its expected expenditures for the next six months.

FISCAL IMPACT/SUMMARY

During the month of October, the total value of the City's investment portfolio decreased by \$6,023,389.48. The decrease is primarily due to over \$4 million in progress payments relating to construction projects such as the Downtown Superblock Parking Structure, Lagos de Moreno Park and The Tracks at Brea, as well as two large intersection rehabilitation projects. The City's PARS account increased by \$75,596.09 primarily due to investment activity and the City's bond reserve accounts decreased by \$99,142.43 primarily due to the 2010 Lease Revenue Bond debt payment.





RECOMMENDATION

BACKGROUND/DISCUSSION

The Monthly Report of Investments (formally known as the Treasurer's Report) is in accordance with Government Code Section 53607 and contains information on the investment activities for the month of October 2017. Funds received by the Successor Agency are typically spent within 3-6 months; therefore are not invested long-term. The Successor Agency's Local Agency Investment Fund (LAIF) is used for short-term investments and functions like a savings account until funds are required to meet expenditures needs. Attachment A includes a Portfolio Summary and Holdings Report prepared by Chandler Asset Management for the funds invested on behalf of the Successor Agency's Local Agency Investment Fund (LAIF), was \$1,116,147.27 in comparison to \$1,115,081.28 at September 30, 2017. The Successor Agency to the Brea Redevelopment Agency has sufficient cash flow to meet its expected expenditures for the next six months.

The Successor Agency also has restricted (fiscal agent) cash and investment accounts related to its various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of October 31, 2017, the market value of these funds, including short-term cash and accrued interest was \$15,826,845.45 as compared to \$15,816,649.54 as of September 30, 2017.

FISCAL IMPACT/SUMMARY

During the month of October, the total value of the Successor Agency to the Brea Redevelopment Agency's investment portfolio increased by \$1,065.99 due to changes in market value . The total value of the restricted cash and investments increased by \$10,195.91 primarily due to investment activity.


