**SUBJECT:** Adoption of Ordinance No. 1206, Zoning Ordinance Amendment No. ZOA 18-02

## **RECOMMENDATION**

1) Open the public hearing, receive any public testimony and close hearing; and 2) Adopt Ordinance No. 1206 on second reading, approving Zoning Ordinance Amendment No. ZOA 18-02, an Ordinance of the City of Brea regarding the requirements and procedures for implementing the Planned Community (PC) Zone and amending the Brea Municipal Code regarding the same.

## **BACKGROUND/DISCUSSION**

## BACKGROUND

In 2017 the City completed the Brea Envisions process. This 18 month long, community wide, outreach effort had key goals to tap into Brea's residents and businesses to better understand what they found to be important needs and guiding considerations for the City's future. Led by a citizen committee, the effort culminated in delivery of the Brea Envisions Community Strategic Plan. This plan contains the captured community themes, vision, and strategic initiatives information from the outreach process.

In late 2017, the City initiated the Brea Core Plan effort, the first step toward implementing some of the direction provided by the Brea Envision process. This first of two phases of work is underway and includes an awareness campaign as well as initial testing of ideas from Brea Envisions, applied to a central defined area of Brea. Phase II will dive deeper into issues and establish more detailed direction, likely to include new land use considerations in focused areas, alternative transportation ideas and solutions, reviewing parks/recreation/cultural arts/human service needs, to name but a few anticipated highlights. Developing an approach, scope and budget for Phase II is in discussion now and will be presented to the Council at a future date.

The Brea Core Plan process and its eventual Specific Plan is a time tested and "proactive" planning effort—the City is actively planning for its future and messaging to investors and developers what we want to see in the future via the adoption of new standards and/or guidelines for new development.

However, time does not stand still and these comprehensive planning processes can often take

several years, sometimes longer, to complete—simply, the issues are detailed and involved and the process takes time. New private investment and development projects may be proposed during that time and may include creative and new types of development not currently accommodated under our development codes, but which may match-up well to the needs we have heard through Brea Envisions, as well as what may be reflected in the eventual Brea Core Plan. And, timing and economic realities for private investment can be finite and short—such that proposed projects may no longer make sense to a developer if they were forced to await completion of a comprehensive planning effort by the City.

The quandary then—have "new and different" development await the new standards and zoning of the Brea Core Plan? Or, identify an approach to consider such development projects within a process which would not have to await the completion of the Brea Core Plan?

In late 2017 staff were approached by various development interests which begged these very questions. Those projects included the Brea Downtown Hotel, Mercury Lane Apartments, as well as early indication from Simon Properties of new development at the Brea Mall (and, in the intervening months staff have been approached with other prospective projects too).

As discussions of the Downtown Hotel project surfaced last summer, staff discussed circumstances with Council and receptiveness to consider alternate entitlement processes for such projects (Development Committee and Council discussion, July 3 and 11, 2017) while the Brea Core Plan effort evolved to more completely address longer term planning tools for project review. Key to these discussions were the potential need to modify Brea's current development standards and allowances for these projects and an openness to consider such modifications if the projects provide significant community benefits to Brea. A need was also identified to bring any such private development projects forward for the City's consideration.

Staff embarked on this research anticipating that new code processes would need to be created to meet these goals. However, our research and collaboration with the City Attorney's Office have found that Brea's current zoning code and its Planned Community (PC) zoning district already provide for basic processes which can meet the identified needs.

The PC zone has been used several times in the past to develop areas of Brea to realize neighborhoods now familiar to many—the Country Hills master plan (which comprises much of east Brea), as well as three residential neighborhoods in west Brea, along the Tamarack Avenue corridor, south of Central Avenue—all of which provided for new and different development standards outside Brea's then adopted codes.

The PC zone is therefore an existing planning tool that could be used to address the City's current situation. As discussed below, however, the provisions of the Brea Municipal Code regarding the PC zone have not been used or updated since 1970's. Staff therefore believes that these provisions should be updated to meet current planning standards before considering whether they should be applied to any particular project.

At its meeting of July 17, the City Council directed staff to bring forward a draft Zoning Ordinance Amendment (ZOA) to consider such an update to the PC zone. That ZOA has been prepared and is now before the Planning Commission for its recommendation to the City Council who will then consider the amendment for final action and any adoption. Also presented for the Commission's consideration is a related General Plan Amendment (GPA). The City's current General Plan is silent with regard to the PC zone even though the PC zone predates and was in use prior to the General Plan. The GPA would therefore be an update to recognize the continuing availability and use of the PC zone to ensure continued consistency between the General Plan and the Municipal Code.

## **DISCUSSION**

The Planned Community (PC) zone has been included in Brea's code dating as far back as 1968 and has been used to implement several projects since that time. Most specifically, the PC zone and its processes were used to entitle large tracts of homes as well as ancillary commercial uses on the east side of Brea, the Country Hills master plan and its neighborhoods. Additionally, the zoning district was applied to several multi-family apartment projects on Tamarack Avenue on the west side of town.

The PC zoning district code text currently lists its description and purpose as follows:

"The purpose of this zone is to encourage, preserve and improve the health, safety and general welfare of the community by encouraging the use of contemporary land planning principles. The provisions of this zone are intended to allow diversification of uses, use relationships and heights of buildings, and open spaces in planned building groups while ensuring compliance with the spirit and intent of the zoning code and the City's adopted General Plan."

This language speaks to the situation the City currently faces with several development projects which are being proposed (outlined earlier in this report). However, because the applicable provisions of the Code have not been updated in some time, other provisions do not match contemporary planning, employ outdated terminology, and leave the processes for implementing the PC zone somewhat vague. Staff is therefore proposing an update and refresh of the PC zoning district language and its processes and procedures to align the code with contemporary planning practices, provide needed structure to the process, and establish a clearer process to consider projects that would require development standards that do not already apply to a given property.

Under the current code, properties zoned PC can be approved for any use and whatever development standards the City chooses to allow at the time the property is re-zoned as PC, regardless of whether such uses or standards are allowed anywhere else in the City. The proposed update to the PC would continue consideration of such new and creative standards. This can be particularly beneficial in the Central Core area of the City where new and different development standards and guidelines may result at the conclusion of the Central Core Plan long range planning effort.

The process outlined on the ordinance would formally begin only if the Council acts to initiate an amendment to the boundaries of the PC Zone to include new properties, allowing the Council at a very early step to decide whether a proposed PC project should move forward with further planning and study. Importantly, the Council's decision to initiate the boundary amendment would not be an approval, or even an endorsement of any project, but merely an indication that the Council is willing to consider the project pending a full review and study. It would also be an opportunity for the Council to provide early direction to staff and the developer as to what information the Council deems necessary to consider the project at a later time.

After the Council initiates the PC Zone change, the applicant then would work with the staff on the content of the master plan and all related studies – including all required environmental review. The full submittal requirements, critically including a plan for public outreach by the

developer, are detailed within the new draft code (see exhibit within the attached draft Ordinance). Staff have worked with the City Attorneys Office to assure that the process and submittal needs and details are robust, comprehensive and commensurate with the important decisions the Planning Commission and City Council will face when considering potential different and creative projects for development in Brea. The zone change and master plan would then be reviewed by the Planning Commission, before final consideration by the Council. Final approval of the master plan would expressly require that the Council make the following findings:

1. The Planned Community Master Plan is consistent with the General Plan, inclusive of any amendments proposed and approved as part of the application for the Planned Community Master Plan.

2. The Planned Community Master Plan is consistent with and the Brea Envisions Community Strategic Plan.

3. The Planned Community Master Plan would provide for an innovative development in an area of the City that presents unique planning challenges due to considerations such as geography, topography, and changing patterns of development not otherwise addressed by the City's existing zoning rules.

4. The properties included in the Planned Community Master Plan are suitable for the uses specified therein, in terms of access, size, their relationship to adjacent properties and similar or related uses, and other considerations deemed relevant by the City Council.

5. The Planned Community Master Plan is in the best interest of the City as a whole.

These findings are an important new feature of the ordinance. The current code only peripherally speaks to findings—some subtle, some more overt—but generally unstructured and spread in different areas of the code. The proposed code amendment places uniform findings within a specific section of the Chapter, clearly labeled, and consistently worded to match up with other aspects of the code and its review process.

Finally, the proposed code update would introduce a requirement for a Development Agreement (DA) The requirement for a DA is proposed to assure that such projects and considerations are commensurate with the community benefits a project provides. For Developers, a DA provides a guarantee that the City will not change its mind during the term of the agreement to disallow the project before it can be built. This sort of assurance is especially important in the Core Area, which is the subject of ongoing planning efforts, the results of which are not yet known. It would also be important for the City to be assured that if it goes through the considerable process of reviewing and approving such a project, that it can be developed as planned.

A DA would also require that the proposed Planned Community Master Plan also provide some form of community benefit – subject to the City Council's exclusive ability to negotiate and approve such benefits– further assuring the City and its residents that new projects that utilize the PC zone will have a positive impact. Staff also believes that the DA requirement would serve as a critical check and balance to assure that the approval of any alternative design and use standards would be balanced by compelling benefits for our community. DA processing will necessarily include early discussion and direction from the City Council regarding the negotiation of appropriate community benefits associated with any proposed project. The draft resolution attached to this report provides the proposed amendment language for the PC, Planned Community, zoning district together with clarifying language to be inserted into the General Plan.

# **CONCLUSION**

Brea is currently experiencing a high level of proposed development projects which hold potential to fulfill future needs as expressed within the General Plan and Brea Envisions Community Strategic Plan. Currently, the chapter within the zoning ordinance by which to consider such projects (Planned Community zoning district) lacks clarity, a structured process, and defined findings necessary to consider such projects for approval. The proposed amendment to the Planned Community zone provides for these features and offers a system of checks and balances within which to consider new development, including added tests for new development using the creative PC zone approach. Direct references to the PC zoning district and its implementation basis are also proposed to be added to the City's General Plan at this time in order to provide clarity and to complete the PC update process.

Council approved the introduction of Ordinance 1206 at the October 16, 2018, City Council meeting.

# COMMISSION/COMMITTEE RECOMMENDATION

On September 25, 2018, the Planning Commission unanimously voted to recommend approval to amend and update the Planned Communities zone. The Commission discussed and clarified whether the proposed amendments would allow applicants to bypass the community, approvals, or approving bodies, finding that the proposed PC process would actually expand community and decision-maker involvement in project consideration. Staff clarified that the proposed amendments provide a more clear process and submittal requirements--requiring a check-in with the City Council prior to acceptance of any application, making specific findings (outlined above) for any project approval, demonstrating community benefit from proposed projects, requiring the applicant to provide an community outreach plan (more comprehensive than basic legal hearing notice for a proposed project), and including the ultimate approval of a development agreement.

The Commission recommended approval of the draft ordinance with the following revisions:

- Add "Planned Community (PC) Zone" to the title of the General Plan section to read "Specific Plan and Planned Community (PC) Zone"
- Add "trail" to the required elements section under "Public Services and Facilities Element"

## **ORDINANCE NO. 1206**

## AN ORDINANCE OF THE CITY OF BREA REGARDING THE REQUIREMENTS AND PROCEDURES FOR IMPLEMENTING THE PLANNED COMMUNITY (PC) ZONE AND AMENDING THE BREA MUNICIPAL CODE REGARDING THE SAME

## A. <u>RECITALS.</u>

1. The City has initiated applications for General Plan Amendment No. GPA 18-01 and Zoning Ordinance Amendment No. ZOA 18-02 regarding the requirements and procedures for implementing the Planned Community (PC) Zone. The text of ZOA 18-02 is set forth in the attached Exhibit A, which is hereby incorporated into this Ordinance as though set forth in full.

2. On September 25, 2018, the Planning Commission held a duly noticed public hearing on GPA 18-01 and ZOA 18-2, at which all persons present had an opportunity to speak on the matter. After considering all of the evidence presented, including but not limited to all written evidence and testimony presented during that hearing, adopted Planning Commission Resolution No.18-10 recommending that the City Council approve GPA 18-01 and ZOA 18-2.

3. On October 16, 2018, the City Council held a duly noticed public hearing on GPA 18-01 and ZOA 18-2, at which all persons present had an opportunity to speak on the matter.

4. All legal prerequisites to adoption of this Ordinance have been met.

## B. ORDINANCE.

## THE CITY COUNCIL OF THE CITY OF BREA DOES ORDAIN AS FOLLOWS:

**SECTION 1.** The City Council finds that all facts set forth in the Recitals, Part A of this Resolution, are true and correct.

**SECTION 2.** The City Council finds that it can be seen with certainty that there is no possibility the adoption of this Ordinance will have a significant effect on the environment because it only establishes generally applicable procedures by which the City will consider where and how to implement the Planned Community zone without reference to any particular development project. It is therefore exempt from California Environmental Quality Act review pursuant to Title 14, Section 15061(b)(3) of the California Code of Regulations.

**SECTION 3.** Chapter 20.272 of the Brea Municipal Code is hereby amended in its entirety to read as set forth in Exhibit A to this Ordinance, which is hereby incorporated as though set forth in full.

**SECTION 4.** The City Council declares that, should any provision, section, paragraph, sentence, or word of this Ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences, and words of this Ordinance shall remain in full force and effect.

**SECTION 5.** The City Clerk shall certify to the adoption of this Ordinance.

## **ORDINANCE NO. 1206**

## Brea City Code CHAPTER 20.272 PC PLANNED COMMUNITY

## § 20.272.010 INTENT AND PURPOSE

- A. The purpose of this zone is to encourage, preserve, and improve the health, safety, and general welfare of the community by encouraging innovative development that allows a diversification of uses, use relationships, building heights, densities, and open spaces in planned community developments while ensuring consistency with the City's General Plan.
- B. Development of properties in the Planned Community Zone will occur in accordance with the requirements and provisions of a detailed, site-specific Planned Community Master Plan specifically created and adopted for such properties to promote innovative development projects that anticipate the future needs of the City's residents, businesses, and visitors, while respecting existing uses. The Planned Community Zone shall be reserved for the development of innovative projects in areas of the City that present unique planning challenges due to considerations such as geography, topography, and changing patterns of development not otherwise addressed by the City's existing zoning rules.

## § 20.272.020 APPLICABILITY

- A. This Chapter shall apply to all properties designated as Planned Community on the City's Zoning Map.
- B. An amendment to the Zoning Map to change the boundaries of the Planned Community zone may only be initiated by the City Council; provided that any property owner or his or her designated agent, may petition the City Council to initiate such an amendment. In all other regards, amendments to the Zoning Map affecting the boundaries of the Planned Community Zone shall comply with the provisions of Chapter 20.404 and this Chapter 20.272 except as they might otherwise conflict with the provisions of this Chapter, in which case this Chapter shall control.

## § 20.272.030 PLANNED COMMUNITY MASTER PLANS

A. *Master Plan Required.* All properties within the Planned Community Zone must have an approved Planned Community Master Plan pursuant to this Chapter. Any application to amend the Zoning Map to incorporate a property into the Planned Community Zone must be accompanied by a complete application for approval of a Planned Community Master Plan that includes that property. No such Zoning Map amendment shall become effective unless and until the City Council approves a Planned Community Master Plan that includes that property and such approval is final.

- B. Uses Allowed. No building, structure, land in the Planned Community Zone shall be used, erected, structurally altered, or enlarged except in conformance with a Planned Community Master Plan approved pursuant to this Chapter.
- C. *Required Elements.* Every Planned Community Master Plan shall include a general statement of goals and objectives and detailed elements that explain how such goals and objectives will be met. The following elements shall be required for every Planned Community Master Plan:
  - 1. Land Use Element. The land use element shall consist of text, maps figures, setting forth the distribution, general location, and extent of the areas of land devoted to each category of land use proposed as part of the Planned Community Master Plan. It may therefore include, but not necessarily be limited to designations for various housing types, retail shopping facilities, office facilities, service facilities, public and semipublic facilities, conservation or open space areas, and mixed uses, as well as development and construction timelines for any of these.
  - 2 *Circulation Element.* The circulation element shall consist of text, maps, and figures, setting forth the general locations, dimensions, operational standards, and specifications of all streets, walkways, trails, transportation alternatives, and all transportation-related infrastructure proposed as part of the Planned Community Master Plan. This element shall include but not necessarily be limited to design criteria for engineering review and the traffic carrying capacities of all arterial streets and highways.
  - 3. *Population Element*. The population element shall contain text, maps, and figures that explain the distribution of dwelling unit and anticipated population density for both the entire Planned Community Master Plan and each subarea, if any.
  - 4. *Public Services and Facilities Element.* The public services and facilities element shall contain text, maps, and figures setting forth the general locations and specifications of any and all existing and proposed trail and public facilities for the Planned Community Master Plan area.
- D. Additional Elements. Every Planned Community Master Plan shall also include such additional elements as the City deems necessary for development of the Planned Community Master Plan or evaluation of its impacts. Examples of such additional elements that may be required include, but are not necessarily limited to, a Sustainability Element, an Urban Design Element, or a Cultural Arts Element. The City may also require the recordation of all subdivision tracts or parcels, a schedule of construction, a phasing plan, and incorporation of the application requirements contained in Section 20.272.030.F, as the City deems appropriate.

- E. *Required Plans, Figures, and Data.* Each Planned Community Master Plan shall include plans, figures, and data in sufficient number and detail to allow for effective evaluation and implementation. Such plans, figures, and data shall include, but not necessarily be limited to, the following:
  - 1. Detailed site plans.
  - 2 Legal descriptions or boundary surveys of the property or properties.
  - 3. Site utilization maps drawn to scale and showing the location of the proposed site and its relationship to surrounding existing uses.
  - 4. Grading plans, including lot dimensions and pad size of all lots and their relationships, the nature and extent of all cut and fill, the location, grades, widths, and related details for all utilities, streets, walkways, driveways, and related facilities.
  - 5. Location, design, and related details for all parking areas, vehicle storage, and any proposed alternative transportation infrastructure.
  - 6. Landscape and hardscape plans.
  - 7. Architectural plans and details, including height, number of stories, materials, colors, and finishes.
  - 8. Renderings and view illustrations, as deemed necessary.
  - 9. Conceptual color and materials boards, including specifications, quality, and durability of materials.
  - 10. Drainage plans.
  - 11. Fencing and wall plans.
  - 12 Public and private amenities plans
  - 13. Subdivision plans, as necessary to clarify any proposed subdivision.
- F. Development and Design Standards. Each Planned Community Master Plan shall include detailed development and design standards in accordance with this paragraph.
  - 1. *Existing Standards.* Proposed land uses that will be developed in accordance with existing ordinances of the city, those zones or development standards that are to be employed in implementing each type, phase or area of residential and/or commercial development shall be so designated and shall be developed according to the development and

design standards and review procedures that are applicable to that designation.

- 2 Alternative Standards. The City Council may approve alternative development and design standards in a Planned Community Master Plan for development at densities and levels of intensity not otherwise provided for in Title 20 but designed specifically for a particular type, phase, or area of the Planned Community Master Plan; provided that nothing in this Chapter shall be construed to require the City to approve any alternative development or design standards. Proposed land uses that will be developed with such alternative development and design standards shall be so designated in the Planned Community Master Plan and shall be developed according to the applicable development and design standards and review procedures set forth in the Planned Community Master Plan.
- 3. Except as otherwise provided in the design and development standards in the Planned Community Master Plan, all other provisions of the zoning code shall apply in the Planned Community Zone. Furthermore, all development in the Planned Community Zone is subject to the requirements of this Code pertaining to art in public places and subdivisions notwithstanding any provision in an adopted Planned Community Master Plan.
- G. Procedures.
  - 1. *Application*. The owners of the subject property or their authorized agents may apply for approval of a Planned Community Master Plan. All properties included in the application must be under single ownership or controlled by a single entity from the time of application and until the effective date of the ordinance approving the Zoning Map amendment associated with the Planned Community Master Plan. All applications shall be made on a form prescribed by the director that requires, but shall not necessarily be limited to the following:
    - a. Five print copies and one electronic copy of the draft Planned Community Master Plan, including but not necessarily limited to all required contents.
    - b. A market or economic analysis of all proposed uses, including analysis of alternative uses and alternative locations.
    - c. A detailed list and explanation of the community benefits that the Planned Community Master Plan would provide; including when appropriate a list of such community benefits that will be provided pursuant to a development agreement.
    - d. A plan for engaging in public outreach with a cross-section of residents, businesses, and other community stakeholders.

- e. A filing fee in accordance with a schedule adopted by City Council resolution, which fee shall be sufficient to cover the City's costs and expenses in processing the application.
- f. Any information the City deems necessary to the City's preparation of any additional study or studies it deems necessary for consideration of the Planned Community Master Plan; e.g. economic impact analysis, parking impact analysis, etc.
- 2. *Public Outreach Required.* The applicant shall engage in public outreach regarding the proposed Planned Community Master Plan in accordance with the plan submitted to the City and shall provide a summary report of the results of such outreach for the consideration of the Planning Commission and City Council.
- 3. Development Agreement Required. An application for a Planned Community Master Plan must include an application for a development agreement applicable to the entirety of the plan area, and no approval of a Planned Community Master Plan shall be final unless and until the City Council has approved the development agreement and such approval is final. The purpose of this requirement is to provide the community and applicants the assurance that development of the Planned Community Master Plan, and its associated community benefits, may be realized notwithstanding any development standards to the contrary that the City may adopt after approval of the Planned Community Master Plan.
- 4. *Planning Commission Review and Recommendation.* The Planning Commission shall consider each application for a Planned Community Master Plan at a public hearing, which it may hold concurrently with any hearings on any related applications such as a related Zoning Map amendment. Following the hearing, the Commission shall recommend to the Council approval or disapproval of the application.
- 5. *City Council Decision*. The City Council shall have sole authority to approve a Planned Community Master Plan. The City Council shall consider each application and the recommendation of the Planning Commission at a public hearing, which it may hold concurrently with any hearings on any related applications. Following the hearing, the City Council shall approve or disapprove the application by reference to the findings required for approval. The City Council shall only approve the application by ordinance.
- 6. *Findings Required for Approval.* The City Council shall only approve a Planned Community Plan shall only approved if it makes the following findings:

- a. The Planned Community Master Plan is consistent with the General Plan, inclusive of any amendments proposed and approved as part of the application for the Planned Community Master Plan.
- b. The Planned Community Master Plan is consistent with the Brea Envisions Community Strategic Plan.
- c. The Planned Community Master Plan would provide for an innovative development in an area of the City that presents unique planning challenges due to considerations such as geography, topography, and changing patterns of development not otherwise addressed by the City's existing zoning rules.
- d. The properties included in the Planned Community Master Plan are suitable for the uses specified therein, in terms of access, size, their relationship to adjacent properties and similar or related uses, and other considerations deemed relevant by the City Council.
- e. The Planned Community Master Plan is in the best interest of the City as a whole.
- 7. *Amendment.* A Planned Community Master Plan may be amended subject to the same procedures and requirements applicable to its adoption.
- H. *Interpretation*. Each adopted Planned Community Master Plan shall be construed in the manner most consistent with the General Plan, this Chapter, and the purposes for and findings upon which the Planned Community Master Plan was adopted. Any uncertainty or ambiguity in the requirements or application of any adopted Planned Community Master Plan may be resolved pursuant to the administrative interpretation process found in Section 20.408.010.

**SUBJECT:** Amendment to Professional Services Agreement with MTGL, Inc. for Additional Construction Materials and Soils Testing Services on Capital Improvement Projects

## RECOMMENDATION

Approve the Amendment to Professional Services Agreement increasing the annual contract amount from \$50,000 to \$150,000.

## **BACKGROUND/DISCUSSION**

On July 1, 2015, the City Council approved a Professional Services Agreement (PSA) with MTGL, Inc. to provide Construction Materials and Soils Testing (Geotechnical) services for various Capital Improvement Projects on an "As-Needed (On-Call)" basis (see Contract). The PSA includes a not-to-exceed amount of \$50,000 per year with an initial one-year term and provisions for three-one year extensions making the total possible contract term four (4) years. To date, the PSA term has been extended three times with the current term from July 1, 2018 to June 30, 2019.

Throughout the span of this On-Call PSA for Geotechnical services, MTGL has provided services on several high-priority projects including The Glenbrook Tract Water Line Replacement and Street Rehabilitation (CIP 7452), The Tracks at Brea, Segments 6, 2 and 3 (CIP 7873), and The Laurel Elementary Magnet School/Lagos de Moreno Park Upgrades (CIP 7929).

In the previous PSA term, July 1, 2017 to June 30, 2018, the City increased the annual amount from \$50,000 to \$140,000 as a result of several issues regarding the Lagos De Moreno Park Upgrades (CIP 7929). One major issue consisted of an unforeseen six inch (6") sewer lateral that was discovered during excavation which required replacement. As a result, the original completion date of November 28, 2017 was pushed to June 2018. Subsequent to the aforementioned issues, the primary contractor continued to cause numerous construction delays due to poor performance, as well as unorthodox means and methods. This caused the need for frequent additional site visits by MTGL staff for special inspection and materials testing.

Collectively, between the unforeseen issues and the contractor's numerous construction delays, CIP 7929 was significantly competed on September 28, 2018. With a substantial completion date of September 28, 2018, the contractor is 172 working days over the time specified in the contract.

As a result, MTGL provided additional services for the project past the extended estimated completion date of June, 2018 to September 28, 2018 which resulted in a total amount of

\$150,000, which is \$100,000 over the current allowable annual limit of the PSA. In order to increase the purchase order so these extra charges can be accommodated, the annual PSA amount of \$50,000 will need to be increased. Staff has prepared a PSA Amendment (Amendment No. 2) to increase the annual not-to-exceed third extended term amount from \$50,000 to \$150,000, which will cover the added CIP 7929 project costs (see Amendment #2).

# COMMISSION/COMMITTEE RECOMMENDATION

Finance Committee reviewed this report at their October 30, 2018 meeting. The committee recommended approval to City Council with a comment that staff investigate ways City Council can review change orders on future contracts as they're being issued by staff.

## FISCAL IMPACT/SUMMARY

Amendment No. 2 to the MTGL annual "As-Needed (On-Call)" PSA for Geotechnical services will allow staff to increase the amount of the purchase order to \$150,000 for CIP 7929, which will cover the work up to September 28, 2018. Therefore, staff recommends amending the PSA with MTGL to increase the not-to-exceed amount from \$50,000 to \$150,000 for the third extended term.

All costs related to MTGL services are included in the approved budget for the aforementioned project. As indicated by the table below, there are sufficient funds within the project to cover the cost of purchase order changes within the Amendment, therefore, there will be no impact to the General Fund.

#### **PROFESSIONAL SERVICES AGREEMENT**

This Agreement is made and entered into this <u>1<sup>st</sup></u> day of <u>July</u> 2015 between the City of Brea, a Municipal Corporation (hereinafter referred to as "CITY") and <u>MTGL, Inc.</u> (hereinafter referred to as "CONSULTANT").

A. Recitals

(i) CITY has heretofore issued its Request for Proposal pertaining to the performance of professional services with respect to <u>construction materials and soils testing services for various capital improvement</u> <u>projects on an "as-needed (on-call)" basis</u> ("Tasks" hereafter), a full, true and correct copy of which is attached hereto as Exhibit "A" and by this reference made a part hereof.

(ii) CONSULTANT has now submitted its proposal for the performance of such services, a full, true and correct copy of which proposal is attached hereto as Exhibit "B" and by this reference made a part hereof.

(iii) CITY desires to retain CONSULTANT to perform professional services necessary to render advice and assistance to CITY, City's Planning Commission, City Council and staff to complete said Tasks.

(iv) CONSULTANT represents that it is qualified to perform such services and is willing to perform such professional services as hereinafter defined.

NOW, THEREFORE, it is agreed by and between CITY and CONSULTANT as follows:

B. Agreement

1. <u>Definitions</u>: The following definitions shall apply to the following terms, except where the context of this Agreement otherwise requires:

(a) <u>Tasks</u>: Provide professional services as described in Exhibit "A" hereto including, but not limited to, the preparation of maps, reports, and documents, presentation, both oral and in writing, of such plans, maps, reports and documents to CITY as required.

(b) <u>Services</u>: Such professional services as are necessary to be performed by CONSULTANT in order to complete the assigned Tasks. The CONSULTANT will provide services on an "as-needed (on-call)" basis for projects to be determined during the term of the contract. The contract will be for a one-year term with provisions for three-one year extensions with the total term not exceeding four (4) years.

(c) <u>Completion of Tasks</u>: The date of completion of all assigned Tasks, including any and all procedures, development plans, maps, plan documents, technical reports, meetings and oral presentations regarding the completion of Tasks as set forth in Exhibits "A" hereto.

#### 2. <u>CONSULTANT agrees as follows:</u>

(a) CONSULTANT shall forthwith undertake and complete the assigned Tasks in accordance with Exhibits "A" hereto and all in accordance with Federal, State and CITY statutes, regulations, ordinances and guidelines, all to the reasonable satisfaction of CITY.

(b) CONSULTANT shall supply copies of all maps, reports, plans and documents (hereinafter collectively referred to as "documents") including all supplemental technical documents, as described in Exhibits "A" to CITY within the time specified in Exhibit "A". Copies of the documents shall be in such numbers as are required in Exhibit "A". CITY may thereafter review and forward to CONSULTANT comments regarding said documents and CONSULTANT shall thereafter make such revisions to said documents as are deemed necessary. CITY shall receive revised documents in such form and in the quantities determined necessary by CITY. The time limits set forth pursuant to this Section B2(b) may be extended upon written approval of CITY.

(c) CONSULTANT shall, at CONSULTANT's sole cost and expense, secure and hire such other persons as may, in the opinion of CONSULTANT, be necessary to comply with the terms of this Agreement. In the event any such other persons are retained by CONSULTANT, CONSULTANT hereby warrants that such persons shall be fully qualified to perform services required hereunder. CONSULTANT further agrees that no subcontractor shall be retained by CONSULTANT except as may otherwise be set forth in Exhibit "B" and upon the prior written approval of CITY.

#### 3. <u>CITY agrees as follows:</u>

(a) To pay CONSULTANT pursuant to the provisions of Exhibit "B" Services required hereunder. Said sum(s) shall cover the costs of all staff time and all other direct and indirect costs or fees, including the work of employees, consultants and subcontractors to CONSULTANT, except as may otherwise be set forth in Exhibit "B". Payment to CONSULTANT, by CITY, shall be made in accordance with the schedule set forth below.

(b) Payments to CONSULTANT shall be made by CITY in accordance with the invoices submitted by CONSULTANT, on a monthly basis, and such invoices shall be paid within a reasonable time after said invoices are received by CITY. All charges shall be in accordance with CONSULTANT's proposal either with respect to hourly rates, time and materials, or lump sum amounts for individual tasks, as approved, in writing, by CITY. In no event shall CONSULTANT, or any person claiming by or through CONSULTANT be paid an aggregate amount in excess of <u>fifty thousand dollars and zero cents</u> (\$50,000.00). The costs associated with the Tasks performed for private development projects are not part of the not-to-exceed amount.

(c) CONSULTANT agrees that, in no event, shall CITY be required to pay to CONSULTANT any sum in excess of 95% of the maximum payable hereunder prior to receipt by CITY of all final documents, together with all supplemental technical documents, as described herein acceptable in form and content to CITY. Final payment shall be made not later than 60 days after presentation of final documents and acceptance thereof by CITY.

(d) Additional services: Payments for additional services requested, in writing, by CITY, and not included in CONSULTANT's proposal as set forth in Exhibit "A" hereof, shall be paid on a reimbursement basis in accordance with the fee schedule set forth in said Exhibit "B". Charges for additional services shall be invoiced on a monthly basis and shall be paid by CITY within a reasonable time after said invoices are received by CITY.

4. <u>CITY agrees to provide to CONSULTANT</u>:

(a) Information and assistance as set forth in Exhibit "A" hereto.

(b) Photographically reproducible copies of maps and other information, if available, which CONSULTANT considers necessary in order to complete the Tasks.

(c) Such information as is generally available from CITY files applicable to the Tasks.

(d) Assistance, if necessary, in obtaining information from other governmental agencies and/or private parties. However, it shall be CONSULTANT's responsibility to make all initial contact with respect to the gathering of such information.

5. <u>Ownership of Documents</u>: All documents, data, studies, surveys, drawings, maps, models, photographs and reports prepared by CONSULTANT pursuant to this Agreement shall be considered the property of CITY and, upon payment for services performed by CONSULTANT, such documents and other identified materials shall be delivered to CITY by CONSULTANT. CONSULTANT may, however, make and retain such copies of said documents and materials as CONSULTANT may desire.

6. <u>Termination</u>: This Agreement may be terminated by CITY upon the giving of a written "Notice of Termination" to CONSULTANT at least fifteen (15) days prior to the date of termination specified in said Notice. CONSULTANT shall not be compensated for any work performed after receipt of the Notice of Termination. CONSULTANT shall provide to CITY any and all documents, whether in draft or final form, prepared by CONSULTANT as of the date of termination. CONSULTANT may not terminate this Agreement except for cause.

7. <u>Notices and Designated Representatives</u>: Any and all notices, demands, invoices and written communications between the parties hereto shall be addressed as set forth in this section 7. The below named individuals, furthermore, shall be those persons primarily responsible for the performance by the parties under this Agreement:

#### CONSULTANT REPRESENTATIVE

Any such notices, demands, invoices and written communications, by mail, shall be deemed to have been received by the addressee forty-eight (48) hours after deposit thereof in the United States mail, postage prepaid and properly addressed as set forth above.

8. <u>Insurance</u>: The CONSULTANT shall not commence work under this contract until it has obtained all insurance required hereunder in a company or companies acceptable to CITY nor shall the CONSULTANT

allow any subcontractor to commence work on its subcontract until all insurance required of the subcontractor has been obtained. The CONSULTANT shall take out and maintain at all times during the life of this contract the following policies of insurance:

(a) Compensation insurance: Before beginning work, the CONSULTANT shall furnish to the CITY a certificate of insurance as proof that it has taken out full compensation insurance for all persons whom the CONSULTANT may employ directly or through subcontractors in carrying out the work specified herein, in accordance with the laws of the State of California. Such insurance shall be maintained in full force and effect during the period covered by this contract. Further, such policy of insurance shall provide that the insurer waives all rights of subrogation against CITY and its elected officials, officers, employees and agents.

In accordance with the provisions of Section 3700 of the California Labor Code, every contractor shall secure the payment of compensation to his employees. CONSULTANT, by executing this Agreement, certifies as follows:

"I am aware of the provisions of Section 3700 of the labor Code which require every employer to be insured against liability for workers' compensation or to undertake self insurance in accordance with the provisions of that code, and I will comply with such provisions before commencing the performance of work of this contract."

(b) For all operations of the CONSULTANT or any subcontractor in performing the work provided for herein, insurance with the following minimum limits and coverage:

(1) Commercial General Liability (occurrence) - for bodily injury, death and property damage for products/completed operations and any and all other activities undertaken by the CONSULTANT in the performance of this Agreement - - or - -:

(2) (Alternative to Commercial General Liability) - Comprehensive, broad form General

Public Liability (occurrence) - for bodily injury, death and property damage arising out of any activities undertaken by CONSULTANT in the performance of this Agreement. (3) Comprehensive Automobile Liability (occurrence) - for bodily injury, death and property damage insuring against all liability arising out of the use of any vehicle.

(4) Professional Errors and Omissions Liability - insuring against all liability arising out of professional errors and/or omissions, providing protection of at least <u>two million dollars and zero cents</u> (\$2,000,000.00) for errors and/or omissions ("malpractice") of CONSULTANT in the performance of this Agreement . Such policy may be subject to a deductible or retention in an amount acceptable to CITY and shall further be subject to the provisions of subsections (2) and (6) of Section c, below. If a "claims made" policy is provided, such policy shall be maintained in effect from the date of performance of work or services on CITY's behalf until three (3) years after the date the work or services are accepted as completed. Coverage for the post-completion period may be provided by renewal or replacement of the policy for each of the three (3) years or by a three (3) year extended reporting period endorsement which reinstates all limits for the extended reported period. If any such policy and/or policies have a retroactive date, that date shall be no later than the date of first performance of work or services on behalf of CITY. Renewal or replacement policies shall not allow for any advancement of such retroactive date. Each such policy or policies shall include a standard "notice of circumstances" provision.

(5) Other required insurance, endorsements or exclusions as required by the Request for Proposal.

(6) The policies of insurance required in this Section 8(b) shall have no less than the following limits of coverage:

(i) \$2,000,000 (Two Million Dollars) for bodily injury or death;

(ii) \$2,000,000 (Two Million Dollars) for property damage;

(iii) The total of the limits specified in subsections (i) and (ii), above, where a combined single limit is provided.

(c) The policies of insurance required in subsections (1), (2) and (3) of Section 8(b), above shall:

(1) Be subject to no deductible amount unless otherwise provided, or approved in writing

by CITY;

(2) Be issued by an insurance company approved in writing by CITY, which is admitted and licensed to do business in the State of California and which is rated A VII or better according to the most recent A.M. Best Co. Rating Guide;

(3) Name as additional insureds the CITY, its elected officials, officers, employees, attorneys and agents, and any other parties, including subcontractors, specified by CITY to be included;

(4) Specify that it acts as primary insurance and that no insurance held or owned by the

designated additional insureds shall be called upon to cover a loss under said policy;

(5) Specify that it applies separately to each insured against whom claim is made or suit is

brought, except with respect to the limits of the insurer's liability;

(6) Contain a clause substantially in the following words:

"It is hereby understood and agreed that this policy may not be canceled nor the amount of coverage thereof reduced until thirty (30) days after receipt by CITY of written notice of such cancellation or reduction of coverage as evidenced by receipt of a registered letter."

(7) Specify that any failure to comply with reporting or other provisions of the required policy, including breaches of warranty, shall not affect the coverage required to be provided;

(8) Specify that the insurer waives all rights of subrogation against any of the named

additional insureds; and

(9) Specify that any and all costs of adjusting and/or defending any claim against any

insured, including court costs and attorneys' fees, shall be paid in addition to and shall not deplete any policy limits.

(10) Otherwise be in form satisfactory to CITY.

(d) Prior to commencing performance under this Agreement, the CONSULTANT shall furnish the

CITY with original endorsements, or copies of each required policy, effecting and evidencing the insurance coverage required by this Agreement. The endorsements shall be signed by a person authorized by the insurer(s) to bind coverage on its behalf. All endorsements or policies shall be received and approved by the CITY before CONSULTANT commences performance. If performance of this Agreement shall extend beyond one (1) year, CONSULTANT shall provide CITY with the required policies or endorsements evidencing renewal of the required policies of insurance prior to the expiration of any required policies of insurance.

9. <u>Indemnification</u>: Other than in the performance of professional services and to the fullest extent permitted by law, CONSULTANT shall indemnify, defend and hold CITY, its employees, agents and officials harmless from and against their tort liability, (including liability for claims, suits, actions, expenses or costs of any kind, whether actual, alleged or threatened, actual attorney's fees incurred by CITY, court costs, interest or defense costs including expert witness fees), where the same arise out of, in whole or in part, the performance of the Agreement by CONSULTANT (or any individual or entity that CONSULTANT shall bear the legal liability thereof) and which result in bodily injury or property damage to any individual or entity, including the employees or officials of CONSULTANT.

In addition to the foregoing, CONSULTANT shall indemnify, defend and hold harmless CITY and its officials and employees from and against any and all losses, liabilities, damages, costs and expenses, including reasonable attorney's fees and costs to the extent the same are caused by the professional negligence of CONSULTANT (or any entity or individual that CONSULTANT shall bear the legal liability thereof) in the performance of professional services pursuant to this Agreement.

10. <u>Assignment</u>: No assignment of this Agreement or of any part or obligation of performance hereunder shall be made, either in whole or in part, by CONSULTANT without the prior written consent of CITY.

11. Damages: In the event that CONSULTANT fails to submit to CITY the completed project, together with all documents and supplemental material required hereunder, in public hearing form to the reasonable satisfaction of CITY, within the time set forth herein, or as may be extended by written consent of the parties hereto, CONSULTANT shall pay to CITY, as liquidated damages and not as a penalty, the sum of <u>N/A</u> dollars (\$000.00) per day for each day CONSULTANT is in default, which sum represents a reasonable endeavor by the parties hereto to estimate a fair compensation for the foreseeable losses that might result from such a default in performance by CONSULTANT, and due to the difficulty which would otherwise occur in establishing actual damages resulting from such default, unless said default is caused by CITY or by acts of God, acts of the public enemy, fire, floods, epidemics, or quarantine restrictions.

12. <u>Independent Contractor</u>: The parties hereto agree that CONSULTANT and its employers, officers and agents are independent contractors under this Agreement and shall not be construed for any purpose to be employees of CITY.

13. <u>Governing Law</u>: This Agreement shall be governed by and construed in accordance with the laws of the State of California.

14. <u>Attorneys' Fees</u>: In the event any legal proceeding is instituted to enforce any term or provision of the Agreement, the prevailing party in said legal proceeding shall be entitled to recover attorneys' fees and costs from the opposing party in an amount determined by the court to be reasonable.

15. <u>Entire Agreement</u>: This Agreement supersedes any and all other agreements, either oral or in writing, between the parties with respect to the subject matter herein. Each party to this Agreement acknowledges that no representation by any party which is not embodied herein nor any other agreement, statement, or promise not contained in this Agreement shall be valid and binding. Any modification of this Agreement shall be effective only if it is in writing signed by all parties.

- 4. Any other expenses incurred by Offeror prior to date of award, if any, of the Agreement.

#### G. JOINT OFFERS

Where two or more Offerors desire to submit a single proposal in response to this RFP, they should do so on a prime-subcontractor basis rather than as a joint venture. City intends to contract with a single firm and not with multiple firms doing business as a joint venture.

#### H. PROTEST PROCEDURES

Any protests filed by an Offeror in connection with this RFP must be submitted in writing via certified mail to the following:

#### I. FEE PROPOSAL

Provide a schedule of hourly rates that will be charged to perform services specified in Section V. The City proposes to issue a contract for a period of one (1) year with the City having the option to extend under the same terms and conditions for a maximum of three (3) one (1) year options.

The consultant will enter into an agreement with the City based upon the contents of the RFP and the consultant's proposal. The City's standard form of agreement is included in Section IV. The consultant shall carefully review the agreement, especially with regard to the indemnity and insurance provisions, and include with the proposal a description of any exceptions, technical or contractual, requested to the standard contract. If there are no exceptions, a statement to that effect shall be included in the proposal.

#### J. PREVAILING WAGES

Certain labor categories under this project are subject to prevailing wages as identified in the State of California Labor Code Sections 1720-1815 and Federal Wage Rates. Consultant and its sub-contractors shall conform to applicable wage rates. It is required that all mechanics and laborers employed or working at the site be paid not less than the basic hourly rates of pay and fringe benefits as shown in the current minimum applicable wage schedules. Offerors and their sub-contractors must use the current wage schedules applicable at the time the work is in progress.

#### K. INSURANCE REQUIREMENTS

The consultant shall take out and maintain at all times during the term of the contract, the insurance specified in the agreement and acceptable to the City. Insurance "Acceptable to the City" shall be defined as a company admitted (licensed) to write insurance in California and having a Best's Guide rating of not less than A VII. These minimum levels of coverage are required to be maintained for the duration of the project:

- A. <u>General Liability Coverage</u> \$2,000,000 per occurrence for bodily injury and property damage. If Commercial General Liability Insurance or other form with a general limit is used, either the general aggregate limit shall apply separately to this project/location or the general aggregate limit shall be twice the required occurrence limit.
- B. <u>Professional Liability Coverage</u> Professional Errors and Omissions Liability - insuring against all liability arising out of professional errors and/or omissions, providing protection of at least \$2,000,000.00 for errors and/or omissions ("malpractice") of CONSULTANT in the performance of this Agreement.
- C. *Worker's Compensation Coverage*: State statutory limits.

Deductibles, Self-Insurance Retentions, or Similar Forms of Coverage Limitations or Modifications, must be declared to and approved by the City of Brea.

All insurance policies required shall name as additional insureds the City, its elected officials, officers, employees, attorneys and agents, and any other parties, including subcontractors, specified by City to be included.

The consultant is encouraged to review details of insurance requirements as noted in Section IV, "Professional Service Agreement" and contact its insurance carriers during the proposal stage to ensure that the insurance requirements can be met if selected for negotiation of a contract agreement.

## SECTION II - PROPOSAL CONTENT

#### A. PROPOSAL FORMAT AND CONTENT

Although no specific format is required by the City, this section is intended to provide guidelines to the consultant regarding features which the City will look for and expect to be included in the proposal.

#### 1. Presentation

Proposals shall be typed, with 12 pt font, double spaced and submitted on 8  $1/2 \times 11^{"}$  size paper, using a single method of fastening. Charts and schedules may be included in 11" x 17" format. Offers should not include any unnecessarily elaborate or promotional material. Lengthy narrative is discouraged, and presentations should be brief and concise. Proposals should not exceed fifty (50) pages in length, including appendices.

#### 2. Letter of Transmittal

The Letter of Transmittal shall be addressed to Raul Lising, P.E., Interim City Engineer, at a minimum, contain the following:

- a. Identification of Offeror that will have contractual responsibility with the City. Identification shall include legal name of company, corporate address, telephone and fax number. Include name, title, address, and telephone number of the contact person identified during period of proposal evaluation.
- b. Identification of all proposed subcontractors including legal name of company, contact person's name and address, phone number and fax number. Relationship between Offeror and subcontractors, if applicable.
- c. Acknowledgment of receipt of all RFP addenda, if any.
- d. A statement to the effect that the proposal shall remain valid for a period of not less than 90 days from the date of submittal.
- e. Signature of a person authorized to bind Offeror to the terms of the proposal.
- f. Signed statement attesting that all information submitted with the proposal is true and correct.

#### 3. Technical Proposal

#### a. Qualifications, Related Experience and References of Offeror

This section of the proposal should establish the ability of Offeror to satisfactorily perform the required work by reasons of: experience in performing work of the same or similar nature; demonstrated experience working with local agencies and cities directly involved in this project; strength and stability of the Offeror; staffing capability; work load; record of meeting schedules on similar projects; and supportive client references. Equal weighting will be given to firms for past experience performing work of a similar nature whether with the City or elsewhere.

Offeror to:

- (1) Provide a brief profile of the firm, including the types of services offered; the year founded; form of the organization (corporation, partnership, sole proprietorship); number, size and location of offices; number of employees.
- (2) Provide a general description of the firm's financial condition, identify any conditions (e.g., bankruptcy, pending litigation, planned office closures, impending merger) that may impede Offeror's ability to complete the project. City does not have a policy for debarring or disqualifying.
- (3) Describe the firm's experience in performing work of a similar nature to that solicited in this RFP, and highlight the participation in such work by the key personnel proposed for assignment to this project.
- (4) Describe experience in working with the various government agencies that may have jurisdiction over the approval of the work specified in this RFP. Please include specialized experience and professional competence in areas directly related to this RFP.
- (5) Provide a list of past joint work by the Offeror and each subcontractor, if applicable. The list should clearly identify the project and provide a summary of the roles and responsibilities of each party.
- (6) A minimum of three (3) references should be given. Furnish the name, title, address and telephone number of the person(s) at the client organization who is most knowledgeable about the work performed. Offeror may also supply references from other work not cited in this section as related experience.

#### b. Proposed Staffing and Project Organization

This section of the proposal should establish the method that will be used by the Offeror to manage the project as well as identify key personnel assigned. Proposed Staffing and Organization are to be presented by Offeror for both project segments identified in the Scope of Services.

Offeror to:

- (1) Provide education, experience and applicable professional credentials of project staff. Include applicable professional credentials of "key" project staff.
- (2) Furnish brief resumes (not more than two [2] pages each) for the proposed Project Manager, Inspector and other key personnel.
- (3) Identify key personnel proposed to perform the work in the specified tasks and include major areas of subcontract work. Include the person's name, current location, and proposed position for this project, current assignment, and level of commitment to that assignment, availability for this assignment and how long each person has been with the firm.
- (4) Include a project organization chart that clearly delineates communication/reporting relationships among the project staff, including subconsultants.
- (5) Include a statement that key personnel will be available to the extent proposed for the duration of the project, acknowledging that no person designated as "key" to the project shall be removed or replaced without the prior written concurrence of the City.

#### c. Detailed Work Plan

Offeror shall provide a narrative that addresses the Scope of Services and shows Offeror's understanding of City's needs and requirements.

The Offeror shall:

- (1) Describe the proposed approach and work plan for completing the services specified in the Scope of Services. The description of the proposed approach shall discuss the services in sufficient detail to demonstrate the Offeror's ability to accomplish the City's objectives.
- (2) Describe approach to managing resources, including a description of the role(s) of any sub-consultants, if applicable, their specific responsibilities, and how their work will be supervised. Identify methods that Offeror will use to ensure quality, budget, and schedule control.

#### d. Exceptions/Deviations

State any exceptions to or deviations from the requirements of this RFP, segregating "technical" exceptions from "contractual" exceptions. Where Offeror wishes to propose alternative approaches to meeting the City's technical or contractual requirements, these should be thoroughly explained. If no contractual exceptions are noted, Offeror will be deemed to have accepted the contract requirements of the Proposed Professional Services Agreement as set forth in Section IV.

#### 4. Fee Proposal

Provide a schedule of hourly rates that will be charged to perform services specified in Section VI. The City proposes to issue a contract for a period of one (1) year with the City having the option to extend under the same terms and conditions for a maximum of three (3) one (1) year options.

#### 5. Appendices

Information considered by Offeror to be pertinent to this project and which has not been specifically solicited in any of the aforementioned sections may be placed in a separate appendix section. Please note that this does not constitute an invitation to submit large amounts of extraneous materials, appendices should be relevant and brief.

#### B. STATUS OF PAST AND PRESENT CONTRACTS FORM

Offeror is required to complete and sign the form entitled "Status of Past and Present Contracts" provided in this RFP and submit as part of the proposal. Offeror shall list the status of past and present contracts where either the firm has provided services as a prime contractor or a subcontractor during the past 5 years and the contract has ended or will end in termination, settlement or litigation. A separate form shall be completed for each contract. If the contract was terminated, list the reason for termination. Offeror must also identify and state the status of any litigation, claims or settlement agreements related to any of the identified contracts. Each form must be signed by the Offeror confirming that the information provided is true and accurate. Offeror is required to submit only one copy of the completed form(s) as part of the proposal and it should be included in only the original proposal.

# **SECTION III - EVALUATION AND AWARD**

## A. EVALUATION CRITERIA

City will evaluate the offers received based on the following criteria:

**1. Qualifications of the Firm** - technical experience in performing work of a similar nature; experience working with public agencies; strength and stability of the firm; and assessment by client references.

**2. Proposed Team and Organization** - qualifications of proposed key personnel; logic of organization; and adequacy of labor commitment and resources to satisfactorily perform the requested services and meet the City's needs.

**3.** Detailed Work Plan - thorough understanding of the City's requirements and objectives; logic, clarity, specificity, and overall quality of work plan.

**4.** Fee Proposal - reasonableness of proposed fees and competitiveness of the amount compared with other proposals.

## B. EVALUATION PROCEDURE

An Evaluation Committee will be appointed to review all proposals. The committee will be comprised of City staff and may include outside personnel. The committee members will review and evaluate the proposals. The committee will recommend to the Director of Public Works the firm whose proposal is most advantageous to the City of Brea. The Director of Public Works will then forward its recommendation to the City Council for final action.

#### C. AWARD

The City of Brea may negotiate contract terms with the selected Offeror prior to award, and expressly reserves the right to negotiate with several Offerors simultaneously. However, since the selection and award may be made without discussion with any Offeror, the proposal submitted should contain Offeror's most favorable terms and conditions.

Negotiations may or may not be conducted with Offerors; therefore, the proposal submitted should contain Offeror's most favorable terms and conditions, since the selection and award may be made without discussion with any Offeror.

City Council action will be requested by the City staff to award contract to the selected Offeror.

#### D. NOTIFICATION OF AWARD AND DEBRIEFING

Offerors who submit a proposal in response to this RFP shall be notified regarding the Offeror awarded a contract. Such notification shall be made within three (3) days of the date the contract is awarded.

Offerors who were not awarded the contract may obtain an explanation concerning the strengths and weaknesses of their proposal. Unsuccessful Offerors, who wish to be debriefed, must request the debriefing in writing or electronic mail and it must be received by the City within three (3) days of notification of the award of contract.

#### **PROFESSIONAL SERVICES AGREEMENT**

A. <u>Recitals</u>

(i) CITY has heretofore issued its Request for Proposal pertaining to the performance of professional services with respect to

hereafter), a full, true and correct copy of which is attached hereto as Exhibit "A" and by this reference made a part hereof.

(ii) CONSULTANT has now submitted its proposal to complete said Tasks, a full, true and correct copy of which proposal is attached hereto as Exhibit "B" and by this reference made a part hereof.

(iii) CITY desires to retain CONSULTANT to perform professional services necessary to render advice and assistance to CITY, CITY's Planning Commission, City Council and staff to complete said Tasks.

(iv) CONSULTANT represents that it is qualified to perform such services and is willing to perform such professional services as hereinafter defined.

NOW, THEREFORE, it is agreed by and between CITY and CONSULTANT as follows: B. <u>Agreement</u>

1. <u>Definitions</u>: The following definitions shall apply to the following terms, except where the context of this Agreement otherwise requires:

(a) <u>Tasks</u>: The provision of professional consulting advice and assistance as described in Exhibit "A" hereto including, but not limited to, the preparation of maps, surveys, reports, and documents, the presentation, both oral and in writing, of such plans, maps, surveys, reports and documents to CITY as required and, as directed, attendance at any and all work sessions, public hearings and other meetings conducted by CITY with respect to said services.

(b) <u>Services</u>: Such professional services as are necessary to be performed by CONSULTANT in order to complete the assigned Tasks.

(c) <u>Completion of Tasks</u>: The date of completion of all assigned Tasks, including any and all procedures, plans, maps, surveys, plan documents, technical reports, meetings, oral presentations and attendance by CONSULTANT at public hearings.

#### 2. <u>CONSULTANT agrees as follows</u>:

(a) CONSULTANT shall forthwith undertake and complete assigned Tasks in accordance with Exhibits "A" and "B" hereto and all in accordance with Federal, State and CITY statutes, regulations, ordinances and guidelines, all to the reasonable satisfaction of CITY.

(b) CONSULTANT shall supply copies of all maps, surveys, reports, plans and documents, including all supplemental technical documents (hereinafter collectively referred to as "documents"), as described in Exhibits "A" and "B" to CITY within the time specified by CITY's written notice to proceed with any assigned Tasks. Copies of documents shall be in such numbers as are required in CITY. CITY may thereafter review and forward to CONSULTANT comments regarding said documents and CONSULTANT shall thereafter make such revisions to said documents as are deemed necessary. CITY shall receive revised documents in such form and in the quantities determined necessary by CITY. The time limits set forth in said written notice to proceed may be extended upon written approval of CITY.

(c) CONSULTANT shall, at CONSULTANT's sole cost and expense, secure and

hire such other persons as may, in the opinion of CONSULTANT, be necessary to comply with the terms of this Agreement. In the event any such other persons are retained by CONSULTANT, CONSULTANT hereby warrants that such persons shall be fully qualified to perform services required hereunder. CONSULTANT further agrees that no subcontractor shall be retained by CONSULTANT except upon the prior written approval of CITY.

3. <u>CITY agrees as follows:</u>

(a) To pay CONSULTANT pursuant to the provisions of Exhibit "C" Services required hereunder. Said sum(s) shall cover the cost of all staff time and all other direct and indirect costs or fees, including the work of employees, consultants and subcontractors to CONSULTANT, except as may otherwise be set forth in Exhibit "C". Payment to CONSULTANT, by CITY, shall be made in accordance with the schedule set forth below.

(b) Payments to CONSULTANT shall be made by CITY in accordance with the invoices submitted by CONSULTANT, on a monthly basis, and such invoices shall be paid within a reasonable time after said invoices are received by CITY. All charges shall be in accordance with CONSULTANT's proposal either with respect to hourly rates, time and materials, or lump sum amounts for individual tasks, as approved, in writing, by CITY. In no event shall CONSULTANT, or any person claiming by or through CONSULTANT, be paid an aggregate amount in excess of \_\_\_\_\_\_\_\_(\$000.00)

4. <u>CITY agrees to provide to CONSULTANT</u>:

(a) Information and assistance as set forth in Exhibit "A" hereto.

(b) Photographically reproducible copies of maps and other information, if available, which CONSULTANT considers necessary in order to complete assigned Tasks.

(c) Such information as is generally available from CITY files applicable to assigned Tasks.

(d) Assistance, if necessary, in obtaining information from other governmental agencies and/or private parties. However, it shall be CONSULTANT's responsibility to make all initial contact with respect to the gathering of such information.

#### 5. <u>Ownership of Written Product</u>:

(a) Unless otherwise agreed upon in writing, all reports, documents, or other original written material, including any original images, photographs, video files, digital files, and/or or other media created or developed for the CITY by CONSULTANT in the performance of this Agreement (collectively, "Written Product") shall be and remain the property of CITY without restriction or limitation upon its use or dissemination by CITY. All Written Product shall be considered to be "works made for hire", and all Written Product and any and all intellectual property rights arising from their creation, including, but not limited to, all copyrights and other proprietary rights, shall be and remain the property of CITY without restriction or limitation or dissemination by CITY. CONSULTANT shall not obtain or attempt to obtain copyright protection as to any of the Written Product.

(b) CONSULTANT hereby assigns to CITY all ownership and any and all intellectual property rights to the Written Product that are not otherwise vested in the CITY pursuant to subsection (a), above.

(c) CONSULTANT warrants and represents that it has secured all necessary licenses, consents or approvals to use any instrumentality, thing or component as to which any intellectual property right exists, including computer software, used in the rendering of the Services and the production of all Written Product produced under this Agreement, and that CITY has full legal

title to and the right to reproduce the Written Product. CONSULTANT shall defend, indemnify and hold CITY, and its elected officials, officers, employees, servants, attorneys, designated volunteers, and agents serving as independent contractors in the role of city officials, harmless from any loss, claim or liability in any way related to a claim that CITY's use of any of the Written Product is violating federal, state or local laws, or any contractual provisions, or any laws relating to trade names, licenses, franchises, copyrights, patents or other means of protecting intellectual property rights and/or interests in product or inventions. Consultant shall bear all costs arising from the use of patented, copyrighted, trade secret or trademarked documents, materials, equipment, devices or processes in connection with its provision of the Services and Written Product produced under this Agreement. In the event the use of any of the Written Product or other deliverables hereunder by CITY is held to constitute an infringement and the use of any of the same is enjoined, CONSULTANT, at its expense, shall: (a) secure for CITY the right to continue using the Written Product and other deliverables by suspension of any injunction, or by procuring a license or licenses for CITY; or (b) modify the Written Product and other deliverables so that they become non-infringing while remaining in compliance with the requirements of this Agreement. This covenant shall survive the termination of this Agreement.

6. <u>Termination</u>: This Agreement may be terminated by CITY upon the giving of a written "Notice of Termination" to CONSULTANT at least fifteen (15) days prior to the date of termination specified in said Notice. CONSULTANT shall not be compensated for any work performed after receipt of the Notice of Termination. CONSULTANT shall provide to CITY any and all documents, whether in draft or final form, prepared by CONSULTANT as of the date of termination. Any such notices, demands, invoices and written communications, by mail, shall be deemed to have been received by the addressee forty-eight (48) hours after deposit thereof in the United States mail, postage prepaid and properly addressed as set forth above.

8. <u>Insurance</u>: The CONSULTANT shall not commence work under this contract until it has obtained all insurance required hereunder in a company or companies acceptable to CITY nor shall the CONSULTANT allow any subcontractor to commence work on its subcontract until all insurance required of the subcontractor has been obtained. The CONSULTANT shall take out and maintain at all times during the life of this contract the following policies of insurance:

(a) Workers Compensation insurance: Before beginning work, the CONSULTANT shall furnish to the CITY a certificate of insurance as proof that it has taken out full compensation insurance for all persons whom the CONSULTANT may employ directly or through subcontractors in carrying out the work specified herein, in accordance with the laws of the State of California. Such insurance shall be maintained in full force and effect during the period covered by this contract. Further, such policy of insurance shall provide that the insurer

waives all rights of subrogation against CITY and its elected officials, officers, employees and agents.

In accordance with the provisions of Section 3700 of the California Labor Code, every contractor shall secure the payment of compensation to his employees. CONSULTANT, by executing this Agreement, certifies as follows:

"I am aware of the provisions of Section 3700 of the labor Code which require every employer to be insured against liability for workers' compensation or to undertake self insurance in accordance with the provisions of that code, and I will comply with such provisions before commencing the performance of work of this contract."

(b) For all operations of the CONSULTANT or any subcontractor in performing the work provided for herein, insurance with the following minimum limits and coverage:

(1) Commercial General Liability (occurrence) - for bodily injury, death and property damage for products/completed operations and any and all other activities undertaken by the CONSULTANT in the performance of this Agreement.

(2) Comprehensive Automobile Liability (occurrence) - for bodily injury, death and property damage insuring against all liability arising out of the use of any vehicle.

(3) Professional Errors and Omissions Liability (if required by the RFP)-

insuring against all liability arising out of professional errors and/or omissions, providing protection of at least <u>\$ two million dollars and zero cents</u> (\$2,000,000.00) for errors and/or omissions ("malpractice") of CONSULTANT in the performance of this Agreement. Such policy may be subject to a deductible or retention in an amount acceptable to CITY and shall further be subject to the provisions of subsections (2) and (6) of Section c, below. If a "claims made" policy is provided, such policy shall be maintained in effect from the date of performance of work or services on CITY's behalf until three (3) years after the date the work or services are

accepted as completed. Coverage for the post-completion period may be provided by renewal or replacement of the policy for each of the three (3) years or by a three (3) year extended reporting period endorsement which reinstates all limits for the extended reported period. If any such policy and/or policies have a retroactive date, that date shall be no later than the date of first performance of work or services on behalf of CITY. Renewal or replacement policies shall not allow for any advancement of such retroactive date. Each such policy or policies shall include a standard "notice of circumstances" provision, and shall be subject to the requirements of subsections (1), (2), (5), (6), (7), and (9) of Section 8 (c).

(5) Other required insurance, endorsements or exclusions as required by the Request for Proposal.

(6) The policies of insurance required in this Section 8(b) shall have no less than the following limits of coverage:

(i) \$2,000,000 (Two Million Dollars) for bodily injury or death;

(ii) \$2,000,000 (Two Million Dollars) for property damage;

(iii) The total of the limits specified in subsections (i) and (ii),

(3) Name as additional insureds the CITY, its elected officials, officers,

employees, attorneys and agents, and any other parties, including subcontractors, specified by

CITY to be included;

(4) Specify that it acts as primary insurance and that no insurance held or

owned by the designated additional insureds shall be called upon to cover a loss under said

policy;

(5) Specify that it applies separately to each insured against whom claim is

made or suit is brought, except with respect to the limits of the insurer's liability;

(6) Contain a clause substantially in the following words:

"It is hereby understood and agreed that this policy may not be canceled nor the amount of coverage thereof reduced until thirty (30) days after receipt by CITY of written notice of such cancellation or reduction of coverage as evidenced by receipt of a registered letter."

(7) Specify that any failure to comply with reporting or other provisions of

All endorsements or policies shall be received and approved by the CITY before CONSULTANT commences performance. If performance of this Agreement shall extend beyond one (1) year, CONSULTANT shall provide CITY with the required policies or endorsements evidencing renewal of the required policies of insurance prior to the expiration of any required policies of insurance.

9. <u>Indemnification</u>: Other than in the performance of professional services and to the fullest extent permitted by law, CONSULTANT shall indemnify, defend and hold CITY, its employees, agents and officials harmless from and against their tort liability, (including liability for claims, suits, actions, expenses or costs of any kind, whether actual, alleged or threatened, actual attorney's fees incurred by CITY, court costs, interest or defense costs including expert witness fees), where the same arise out of, in whole or in part, the performance of the Agreement by CONSULTANT (or any individual or entity that CONSULTANT shall bear the legal liability thereof) and which result in bodily injury or property damage to any individual or entity, including the employees or officials of CONSULTANT.

In addition to the foregoing, CONSULTANT shall indemnify, defend and hold harmless CITY and its officials and employees from and against any and all losses, liabilities, damages, costs and expenses, including reasonable attorney's fees and costs to the extent the same are caused by the professional negligence of CONSULTANT (or any entity or individual that CONSULTANT shall bear the legal liability thereof) in the performance of professional services pursuant to this Agreement.

10. <u>Assignment</u>: No assignment of this Agreement or of any part or obligation of performance hereunder shall be made, either in whole or in part, by CONSULTANT without the prior written consent of CITY.

11. Damages: In the event that CONSULTANT fails to complete an assigned Task, together with all documents and supplemental material required hereunder, in form to the reasonable satisfaction of CITY, within the time set forth in the notice to proceed, or as may be extended by written consent of the parties hereto, CONSULTANT shall pay to CITY, as liquidated damages and not as a penalty, the sum of N/A dollars (\$000.00) per day for each day CONSULTANT is in default, which sum represents a reasonable endeavor by the parties hereto to estimate a fair compensation for the foreseeable losses that might result from such a default in performance by CONSULTANT, and due to the difficulty which would otherwise occur in establishing actual damages resulting from such default, unless said default is caused by CITY or by acts of God, acts of the public enemy, fire, floods, epidemics, or quarantine restrictions.

12. Independent Contractor: CONSULTANT is retained by CITY only to the extent set forth in this Agreement, and the CONSULTANT's relationship to the CITY is that of an independent contractor. CONSULTANT shall be free to dispose of all portions of CONSULTANT's time and activities which CONSULTANT is not obligated to devote to the CITY in such a manner and to such persons, firms, or corporations as the CONSULTANT sees fit except as expressly provided in this Agreement. Neither the CITY nor any of its agents shall have control over the conduct of the CONSULTANT or any of the CONSULTANT's employees, except as set forth in this Agreement. CONSULTANT shall not have the status of an employee under this Agreement, or be entitled to participate in any insurance, medical care, vacation, sick

15. <u>Entire Agreement</u>: This Agreement supersedes any and all other agreements,

either oral or in writing, between the parties with respect to the subject matter herein. Each party to this Agreement acknowledges that no representation by any party which is not embodied herein nor any other agreement, statement, or promise not contained in this Agreement shall be valid and binding. Any modification of this Agreement shall be effective only if it is in writing signed by all parties. In the event of any inconsistency between this document and any of the Exhibits, the provisions of this document shall govern over the Exhibits, and the provisions of Exhibits A and C shall govern over the provisions of Exhibit B.

# SECTION V – SCOPE OF SERVICES

## I. PROPOSED SCOPE OF SERVICES

## A. WORK DEFINITION

The City of Brea is proposing approximately \$28 million in capital improvements for FY 2015-2016, with additional funding planned for future years. The capital improvement program includes projects in the following categories: street improvements, traffic safety enhancements, water improvements, storm drain improvements, sewer improvements, facility improvements. Ongoing annual projects such as slurry seal, sidewalk replacement, sewer mainline relining, and miscellaneous water improvements will continue as funding allows. The purpose of this RFP is to contract with a consultant to provide construction materials and soils testing services for these projects.

The consultant shall provide services as described in Chapter 16, "Administer Construction Contracts," of the State of California Department of Transportation's (Caltrans) Local Assistance Procedure Manual (LAPM).

## B. SCOPE OF SERVICES

More specifically, construction materials and soils testing services shall include, but are not limited to:

## Acceptance Testing (AT) Services

- 1. Collecting concrete samples and testing their strength.
- 2. Checking subgrade compaction for concrete and asphalt construction.
- 3. Perform tests for sieve analysis, sand equivalent, and cleanness, as needed.
- 4. Checking compaction of asphalt pavement and overlays.
- 5. Performing plant inspection at facilities supplying concrete and hot mix asphalt.
- 6. Provide test results to the City.
- 7. Provide summary report of testing results.
- 8. Perform testing and sampling according to the City's Quality Assurance Plan (QAP) and Caltrans procedures.

#### Independent Assurance Program (IAP) Testing Services

- 9. Verify that sampling and testing procedures are being performed properly and in accordance with the City's QAP and Caltrans procedures.
- 10. Verify certifications of samplers and testers.
- 11. Perform split sample tests as necessary.
- 12. Maintain witness test records.
- 13. Verify that all testing equipment used for acceptance testing is in good condition and properly calibrated.
- 14. Verify that all plant inspections are being performed correctly by qualified testers.
- 15. Provide summary report of quality assurance results.
- 16. Perform such other similar and related tasks as may be assigned by the City Engineer.

#### C. <u>REQUIRED LICENSES AND CERTIFICATES</u>

The laboratory performing the construction materials and soils testing and all samplers and testers must possess valid certifications as may be required by Caltrans.

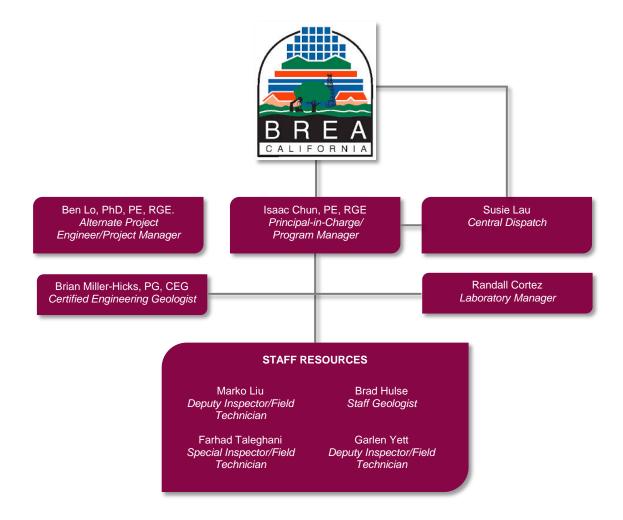

#### SECTION C | DETAILED WORK PLAN

#### CONTRACT UNDERSTANDING

The City is seeking a consultant to provide on-call as-required on a short notice basis services for construction materials and soils testing services. MTGL has the project team qualified to perform the required scope of services.

#### SOILS ENGINEERING, TESTING, AND INSPECTION

**Soils Engineering:** Soils engineering, testing, and inspection services would include preliminary site investigations for roadway and building construction including geotechnical analysis of site subsurface soils, foundations design, excavation and backfill, pavement thickness design based on R Value tests (ASTM 2844) performed on the basement soils, and the traffic indices determined by the City of Anaheim.

**Preliminary Site Investigations:** Preliminary site investigations will consist of field explorations utilizing a hollow stem auger drill rig, laboratory testing of representative soils in accordance with the specifications of The American Society for Testing and Materials (ASTM) or Caltrans Test Methods (CTM), and a review of the compiled data and preparation of a written report containing recommendations in accordance to generally accepted engineering principles and practices.

**Compaction Testing of On-Site Improvements & Trench Backfill:** Field compaction testing and laboratory testing of soils, aggregates, asphalt, and concrete during construction will be performed during grading, excavation, backfill, and aggregate and concrete placement operations. Field compaction testing will be performed by our ICC Certified Soils Inspector by either the sand cone method (ASTM D1556) or the nuclear gauge method (ASTM D2922), water content tests, and maximum density optimum moisture tests per ASTM D1557.

Trench backfill compaction tests would be taken at locations and frequencies in accordance to guidelines provided by the City of Anaheim. In general, test locations on the main trenches would be spaced no more than 300 linear feet apart and 20% of the lateral trenches would be tested. Compaction tests would be taken at mid depth in the backfill zone and in the subgrade zone in trenches with depths of 4 feet or less. One half of the tests shall be taken from each depth. Trenches deeper than 4 feet would be tested in each 4 foot lift and the subgrade zone. No tests would be taken in the bedding or pipe zone. Excavating of test holes in excess of 1.0 feet in depth would not be included within the workscope.

In addition, sub-grade compaction testing of paved areas on-site and within the street right of way will be taken at locations and frequencies in accordance to guidelines provided by the City. Subject to the City approval, test locations will be selected by our technician at locations that represent the surface appearance of the sub-grade at the time of testing. Test locations will be spaced no more than 500 linear feet apart.

**Site Grading Observation:** Our services will consist of rough grading operations, performing soils tests, and submittal of a soil grading report. Our technician will observe rough grading operations on a full time basis. Removal bottoms and footing excavations shall be approved by the identified project professional (i.e. GE or CEG). Water content, in place density (compaction), maximum density and optimum moisture, expansion index and soluble sulfate test will be performed at a frequency and at locations selected by the soils engineer. Our laboratory can perform other soils test, if required, subject to the City approval. During the course of construction we will notify the City in writing, with a copy to the contractor, if in our opinion, any time the work is not in conformity to the plans and specifications. Upon completion of the work we will prepare a final report for the City which will summarize our observations and the results of all tests performed. The final report will contain recommendations and opinions regarding the conformance of the completed rough grading to the intent of the plans, soil engineering reports, and specifications.

**Asphaltic Concrete Lay Down Inspection:** Our services will consist of inspection of the asphaltic concrete lay down and quality control during the lay down operation for conformance to the job specifications. The lay down inspection will consist of monitoring the temperature and rolling procedure for the in place density of asphaltic concrete by





nuclear method. Quality control will consist of asphaltic concrete maximum density testing for conformance to the job specifications. A written report will be provided at the completion of the work.

Our services will also include laboratory testing of the aggregate base and asphaltic concrete. Services will include Hveem stabilometer, sieve analysis, sand equivalents and R-Value testing of aggregate base. Tests will be performed on materials sampled at random locations and at frequencies based on the project specifications. Testing requirements for Oil Content of asphalt can be met with our Rapid Ignition Oven, providing real time results to batch plants supplying asphalt.

**Concrete Inspection & Testing:** Our Services will consist of continual concrete inspection during the concrete placement, for conformance to approved plans, specifications, and building codes. During concrete placement our inspector will fabricate 4 compression test specimens for each 100 cubic yards of concrete placed. MTGL will provide testing at different intervals per the City request or requirements. Test cylinders will be cured in our laboratory until they are tested in accordance to ASTM C192. Compression test will be performed in accordance to ASTM C39 at 7 and 28 days, respectively. Copies of the results of all compression tests will be provided upon completion of the test. Prior to any placement of concrete, our inspector will verify all reinforcing steel placed in accordance with the project documentation. Verification of proper size, location and spacing will be the primary focus of these inspections.

**Masonry Inspection & Testing:** Masonry Inspection will be provided continuously ensuring that the reinforcing steel, mortar, grout, ties and spaces are verified. We will provide an ICC certified masonry Special Inspector. Their work will consist of verification of materials to include reinforcement, concrete masonry units, mortar and grout. Following their verification they will observe the contractor during placement of reinforcement, laying of concrete masonry units, to include observation of motored bed and head joints, and grout placement. During grout placement our inspector will verify pour heights, check for proper clearances and check for proper consolidation during vibrating operations. In addition to their observations and verifications, material sampling will be performed on mortar, grout and CMU prisms to verify compressive strength per project specifications. Daily inspection reports will be provided to the Construction Manager with weekly summary reports provided to the City.

**Structural Steel Inspection & Testing:** We will provide an inspector that has been certified by ICC as a special inspector for welding. Their work will consist of inspections of all welds made in the shop operations and/or during the field erection for compliance of the approved plans and job specifications. The inspector will make a systemic record of all welds, including a list of defective welds and a manner of correction. The inspector will check the material, equipment, details of construction and procedures, as well as the welds. The inspector may use gamma ray, sonic or any other aid for visual inspector will also inspect the installation of the high strength bolts for conformance to the job specifications. Our inspector will check the materials, equipment, details of construction and installation procedure.

Daily inspection reports will be provided to the Construction Manager with weekly summary reports provided to SCE. A verified report indicating that all inspected welding has been done in accordance to the approved plans and specifications will be provided upon completion of the work.

Laboratory analysis as required of representative samples during construction will be performed in accordance with the specifications of The American Society for Testing and Materials (ASTM) or Caltrans Test Methods (CTM).

A written report summarizing the results of all tests performed will be prepared upon completion of the work.

#### CONSTRUCTION MATERIALS TESTING AND INSPECTION

Building inspection requirements shall consist of providing certified deputy building inspection personnel, approved by the City of Anaheim Building Division, to inspect and certify various item and provide support sampling and testing in accordance with the latest edition of the IBC and the City of Anaheim Building Division requirements. Our deputy





inspectors will hold valid certification of ACI, ICC, and/or AWS/CWI. The inspector will perform inspections as directed by the City of Anaheim in for conformance to approved plans, specifications, and building codes.

During placement of concrete the ACI/ICC inspector will fabricate compression the required test specimens for laboratory analysis. The test cylinders would be cured in our laboratory until they are tested in accordance to ASTM C192. Compression tests would be performed in accordance to ASTM C39 at 7 and 28 days, respectively. In addition, our inspector would obtain samples of the reinforcing steel to be used for production of concrete. All tests performed on the reinforcing steel would be in accordance to the ASTM A370 and A615 test methods.

Welding inspection would be performed by an inspector that has been certified by AWS as a special inspector for welding. His work would consist of inspection of all welds made in the shop operations and/or during the field erection for compliance of the approved plans and job specifications. He will make a systematic record of all welds, including a list of defective welds and a manner of correction of defects. The inspector would check the material, equipment, details of construction and procedures, and the qualifications and abilities of the welder. The inspector may also use gamma ray, sonic or any other aid for visual inspection that he may deem necessary to assure the adequacy of the welding.

Daily reports of all inspections will be provided to the city of Anaheim. A final verified report that the inspections were performed in accordance to the approved plans and specifications will be provided upon completion of the work.

#### COMMUNICATION

MTGL shall develop and maintain positive and cooperative relationships with all parties that may be affected by the Project. MTGL recognizes that each project is different, presenting a unique set of conditions and challenges. Our staff does not approach the same methodology to every project. With each project, our staff develops an implementation plan unique to the specific needs of the project and client. Although we customize our approach to each project, our experience in providing services throughout Southern California identified several approaches that greatly improve the project's quality and efficiency. We will ensure that the City is involved in every step during the creation of our implementation plan.

#### SCHEDULING

All requests for Special Inspection and Soils and Materials Technicians will be filled by the following business day if notification is received by 3:00 PM the prior business day. MTGL understands that projects may require last minute requests for testing and inspections. Should a last minute request be received, MTGL will assign the next available technician, often the same business day.

#### INVOICING

MTGL can submit invoices to City on a weekly/monthly basis that will itemize each task performed, the number of hours worked per person/consultant, the rate per hour for each person/consultant, total contract amount, percent complete for specified work items, and the remaining contract amount, along with labor compliance reports.

Daily reports are sent with each billing as backup to our invoicing. We monitor re-testing of any failed tests to assist the client in regaining costs for inspection of failing tests from the General Contractor and its Subcontractors.

(i) **On July 1, 2015,** CITY and CONSULTANT entered into an agreement for professional services, whereby CONSULTANT provides as-needed construction materials and soils testing services for various Capital Improvement Projects ("Agreement", hereinafter.)

(ii) The Agreement is for a one-year term with provisions for three-one year extensions with the total term not exceeding four (4) years with a not to exceed amount of fifty thousand dollars and zero cents (\$50,000.00), per term.

(iii) The Agreement was granted a first extended term, July 1, 2016 to June 30, 2017, mutually agreed upon by both parties.

(iv) The Agreement was granted a second extended term, July 1, 2017 to June 30, 2018, mutually agreed upon by both parties.

(v) The Agreement was granted a third extended term, July 1, 2018 to June 30, 2019, mutually agreed upon by both parties.

(vi) The parties hereto desire to amend the Agreement to increase the contract amount from\$50,000 to \$150,000 for only the third extended contract term.

#### B. Amendment.

NOW, THEREFORE, it is agreed by and between CITY and CONSULTANT as follows:

1. Notwithstanding any other provision therein, the amount of the Agreement is hereby increased from \$50,000 to \$150,000 for only the third extended contract term. Except as amended by this Amendment No. 2, all other terms and conditions of the Agreement remain unchanged.

2. **The persons** executing this Amendment No. 2 warrant that they are authorized to execute this first Amendment and that this Amendment No. 2 is binding on the parties hereto.

NOW, WHEREFORE, the parties have executed this Amendment No. 2 as of the date first set forth above.

#### RECOMMENDATION

Adopt the attached resolutions appropriating funds to adjust the Fiscal Year 2018-19 City Operating and Capital Improvement Program Budgets.

#### **BACKGROUND/DISCUSSION**

Budget adjustments are presented to the City Council periodically for review. These adjustments represent the appropriation of items previously approved by the City Council during the fiscal year, or staff recommended adjustments for City Council consideration. The recommended adjustments to the City Operating Budget are listed in City - Exhibit A. These adjustments are separated by funding source and the accounts are identified as either revenue or expenditure accounts.

The Fire Department continues to respond to mutual aid throughout California. Fortunately, Fire Administration has been diligent in seeking reimbursement from costs incurred. Mutual aid responses included: the Pawnee Fire in Lake Napa-Sonoma, the County Fire in Lake Napa-Sonoma, the Skyline Fire at the Riverside Ranger Unit, and the Cranston Fire in the San Bernardino National Forest. These strike team responses resulted in the Fire Department's overtime budget and other operating costs to increase by \$104,541. This cost is fully offset by reimbursements.

The City has been awarded a grant for the Brea Core Connectivity and Active Transportation Plan by CalTrans for \$198,793. The plan will look at improving safety and access for users of major east-west and north-south corridors within the Brea Core Plan area. The grant will fund community engagement efforts to inform, education and include the Brea community in Brea Core Plan effort, collect data and develop plans and remedies to improve circulation and mobility challenges for all multi-modal types of transportation. This money is to offset the cost of Brea Central City Core Project.

For Capital Improvement Project #7903 - Super Block 1 Parking Structure, bond proceeds were anticipated to be received in FY 2018-19; however, they were applied to last fiscal year and after the FY 2018-19 budget adoption in June. Thus, there is a need to de-obligate transfers to the General Fund - 110 (\$1,337,000), the Community Benefit & Economic Development Fund - 140 (\$33,409), and the Capital & Mitigation Improvement Fund - 560 (\$3,900,000) for FY 2018-19.

Lastly, the Fire Department is requesting to purchase an additional cardiac monitor. The approved decision package included four (4) monitors for \$131,280; however, it was later determined that based upon the current deployment an additional monitor (\$32,816) is needed during heavy rains, fire season, and for back-up purposes especially when apparatus is sent out for mutual aid and when equipment is sent back to the manufacturer for repair. Also, an additional \$25,599 is needed to purchase ancillary equipment such as cables, power adapters, and batteries that were not included in original decision package. As with the original decision package, funding for this equipment will come from the Public Safety Augmentation Fund (172).

#### COMMISSION/COMMITTEE RECOMMENDATION

The attached FY 2018-19 budget adjustments were reviewed by the Finance Committee on October 30, 2018, and recommended for City Council approval.

#### FISCAL IMPACT/SUMMARY

The City Operating Budget adjustments for the General Fund (110) in Exhibit A resulted in a decrease in revenues and transfers-in of \$1,023,649 and an increase in expenditures of \$250,303, for a net General Fund decrease in revenues and transfers-in of \$1,273,952. The City Operating Budget adjustments for all funds resulted in a decrease in revenues and transfers-in of \$4,875,325 and an increase in expenditures of \$358,718 for a net decrease in revenues and transfers-in of \$5,234,043.

The Capital Improvement Program Budget adjustments in CIP - Exhibit A consists of a decrease in expenditures of \$4,893,809 with a corresponding net decrease in revenues and transfers-in. The adjustments to revenue and transfers-in are as follows:

#### **RECOMMENDATION**

Receive and file.

#### **BACKGROUND/DISCUSSION**

The Monthly Report of Investments is in accordance with Government Code Section 53607 and contains information on the investment activities for the month of September. Cash for day-to-day activities is deposited in the demand and interest-bearing checking accounts. The Local Agency Investment Fund (LAIF) is used for short term investment and functions like a savings account. The City's managed investment portfolio is for longer-term investments which are managed through Chandler Asset Management. Together, the short and long-term investment accounts represent the City's investment portfolio. Attachment A includes a Portfolio Summary, Holdings Report, Book Value Report and Compliance with Investment Policy Statement prepared by Chandler Asset Management for the invested funds. The book value is the cost, plus or minus amortization/accretion.

As of September 30, 2018, the total market value of the managed investment portfolio, including accrued interest, was \$57,345,499.04 as compared to \$57,445,939.76 at August 31, 2018. The weighted average investment yield for September 2018 was 2.01%, which was the same as the prior month. The City's Local Agency Investment Fund (LAIF) had a total market value, including accrued interest of \$22,611,172.89 at September 30, 2018. This brings the total value of the City's investment portfolio as of September 30, 2018 to \$79,956,671.93 as compared to \$79,245,196.73 at August 31, 2018.

Restricted cash and investments are held in the post-employment benefits trust account administered by PARS (PARS account) and managed by HighMark Capital and the City's various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a monthly statement from US Bank for the PARS account as well as a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of September 30, 2018, the market value of the PARS account, including short-term cash and accrued interest was \$7,562,278.20 as compared to \$7,568,629.91 from the prior month. All other restricted cash investments (bond reserve accounts), including short-term cash and accrued interest was \$5,098,505.13 in comparison to \$6,166,034.87 from the prior month.

All City investments are GASB rated No. 1, where the custodian (The Bank of New York Mellon

Trust Company, N.A.) acts as an agent of the City, and is not a counter party to the investment transaction, and all securities are held in the name of the City of Brea. The custodial account at Bank of New York and account records with Chandler Asset Management have been reconciled to par value for the month. The City of Brea has sufficient cash flow to meet its expected expenditures for the next six months.

#### COMMISSION/COMMITTEE RECOMMENDATION

On October 22, 2018, the Investment Advisory Committee reviewed the Monthly Report of Investments and recommended that the City Council receive and file.

#### FISCAL IMPACT/SUMMARY

During the month of September the total value of the City's investment portfolio increased by \$711,475.20. This is primarily due to the receipt of sales tax during the month. The City's PARS account decreased by \$6,351.71 primarily due to market rate adjustments and the City's bond reserve accounts decreased by \$1,067,529,74 primarily due to debt service payments for the 2005 Olinda Ranch Public Improvements CFD Bond, 2017 Brea Plaza Public Improvements CFD Bond and the 2014 Downtown Brea Public Improvements CFD Bond.

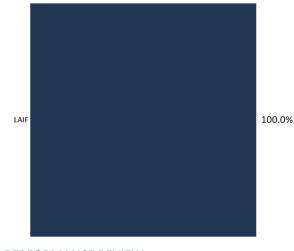

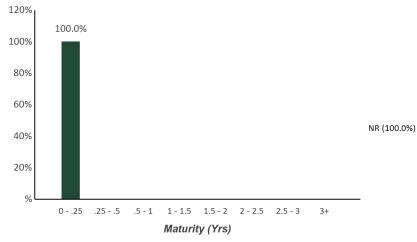

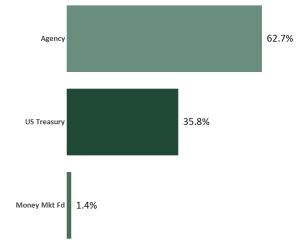

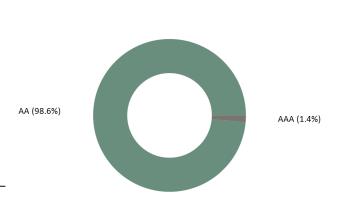
#### SECTOR ALLOCATION

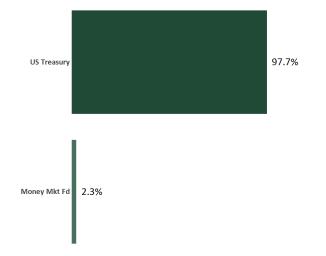

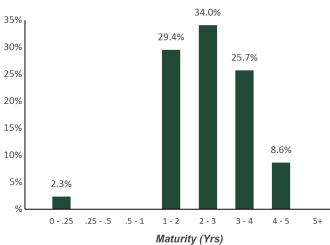

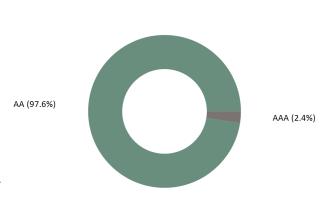
## SECTOR ALLOCATION

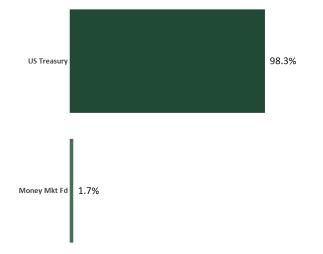

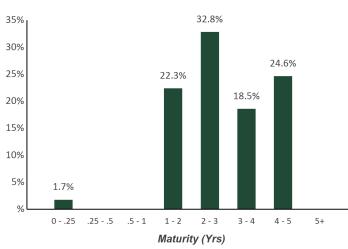

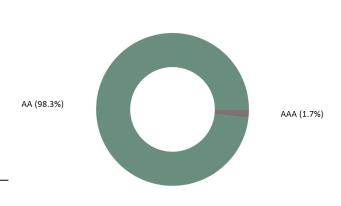
#### SECTOR ALLOCATION

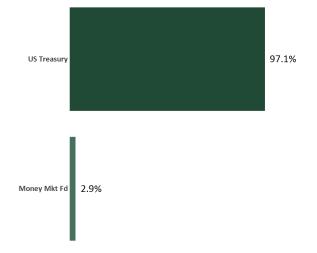

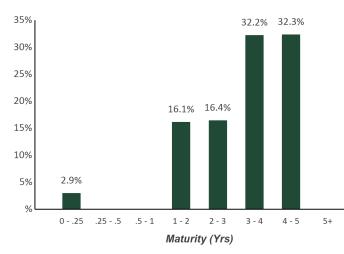

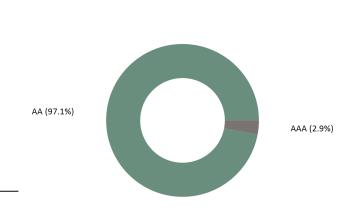
#### SECTOR ALLOCATION

#### RECOMMENDATION

City Council, as Successor Agency: Adopt resolution to adjust the FY 2018-19 Successor Agency to the Brea Redevelopment Agency Operating and Capital Improvement Program Budget.

#### **BACKGROUND/DISCUSSION**

Budget adjustments are presented to the City Council periodically for review. These adjustments represent the appropriation of items previously approved by the City Council during the current fiscal year, or staff recommended budget adjustments for City Council consideration. The recommended adjustments to the Successor Agency to the Brea Redevelopment Agency Operating Budget are listed in Exhibit A. These adjustments are separated by funding source and the accounts are identified as either revenue or expenditure accounts.

In May 2018, the California Department of Finance (DOF) approved the Successor Agency's Last and Final Recognized Obligation Payment Schedule (LFROPS). As part of this approval process, the DOF also approved the 2011 A Bonds Proceeds Funding Agreement that provided for the reimbursement to the City of Brea for costs incurred toward the Downtown Parking Structure. The total reimbursement by the Successor Agency during Fiscal Year 2017-18 was \$5,273,000; however, bond proceeds of \$5,237,000 were budgeted in Fiscal Year 2018-19. The Fiscal Year 2017-18 Budget was adjusted on October 2, 2018 to reflect the receipt of these proceeds. Thus, the de-obligation of this budget is needed for FY 2018-19.

Also, as a condition of obtaining the DOF approved LFROPS, the Successor Agency is required to pay annually to the County of Orange any excess cash that is not pledged toward the future repayment of enforceable obligations. All enforceable obligations are pledged with property tax revenue. In August 2018, there was a payment from the Brea-Olinda Unified School District toward the Agency Loan triggering excess cash to be paid to the County of Orange in the amount of approximately \$207,600.

#### COMMISSION/COMMITTEE RECOMMENDATION

The attached FY 2018-19 budget adjustments were reviewed by the Finance Committee on October 30, 2018, and recommended for City Council approval.

#### FISCAL IMPACT/SUMMARY

The fiscal impact of Exhibit A to the Successor Agency to the Brea Redevelopment Agency FY 2018-19 budget is a decrease in revenues of \$5,237,000 and an increase in expenditures of \$207,600.

#### RECOMMENDATION

#### **BACKGROUND/DISCUSSION**

The Monthly Report of Investments is in accordance with Government Code Section 53607 and contains information on the investment activities for the month of September 2018. Funds received by the Successor Agency are typically spent within three to six months; therefore are not invested long-term. The Successor Agency's Local Agency Investment Fund (LAIF) is used for short-term investments and functions like a savings account until funds are required to meet expenditures needs. Attachment A includes a Portfolio Summary and Holdings Report prepared by Chandler Asset Management for the funds invested on behalf of the Successor Agency. As of September 30, 2018, the market value, including accrued interest on the Successor Agency's Local Agency Investment Fund (LAIF), was \$1,133,625.81 in comparison to \$1,131,712.03 at August 31, 2018. The Successor Agency to the Brea Redevelopment Agency has sufficient cash flow to meet its expected expenditures for the next six months.

The Successor Agency also has restricted (fiscal agent) cash and investment accounts related to its various bond reserve accounts which are managed by Chandler Asset Management. Attachment A includes a portfolio report from Chandler Asset Management for each bond reserve account that is invested. As of September 30, 2018, the market value of these funds, including short-term cash and accrued interest was \$176,373.10 as compared to \$1,509,223.51 as of August 31, 2018.

#### **COMMISSION/COMMITTEE RECOMMENDATION**

On October 22, 2018, the Investment Advisory Committee reviewed the Monthly Report of Investments and recommended that the City Council receive and file.

#### FISCAL IMPACT/SUMMARY

During the month of September, the total value of the Successor Agency to the Brea Redevelopment Agency's investment portfolio increased by \$1,913.78 due to changes in market value. The total value of the restricted cash and investments decreased by \$1,332,850.41 primarily due to debt service payment for the 2016 Tax Allocation Bond.

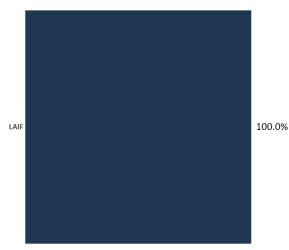

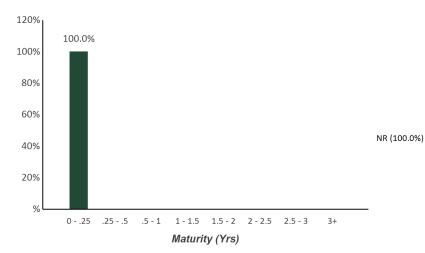
