## **TRAFFIC COMMITTEE MINUTES – Thursday, May 16, 2019**

TIME: 5:30 pm

LOCATION: Executive Conference Room, Level 3

- ATTENDEES: Citizen Reps: Richard Dooley, Ron Martorella (Absent), Jerry Hunter, and Erik Zambon Staff: Tony Olmos, Michael Ho, Ron Aristondo, and Dale Mullins
  - I. Call to Order/Introductions *The meeting was called to order at 5:30 pm.*
  - II. Approve minutes of April 25, 2019 Special Meeting Committee approved minutes.
  - III. Matters from the Audience None
  - IV. Cliffwood Working Group Selection Draw Director Olmos opened the item and provide background to this item and requested the Traffic Committee's direction on how to select the 8 of the 10 members from north of State College. Audience members requested alternative methods on selecting the 8. Traffic Committee heard from all public input and concluded to draw the 8 names. 8 members were selected by draw with 2 residents as alternates. Traffic Committee Citizen Representative (TCCR) Zambon read off all 8 selected names and 2 of the alternates. Traffic Committee approved the 8 members and 2 alternates.
  - V. Olinda Ranch & Blackstone Traffic Calming Plan Overview City Engineer Ho opened and presented the item to provide some background and history. Director Olmos presented and provided a status of the improvements that are currently installed from the list of recommendations from the 2015 Traffic Calming Plan. There was no requested action for this item.
  - VI. Santa Fe Traffic Monitoring Data City Engineer Ho presented the item and summarized the traffic volume, traffic speeds and accident history data along Santa Fe Road that was taken on February 2019. Staff recommended to present the data now and bring this item back at the next meeting with recommendations. The Traffic Committee concurred.
  - VII. Future Traffic Accident Report Discussion The Traffic Committee opened by providing background and some clarification to this item. Chair Dooley expressed a desire to have a report to the Traffic Committee oncitations issued and collisions throughout the City. After discussion,, the Committee agreed to have staff look into what other agencies provide their respective Commissions/Committees. The

Committee was also interested in identifying areas throughout the City that had a high number of citations or collisions. Chair Dooley suggested to see what the City of Yorba Linda provides to their Commission. Traffic Committee directed staff to provide a sample of City of Yorba Linda's Commission citation and collision reporting and to bring forth reporting options.

VIII. Traffic Committee Discussion

TCCR Zambon – Requested staff to look into the signal synchronization for eastbound on State College, it does not seem running correctly. Staff will investigate.

TCCR Hunter – Requested to get the agenda packet earlier. Agendas are provided within 72 hours as required, but will provide it earlier if possible. Also experienced delays making a left turn from the 57/Imperial northbound off-ramp during the afternoon peak period. Staff responded that a current Caltrans project of replacing all ADA access ramps has placed some of the signals on recall and the timing is not synchronized and should be in normal operations once the project is complete.

TCCR Dooley – With Bonanza days approaching, would like the northbound to westbound left turn movement sign timing to have more green time at the intersection of Brea Boulevard and Ash Street. Staff will look into this request. Also, the synchronization along Brea Boulevard from City Limit to City Limit is not working well and would like to staff to look into this request and come back at a future meeting to report on the findings of any failures.

IX. Adjourn – The meeting was adjourned at 6:50 pm. Next scheduled meeting June 20, 2019.

## RECOMMENDATION

Receive and file.

### BACKGROUND/DISCUSSION

The Olinda Ranch/Blackstone area development was processed through the Orange County because the area was not annexed to the City at the time. During the process the City received concerns from the area residents regarding the future safety including Traffic Volume and speeding on Santa Fe road. The matter was heard by the traffic committee and approved by the City Council to conduct a study and developed alternatives to reduce the traffic impact.

In 2014, the City conducted several community meetings to receive the Olinda Ranch/Blackstone neighborhood concerns regarding traffic. This area is bounded by Lambert, Santa Fe and Valencia. The following list presents most of the residents' concerns:

- Speeding on Santa Fe Road
- Cut through traffic
- Parking on Santa Fe Road restricting sight distance

In response to the residents concern, staff conducted a comprehensive Traffic Study (Study) and collected traffic volume and speed data on several segments of Santa Fe Road between Lambert and Carbon Canyon Road. The Study recommended solutions to be implemented in three phases as follows:

#### Phase I

• Install centerline striping, edge line striping, high-visibility crosswalks, and a pork chop with an acceleration lane to limit southbound right turns only on Santa Fe Road at Carbon Canyon Road. These improvements were installed in 2016 by Blackstone developers prior to incorporation of the Blackstone area into the City. (See attachment 1)

#### Phase II

- Install speed feedback signs, bulbouts, and a striped bike lane buffer
- To review and re-evaluated after completion of Phase I and the Blackstone development is built out.
- To return to the Traffic Committee for review and approval prior to implementation. (See attachment 2)

#### Phase III

• Consists of improvements along Carbon Canyon Road, primarily to improve access for residents in the Brea Hills Avenue neighborhood of Olinda Ranch by providing a separate access. Each improvement will be further reviewed, and the need re-evaluated.

- All improvements must meet state and federal guidelines and City standards.
- All improvements will be returned to the Traffic Committee for review and approval prior to being implemented.

In following the recommendations in the Study for Phase I and with all the improvements being installed for Phase I, staff is now required to measure the effectiveness of the improvements prior to considering phase II recommendations. Staff completed collecting traffic volume and speed data in February of 2019 for a period of one week to obtain a good representation of traffic volume and speed and daily variations. Exhibit 1 present the summary of data for before and after phase I implementation. Results are as follows:

## A. Traffic Volume

Comparison of the data as shown in Exhibit 1 indicates that traffic volume increased in Blackstone area west of Valencia Road. This was expected because the Blackstone development was not completely built out when traffic volume was collected on Santa Fe Road in 2014. Data indicates that traffic volume increased by 12% (2,480 to 2780) for the westbound and 5% (2,470 to 2,600) for the eastbound.

Data also indicates that traffic volume on Santa Fe Road between Valencia and Carbon Canyon Road experienced a 75% (1,290 to 260) decrease for the eastbound and an increase of about 90% (190 to 360) for the westbound. The decrease for the eastbound clearly indicates the reduction of cut-through traffic during PM peak period. Speed

### B. Speed

Comparison of speed data for before and after completion of Phase I, indicates that there has not been a statistically significant change of average speed and 85th percentile speed on Santa Fe Road between Lambert and Carbon Canyon.

#### C. Accidents

Reported accidents were obtained from Statewide Integrated Traffic Record System (SWITRS). Data indicates that there were four reported accidents on Santa Fe Road between Lambert and Valencia and one reported accident on Santa Fe Road between Valencia and Carbon Canyon Road between 2013 and mid-2016. The number of accidents were seven on Valencia and none between Valencia and Carbon Canyon. (See Exhibit 2 & 3)

At this time staff would like for the Traffic Committee to review the data for now and to bring this item back at the next meeting to discuss the data and for staff to provide recommendations.



#### BACKGROUND/DISCUSSION

At the May 16, 2019 Traffic Committee meeting, the Traffic Committee requested for citation and collision reports to the Traffic Committee on a routine basis. This information would highlight the areas throughout the City that have high collisions and citations.

The Committee concluded to have staff look into what other agencies provide their respective Commissions/Committees. The Committee was also interested in identifying areas throughout the City that had a high number of citations or collisions.

Per the Committee's request, as a sample, attached is the City of Yorba Linda Traffic Collisions for the month of February 2019 item presented to their March 1, 2019 Traffic Commission. Based on Yorba Linda's monthly report, some of the suggested options, but not limited to, are listed below.

- 1. The five (5) highest number of reported collisions
- 2. The five (5) highest number of reported collisions at an signalized intersection
- 3. The five (5) highest number of reported collisions at an non-signalized intersection
- 4. Highest number of primary collision factors
- 5. Highest number of citations issued.

At this time staff seeks direction from the Committee on what options they would like to see based on staff's input and recommendations.


