TRAFFIC COMMITTEE MINUTES – Thursday, July 18, 2019

- I. Call to Order/Introductions - *The meeting was called to order at 5:30 pm.*
- II. Traffic Committee Member Reorganization – *The Committee Traffic Committee agreed to keep the same Chair, Richard Dooley and Vice Chair Ron Martorella.*
- III. Approve minutes of June 20, 2019 Regular Meeting – *Committee approved minutes.*
- IV. Matters from the Audience – *None*
- V. Traffic Collisions and Citations Report Options – *City Engineer Ho opened the item and provided context and background to this item and the origin of the request. Ho handed out a sample report that showed the number collisions and citations that occurred since March 2019 (handout attached). Police Sergeant Dale Mullins provided a summary of information. TC Members requested a monthly summary and a quarterly report for Committee review at each meeting.*
- VI. Response to Traffic Committee Request from Last Meeting –
 - Request to remove the No Left-Turn signs on s/b Kraemer Blvd just south of Birch Street – *have been in place since 2011, per Google maps. Staff will review this request and follow up at the next meeting.*
 - Synchronization of signals on Brea Blvd. are not coordinated. *Staff provided a brief update and found that each signal along Brea Blvd is part of another coordinated system, ie. Imperial, Birch and Central. Staff will provide an update at the next meeting.*
 - Request for future lane closure notifications for permit work – *Staff is working on getting better times and days from utility companies and will provide a table at a future meeting.*
 - Cliffwood working group – *TC recommended setting the meeting for August 15, at 7pm following regular TC Meeting.*

VII. Project Updates – None

VIII. Traffic Committee Discussion –

TCCR Zambon – Reported on signal issues at various citywide locations: signal timing for left turn eastbound Lambert at Berry; westbound Central at Tamarack-yellow phasing, signal running free; and Valencia at Santa Fe weekend signal should run free to allow left turn movements. Staff will review these locations and will provide an update at a future meeting.

TCCR Martorella – Northbound Kraemer Blvd at Birch Hills Mall – the timing for yellow signal is too short. Santa Fe's NTMP Phase 2 calls for bulb outs at intersections and speed feedback signs on Santa Fe Rd. People are still speeding. Police Sargent Dale Mullins informed the committee PD has placed one of their portable speed feedback signs on Santa Fe and will provide that data at the next committee meeting.

TCCR Dooley – signal timing for Central and Site, the signal runs free. Staff will review and will provide an update at a future meeting.
