TRAFFIC COMMITTEE MINUTES – Thursday, August 15, 2019

TIME: 5:30 pm

LOCATION: Executive Conference Room, Level 3

1. Call to Order/Introductions - *The meeting was called to order at 5:30 pm.*
2. Approve minutes of July 18, 2019 Regular Meeting – *Committee approved minutes.*
3. Matters from the Audience – None
4. Santa Fe Traffic Calming Updates – City Traffic Engineer Roseman presented the background and history of this item. Roseman provided his findings and recommendation to the Committee. He recommended to install speed feedback signs and to re-evaluate the posted speed limit on Santa Fe from Lambert Road to Valencia Avenue. TC agreed to re-evaluate the speed limit and decided to defer the consideration to install speed feedback signs to a later date. Committee voted 4 to 1 in favor of the change, TCCR Dooley voted not in favor of the change.
5. Berry Street Traffic Calming Update – Traffic Engineer Roseman presented the item with background information. Roseman provided a comparison between the traffic speeds and volume pre and post installation of the traffic calming measures to show the effectiveness. The data showed that the speed dropped by 2mph and the volume dropped by 10%. Police Sgt. Mullins stated there has been one traffic accident within the past 15 years. Traffic Committee recommends leaving Berry Street as is because there are no issues with this location.
6. Traffic Collision and Citations, Report Options – Sgt. Mullins provided monthly summary. Traffic Committee receive and file.
7. Response to Traffic Committee Request from Last Meeting – City Traffic Engineer Roseman provided background and information on the City's traffic signal coordination citywide. Roseman gave an overview on which streets that are coordinated and how they operate. Roseman followed up with some findings in the field and will address them with the city signal maintenance contractor. No other action was needed.

8. Traffic Committee Discussion –
 - Cliffwood working group – PW Director Olmos stated the working group meeting will work best for the majority of the members on August 28th, at 6:30 pm. TCCR Chandler will replace TCCR Hunter as Traffic Committee representative. Approved by the Committee.
