## **TRAFFIC COMMITTEE MINUTES – Thursday, January 16, 2020**

**TIME:** 5:30 pm

**LOCATION:** Executive Conference Room, Level 3

1. Call to Order/Introductions - *The meeting was called to order at 5:30 pm.*
2. Approve minutes of November 21, 2019 Regular Meeting – *Changes requested by Acting Sgt. Corporal Johnson to remove Lt. Johnson and change to Officer Johnson. Approved by Traffic Committee.*
3. Matters from the Audience – *None*
4. Traffic Collision and Citations – *Acting Sgt. Corporal Johnson provided a monthly Collision Summary Report. The Traffic Engineer provided additional information related to a collision safety investigation conducted at the Lambert and Berry intersection. The Collision Summary Report was received and filed by the Committee.*
5. Traffic Signal Timing Updates – Provided by the Traffic Engineer
  - *Timing adjustments to improve traffic flow and enhance safety were made at Tamarack & Central, State College & Cliffwood, State College & Balsa, and Associated & Greenbriar*
  - *Pedestrian crossing timing was lengthened at the Cliffwood & Lambert intersection.*
6. Project Updates –
  - a. Speed Limits – *The Traffic Engineer completed his review of the City's existing Engineering and Traffic Surveys and recommended that seven roadway segments be considered for resurvey – Lambert btwn Puente & Berry, Tamarack btwn Central & Lambert, Puente btwn Imperial & south City limit, Puente btwn Whittier & north City Limit, Northwood btwn Puente & Dorothy, Randolph btwn Birch & Imperial, and Steel btwn Central & Carlson.*
  - b. Adaptive Traffic Signal System – *The Traffic Engineer informed the Committee that implementation of the new adaptive traffic signal system at 11 intersections along Birch St and State College is underway and is likely to take 60 days to complete. These improvements are being privately funded as part of the Hines/Avalon Bay project.*

- c. *Lambert Interchange Improvements – The City Engineer provided an update about the 57 Fwy/Lambert Interchange Project to the Committee that Caltrans will be pile driving for another two weeks and notices went out to the adjacent neighbors.*
- d. *Cliffwood Neighborhood Traffic Study – The Traffic Engineer is currently performing field investigations. Speed humps on Balsa have been requested by residents. The next meeting should be scheduled for the end of February.*

7. Traffic Committee Discussion –

- *Requested if staff could find out how many daily truck trips there are to and from the landfill.*
- *On Ethelinda Way a W-3 sign is faded and needs to be replaced.*
- *For the 57Fwy/Lambert Project, the delineators are missing. Also a conflicting thru right turn legend for south bound on ramp on Lambert*
- *Intersection of Berry and Imperial there is an existing ped push button pole behind a sign for crossing north south direction on the east side of the intersection*
- *Requested an update for the next meeting on repair of the Lambert & Berry westbound left-turn arrow recall.*
- *Requested that the City of La Habra be contacted regarding collision statistics for the Central and Palm intersection.*
- *Radar Feedback sign stuck on 40mph. Acting Sgt. Corporal Johnson fixed it.*
- *There was debris on Valencia. Street Superintendent stated the street is swept every 2 weeks as part of the street sweeping pilot program and will be brought back to the Council at a future meeting for consideration.*
